## 1 Introduction

- 1.1.1 This **Land Plans Schedule of Changes** (Doc Ref. 9.10.2) has been prepared on behalf of One Earth Solar Farm Limited.
- 1.1.2 It presents a consolidated list of all amendments to the **Land Plans** which was submitted to the Examination Authority on 27 February 2025 [2.2.3]. Subsequent Schedules of Changes will be submitted if further changes to the Land Plans are necessary.

## 2 Land Plans Schedule of Changes

- 2.1.1 This Schedule of Changes to Land Plans (Doc Ref. 9.10.2) is a supporting document to the Land Plans (Doc. Ref. 2.2.3) and presents a consolidated list of all amendments to version 4 of the Land Plans which was submitted to the Examination Authority on 27 February 2025 [EN010159/APP/2.2.3].
- 2.1.2 The changes have been identified through National Highways updates through consultation and data supply.
- 2.1.3 This **Land Plans Schedule of Changes** (Doc. Ref 9.10.2) is structured by listing individual plots with each row detailing:
  - The Plot Number(s) to which the change relates;
  - The Change Made;
  - The Reason for Change; and
  - The Revision
