In November 2023, following the first round of consultations, our volunteers hand-delivered questionnaires to households across the affected villages, ensuring everyone had the opportunity to share their views on the One Earth Solar Farm proposal. 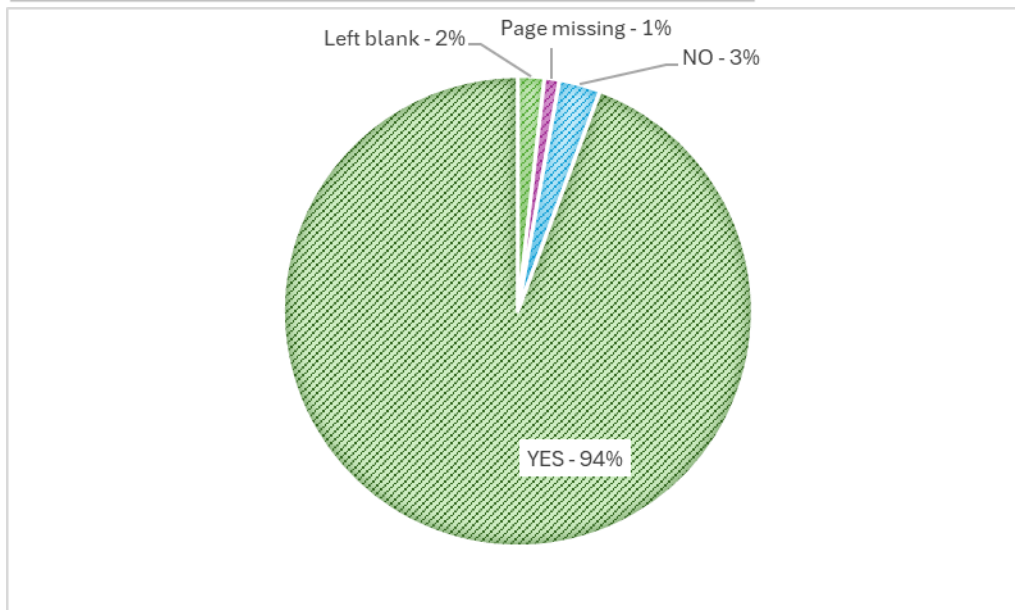

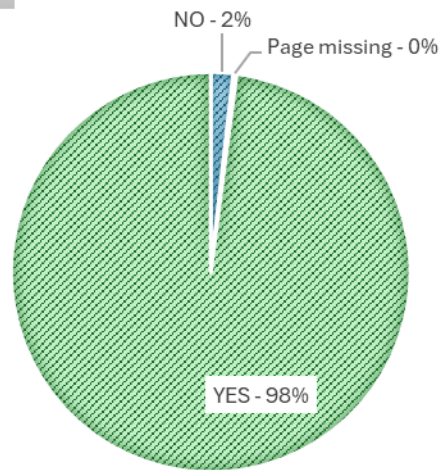

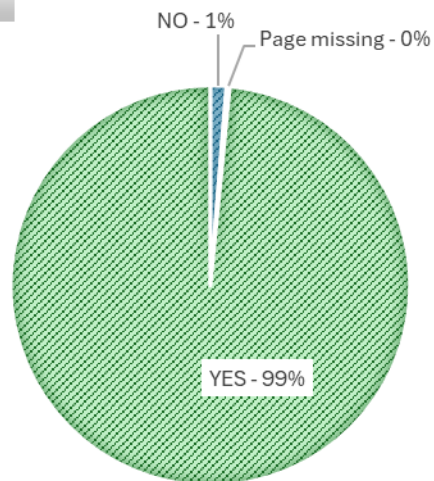

5. Responses to Statement 2: I wish to object to the “One Earth Solar Farm” development because we need to protect UK food production.

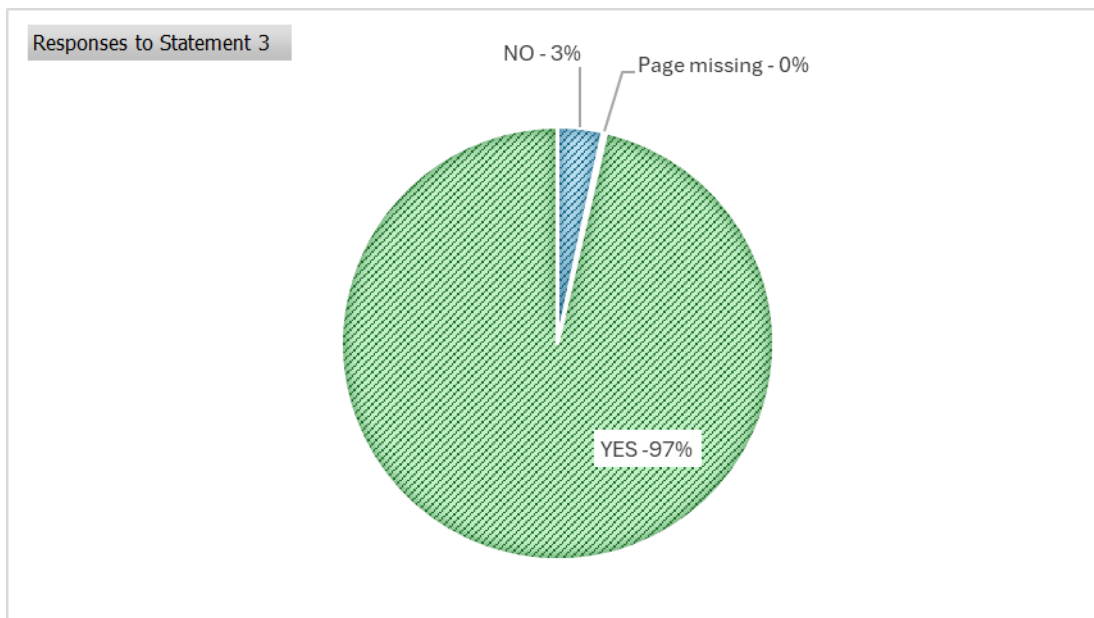

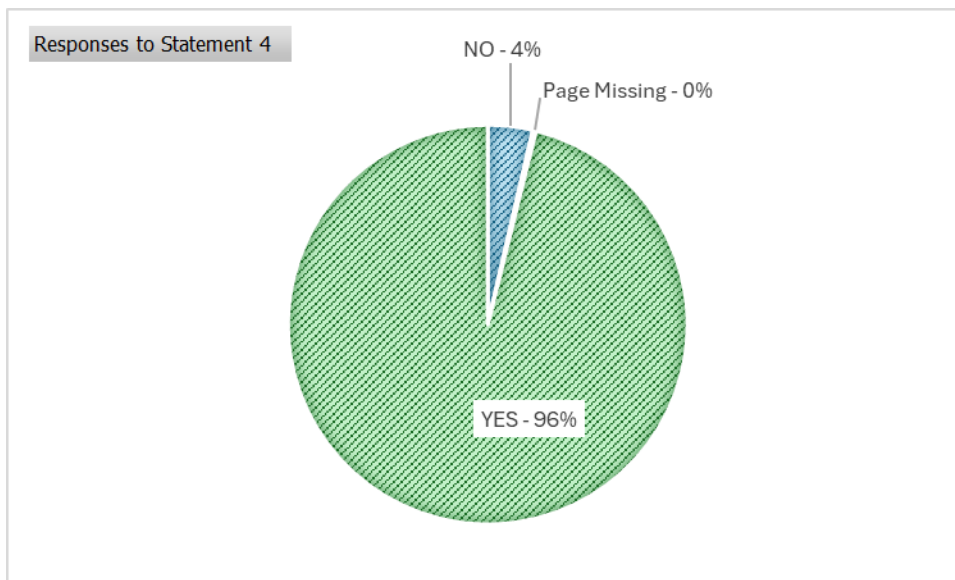

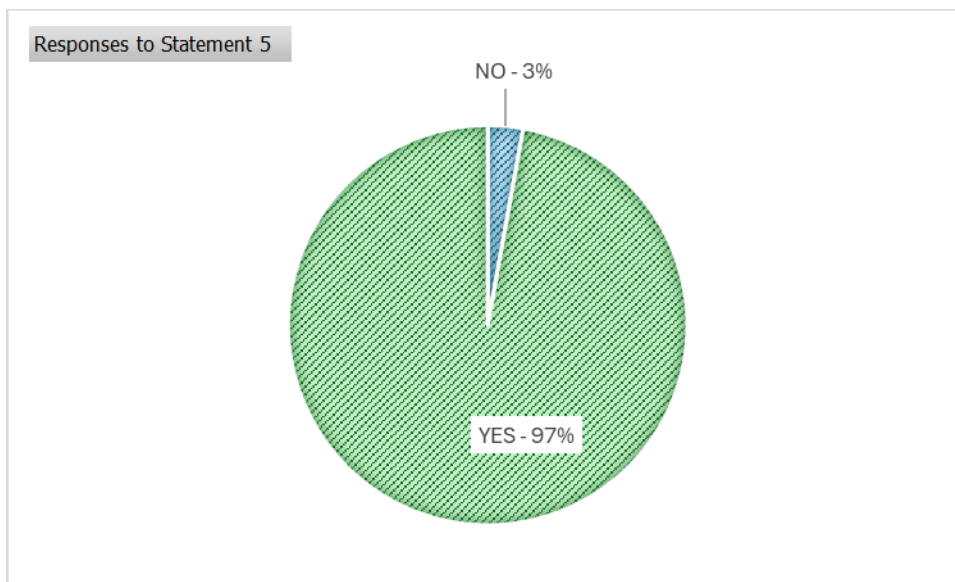

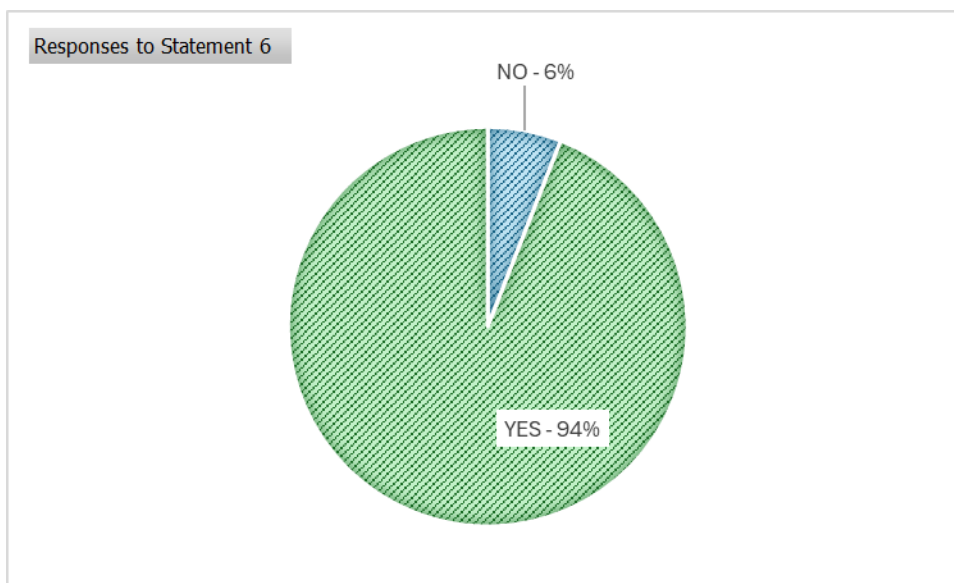

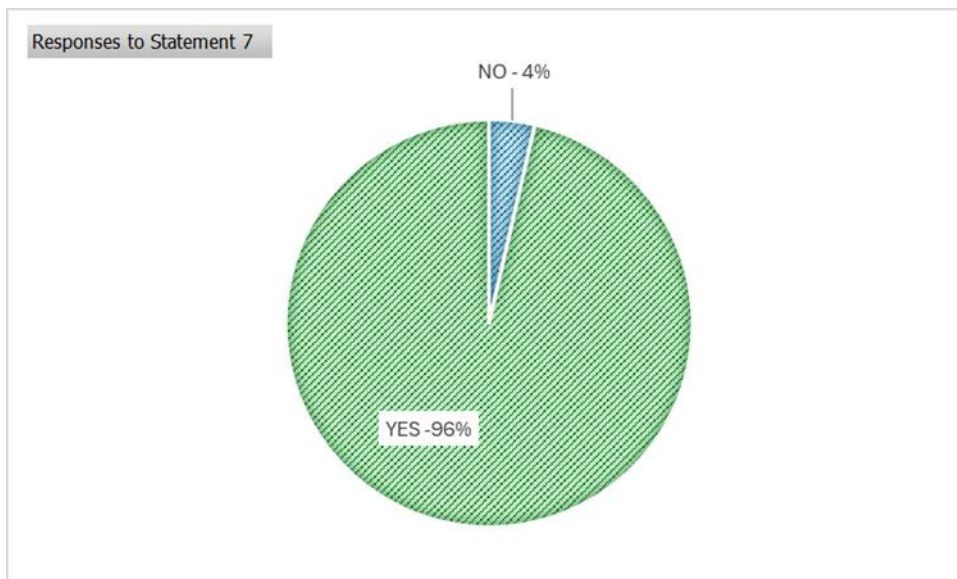

11. Additional Comments given

160 villagers gave additional comments within the comments section of the forms. Of these 160 comments, no comments were in support of the scheme.

Themes of the comments are as follows:

Farmland should be for farming.

Poor consultation with limited information given and the One Earth Team unable to answer many of the questions raised with them.

Use rooftops for solar.

Impact on wellbeing, wildlife, house prices, visual amenity.

Poor information given by One Earth Solar during the consultation.

Risk of fires from the BESS.

Impact on flooding in the area.

Use of cheap panels from China using slave labour.

Impact on those people who are associated with this land being farmed.
