1. Introduction

1.1 Purpose of this Document

- 1.1.1 This document provides a guide to One Earth Solar Farm Limited's (the 'Applicant') application for a Development Consent Order (DCO) for One Earth Solar Farm made to the Secretary of State for Energy Security and Net Zero (the 'Secretary of State') pursuant to the Planning Act 2008 (PA 2008).
- 1.1.2 The DCO Application is for a Nationally Significant Infrastructure Project (NSIP) comprising the installation, operation (including maintenance) and decommissioning of solar photovoltaic (PV) panels, Battery Energy Storage Systems (BESS) and associated grid connection infrastructure which will allow for the generation and export of electricity to the High Marnham Substation (hereafter 'the Proposed Development'). The Proposed Development has a grid connection agreement with National Grid allowing the export and import of 740MW of electricity to the High Marnham 400kV Substation ("High Marnham Substation").
- 1.1.3 The Proposed Development meets the criteria to be considered as a Nationally Significant Infrastructure Project ("NSIP") under section 15(2) of the PA 2008 as it is a proposed generating station which would be within England, does not generate electricity from wind, would not be offshore and would have a total generating capacity of more than 50 MW.
- 1.1.4 A full description of the Proposed Development is provided in **Environmental Statement (ES) Volume 1, Chapter 5: Description of the Proposed Development [APP-034]**.
- 1.1.5 This Guide aims to help the Examining Authority ("ExA") and Interested Parties understand the DCO Application through signposting to the documents that make up the Application. This Guide provides an overview of the documents that have been submitted in order to satisfy the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) (APFP Regulations), the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (EIA Regulations) and section 37 of the PA 2008
- 1.1.6 The APFP Regulations were updated in April 2024, and these updated APFP Regulations have been complied with within the Application.
- 1.1.7 Regulation 5 of the APFP Regulations sets out the documents that all DCO applications must include. The APFP Regulations also provide at Regulation 5(2)(q) for the submission of "*any other documents considered necessary to support the application*" as well as at Regulation 5(2)(o) for "*any other plans, drawings and sections necessary to describe the proposals*".

- 1.1.8 Regulation 6 of the APFP Regulations sets out the specific documentation required in support of draft DCO applications for particular types of development, including generating stations and grid connections.
- 1.1.9 The Proposed Development constitutes an Environmental Impact Assessment (EIA) development, and therefore the EIA Regulations and requirements contained therein apply.

1.2 The Applicant

- 1.2.1 One Earth Solar Farm is being promoted by One Earth Solar Farm Ltd. This is a joint venture between Padero Solaer Ltd (trading as PS Renewables) and Ørsted Onshore UK Ltd.
- 1.2.2 Established in 2012, PS Renewables is one of the UK's largest privately held companies that specialises in the development and asset management of renewable energy projects including solar and BESS. PS Renewables' existing solar farm portfolio totals over 300MW of electricity producing potential in the UK.
- 1.2.3 In the UK, Ørsted is a leading offshore wind developer; currently operating 12 offshore wind farms, alongside onshore wind farms in Scotland, and also owning and operating sites for energy storage. Ørsted is committed to ensuring that its presence contributes to sustainable growth and development, helping to support the UK in meeting its legally binding net zero targets through a range of renewable energy technologies including solar, and benefitting the communities in which it operates.

1.3 Structure of this Document

2. The Proposed Development

2.1 Proposed Development Description

- 2.1.1 One Earth Solar Farm is a proposed solar farm that will generate energy for export to the National Grid (the 'Proposed Development').
- 2.1.2 The Proposed Development comprises the construction of a Solar Farm and Battery Energy Storage System (BESS) that would allow for the generation, export and storage of electricity exceeding 50 MW in approximately 1,409 hectares (ha) of land in Lincolnshire and Nottinghamshire. **Volume 1, Chapter 5: Description of the Proposed Development** [~~APP-034~~[REP5-018](#)] contains a full description of the Proposed Development.
- 2.1.3 The main objective of the Proposed Development is to generate low-carbon renewable energy that contributes to addressing the urgent need to decarbonise the UK's energy supply. The **Statement of Need** [~~APP-173~~[REP2-047](#)] provides further details.

The Order Limits

- 2.1.4 The Order limits are shown on the **Location Plan** [~~APP-012~~], **Land Plan** [~~REP1-004~~;[REP5-004](#)] **Works Plan** [~~APP-014~~[REP5-005](#)], and **Crown Land Plan** [~~REP1-005~~].
- 2.1.5 The Proposed Development comprises approximately 1,409 ha of land that is located within the administrative areas of Bassetlaw District Council (BDC), Newark and Sherwood District Council (NSDC), West Lindsey District Council (WLDC), Lincolnshire County Council (LCC) and Nottinghamshire County Council (NCC).

3. Overview of Application Documents

- 3.1.1 The documents submitted as part of the Application have been grouped into the below document volumes noted within Table 3.1 to accord with the Planning Inspectorate's (PINS) Nationally Significant Infrastructure projects: Advice on the Preparation and Submission of Application Documents published in August 2024 (updated January 2025).

Volume 7 – Additional prescribed information for specific types of projects and Other Documents	As the Proposed Development is a non-offshore generating station, Volume 7 contains a statement of responsibility for designing and building the connection (the Grid Connection Statement). This Volume also contains additional documents pertaining to the Proposed Development, required by Regulation 6 of the APFP Regulations and considered by the Applicant to be required to support the application in accordance with Regulation 5(2)(q) of the APFP Regulations.

- 3.1.2 The remainder of this Guide (sections 4 to 10) provides a summary of the purpose of the documents and plans included within each volume described in Table 3.1 above.
- 3.1.3 In addition, Appendix 1 of this Guide provides a document schedule, which is a live document that will be updated during subsequent stages of the application should additional documents be required or updates be made to documents.
- 3.1.4 A copy of all of the application submission documents will be available on the PINS website following acceptance for Examination by PINS.

3.2 Document Numbering

- 3.2.1 Documents are numbered in sequence within the respective volumes (as outlined in Appendix A of this Guide), with the volume number being the first digit of a document number. This is followed, where relevant, by the document number, the chapter and/or Appendix number.

3.3 Control Documents

- 3.3.1 The DCO Application contains a number of control and compliance documents which establish the parameters, consenting envelope and secure the mitigation for the Proposed Development. These are proposed to be secured by the Development Consent Order and are as follows:

3.3.2 The list above forms part of the list of Certified Documents set out at Schedule 12 of the **Draft DCO [~~REP5-006~~REP6-004]**, which includes other documents such as the **Land Plans [REP5-004]** and **Crown Land Plans [REP1-005]** that form the overarching legal controls for the Proposed Development.

3.4 Management Plans

3.4.1 The outline management plans included within Volume 7, Other Documents provide the framework and overarching principles for mitigation during both the construction, operation (and maintenance), and decommissioning (including restoration) phases of the Proposed Development.

3.4.2 The **Draft DCO [~~REP5-006~~REP6-004]** includes requirements that secure further detailed management plans where necessary. These detailed management plans are required to be submitted to and approved by the relevant planning authority as identified in the draft DCO. Table 3.2 below sets out to which phases of the Proposed Development each outline management plan applies.

4. Volume 1 – Application Forms

- 4.1.1 The **Application Form [APP-001]** is the standard application form required by Section 37(3)(b) of the PA 2008 to be submitted with the application. It provides a high-level summary of the Proposed Development and the documents that have been submitted for the Applicant's DCO Application.
- 4.1.2 The **Application Cover Letter [APP-002]** provides a brief description of the Proposed Development, its location, and a general introduction to the Application.
- 4.1.3 The purpose of this **Guide to the Application [REP5-002REP6-002]** is referred to above in section 1.1.
- 4.1.4 **Copies of newspaper notices [APP-004]** are included to show the notices that have been published in the appropriate outlets as part of the pre-application process.
- 4.1.5 The **Pre-application Programme Document [APP-005]** is a document that outlines the main steps the applicant has taken to prepare the application including consultation etc, and includes the Adequacy of Consultation Milestone.
- 4.1.6 A **Section 55 Checklist [APP-006]** is included to demonstrate how the Application fulfils the conditions for acceptance by the Inspectorate under Section 55 of the PA 2008.
- 4.1.7 The **Electronic Application Index [EN010159/APP/1.7]** is the ordered list of all documents and information submitted with the Application. It provides a plain English description of the information contained in each document, electronic file names, reference numbers for each document, and the relevant regulation reference.

5. Volume 2 – Plans, Drawings and Sections

- 5.1.1 In addition to the **Location Plan [REP2-005]**, eight additional plans are submitted as part of the Application. In accordance with Regulation 5(4) of the APFP Regulations, where there are three or more separate drawing sheets, a key plan is provided to enable the reader to understand the relationship between the different sheets.
- 5.1.2 The **Land Plans [REP5-004]** illustrates the land required for or affected by the Proposed Development. This includes (a) land over which it is proposed to exercise powers of compulsory acquisition or any right to use land (b) land in which it is proposed to extinguish easements, servitudes, and other private rights and (c) land over which temporary possession is sought. These plans correspond to the **Book of Reference (parts 1 to 5) [REP5-012]**.
- 5.1.3 The **Works Plans [REP5-005]** demonstrate the relationship between the proposed location of the Proposed Development and the limits of deviation within which the development and works may be carried out. The areas on the Works Plans are numbered, and these correspond to the numbered works set out in Schedule 1 of the **Draft DCO [REP5-006REP6-004]** which are proposed to be authorised by the DCO.
- 5.1.4 The **Streets, rights of way, and access plans [APP-024]** illustrate any new or altered means of access, permanent and temporary alteration of streets, street works and authorisation of use of motor vehicles over public rights of way.
- 5.1.5 The **Site layout plans [APP-016]** are provided to demonstrate the illustrative layout of the Site.
- 5.1.6 The **Outline Surface Water Drainage Strategy Plans [APP-017]** is provided to demonstrate the strategy for managing water runoff and flooding of the Proposed Development.
- 5.1.7 The **Illustrative Masterplan [REP2-008]** is provided to demonstrate an example of the design and layout of the Proposed Development.
- 5.1.8 A **Crown Land Plans [REP1-005]** is provided to demonstrate the land within the Order Limits which belongs to the Crown, Forestry Commission and SoS for Transport, who are Crown Bodies.
- 5.1.9 The **Special Category Land Plans [REP1-006]** is provided to demonstrate the land within the Order Limits that is certain types of land (land held inalienably by the National Trust, land forming part of a common (including a town or village green), open space, or fuel or field garden allotment and statutory undertakers' land) is subject to additional restrictions.

- 5.1.10 Other plans/drawings illustrating the Proposed Development are provided within the **Environmental Statement [APP-030 - 150]**.

6. Volume 3 – Draft Development Consent Order

6.1.1 The **Draft DCO** [~~REP5-006~~REP6-004] is the draft statutory instrument which contains the legal powers that the Applicant is seeking to enable it to construct, operate (including maintenance), and decommission the Proposed Development, should consent to be granted. It sets out the parameters for what development would be permitted. It is comprised of 49 articles and 15 schedules. The Schedules are outlined below:

- > Schedule 1 (Authorised development) – lists the works that would be authorised by the grant of development consent, which are shown on the **Works Plans [REP5-005]** and to which the Schedule refers;
- Schedule 2 (Requirements) – sets out the conditions that the Applicant would be required to accord with when implementing the development authorised by the DCO;
- > Schedule 3 (Legislation to be disapplied) – lists the historic legislation that the Applicant is seeking to disapply for the purposes of the Proposed Development;
- > Schedule 4 (Streets subject to street works) – sets out the streets that would be subject to street works in connection with the development that would be authorised by the DCO;
- > Schedule 5 (Alteration of streets);
- > Schedule 6 (Streets and Public Rights of Way) – is split into five sections, including the following:
 - > Part 1 – Temporary prohibition or restriction of use of streets;
 - > Part 2 – Temporary prohibition or restriction of public rights of way with diversion
 - > Part 3 – Permanent use of motor vehicles on public rights of way
 - > Part 4 – temporary management of public rights of way
 - > Part 5 – Temporary use of motor vehicles on public rights of way

Schedule 7 (Access to Works) – is split into two parts, containing details of the permanent access, and the other for temporary access that would be created as a result of the Proposed Development;

Schedule 8 (Land in which only new rights etc. may be acquired) – sets out the land over which the Applicant is seeking to acquire new land rights only rather than acquiring the entire freehold interest in that land. This Schedule should be read in conjunction with the **Land Plan [REP5-004]**;

- > Schedule 9 (Modification of compensation and compulsory purchase enactments for the creation of new rights and imposition of new restrictive covenants) – amends relevant compulsory purchase legislation to ensure that it can apply to the DCO (particularly in connection with land and rights compulsorily acquired under the DCO); Schedule 10 (Land of which temporary possession may be taken) – sets out the land of which only temporary possession may be taken, pursuant to Article 28 (Temporary use of land for constructing the authorised development);
- > Schedule 11 (Hedgerows to be removed) – sets out details of hedgerows to be removed in two parts, including:
 - > Part 1 – Removal of hedgerows; and
 - > Part 2 – Removal of important hedgerows.

Schedule 12 (Documents and Plans to be Certified) - contains a list of documents that would be ‘certified’ if the DCO is made by the Secretary of State;

- > Schedule 13 (Arbitration Rules) – sets out the arbitration process for how any differences under any provision of the DCO will be resolved;
- > Schedule 14 (Protective Provisions) – sets out protective provisions for the benefit of statutory undertakers whose equipment may be affected by the authorised development. This is set out in three parts, including:
 - Part 1 – For the protection of electricity, gas, water and sewerage undertakers;
 - > Part 2 – For the protection of operators of electronic communications code networks; and
 - > Part 3 – For the protection of drainage authorities.

Schedule 15 (Procedure for discharge of requirements) – provides a bespoke procedure for dealing with an application made to the relevant authority (as defined in the Schedule) for any consent, agreement or approval required or contemplated by the provisions of the DCO. It sets out time periods within which decisions must be made and provides for deemed approval of the applications in certain circumstances. It also makes provision for appeals to be made in the event of a refusal of an application or if the relevant authority requires further information to be provided in relation to that application.

- 6.1.2 The **Explanatory Memorandum** [~~REP5-008~~[REP6-006](#)] explains the purpose and effect of each provision in the draft DCO including why it is considered necessary. It also identifies examples of precedents from other DCOs where applicable.

7. Volume 4 – Compulsory Acquisition Information

- 7.1.1 Part 4 provides the evidence to justify the legal powers sought for compulsory acquisition as well as information on how the Proposed Development is to be funded. The **Statement of Reasons [REP5-010]** explains that there is a compelling case in the public interest which would justify the Applicant's exercise of powers of compulsory acquisition in order to acquire land and rights permanently and to use land temporarily to enable it to construct, operate (including maintenance) and decommission (including restoration) the Proposed Development. The **Pre-application Land and Rights Negotiations Tracker [REP5-014]** should be read alongside the **Statement of Reasons [REP5-010]**, which sets out the status of negotiations with landowners and the powers sought over the Order land.
- 7.1.2 The **Funding Statement [REP3-005]** details how the Proposed Development, including any compulsory purchase acquisition, would be funded.
- 7.1.3 The **Book of Reference (parts 1 to 5) [REP5-012]** identifies all the parties who own or occupy land and/or have an interest in or right over the land affected by the Proposed Development and/or who may be entitled to make a 'relevant claim' as defined in Section 57 of the 2008 Planning Act. It is structured in five parts in accordance with the regulatory requirements:
- Part 1 contains the names and addresses of each person within Category 1 and 2 as set out in section 57;
 - Part 2 contains the names and addresses for service of each person within Categories 3 as set out in section 57;
 - Part 3 of the contains the names of all those persons who it is considered may have their private rights over land affected by the Order;
 - > Part 4 specifies the owner of any Crown interest in the land which is proposed to be used for the purposes of the order for which application is being made; and
 - Part 5 identifies land the acquisition of which is subject to Special Parliamentary Procedure under particular circumstances, including Special Category Land.

8. Volume 5 – Reports and Statements

The Consultation Report explains how the Applicant has complied with the consultation requirements set out in the PA 2008; the APFP Regulations and the EIA Regulations. 8.1.4 **Shadow Habitat Regulation Assessment [REP2-019]** sets out the screening report to determine whether or not development plans could negatively impact local plans on a recognised protected European site beyond reasonable scientific doubt.

8.1.5 The **Statutory Nuisance Statement [APP-166]** identifies the matters set out in Section 79 of the Environmental Protection Act 1990 in respect of statutory nuisances and considers whether the Proposed Development would engage one or more of those matters, as required by Regulation 5(2)(f) of the APFP

Regulations. Where any matters may be potentially engaged, this statement sets out its proposals for mitigating or limiting them.

- 8.1.6 The Applicant requires a range of consents and agreements to construct and operate the Proposed Development. As explained in the **Explanatory Memorandum [REP5-008REP6-006]** to the **Draft DCO [REP5-006REP6-004]**, some of these are included in the Order. However, there are other consents from different regulatory organisations that will be required separately from the Order. The need for such consents and how they are to be obtained is explained in the list of **Schedule of other Consents and Licences [APP-167]** required under other legislation.
- 8.1.7 The **Planning Statement [APP-168]** details the Proposed Development's compliance with the relevant planning policy framework at national and local levels and other matters which the Applicant considers are important and relevant to the Secretary of State's decision. As part of the Planning Statement, there are two appendices including a Site Selection Report and Planning History.
- 8.1.8 The **Policy Compliance Document [APP-169]** provides a comprehensive assessment of the Proposed Development against the relevant policy and guidance documents.
- 8.1.9 **Potential Main Issues for the Examination document [APP-170]** sets out the potential main issues identified by the Applicant for examination.
- 8.1.10 The **Design Approach Document (DAD) [REP2-021]** provides information regarding the context of the Proposed Development's location and context, the design approach and evolution, the green infrastructure strategy, and the detailed design process.
- 8.1.11 The **Outline Design Parameters [REP5-016]** provides the parameters for the detailed design of the Proposed Development.

10. Volume 7 – Additional prescribed information for specific types of projects

- 10.1.1 Volume 7 provides other documents which the Applicant has submitted to adhere to the APFP Regulations and/or which are considered by the Applicant to be required to support the Application.
- 10.1.2 The **Statement of Need [REP2-047]** explains the need for the Proposed Development, supporting the case made in the National Policy Statements relevant to energy infrastructure for low carbon energy generation which is of critical national priority. It draws upon established and emerging primary analysis and opinion by respected third parties, to support the case that the Proposed Development is required to ensure that the UK remains on track to meet its legally binding carbon emissions reduction targets while enhancing national security of supply, and at a cost which, in relation to other electricity generation infrastructure developments, provides value for money for end-use consumers.
- 10.1.3 The **Grid Connection Statement [APP-174]** has been submitted in accordance with Regulation 6(1)(a)(i) of the APFP Regulations. It outlines the details for connecting the solar PV arrays to the National Grid.
- 10.1.4 The **Mineral Safeguarding Assessment [APP-175]** addresses the requirement of national and local policies relating to minerals and provide an assessment of the impact of the Proposed Development on the safeguarded minerals resource.
- 10.1.5 The **Outline Construction Environmental Management Plan [REP5-032REP6-022]** sets out the measures that will be included in a detailed Construction Environmental Management Plan to control potential environmental and amenity impacts of construction. In addition, the management plan provides a framework for construction environmental controls.
- 10.1.6 The **Outline Operational Environmental Management Plan [REP5-034REP6-024]** sets out the measures that will be included in a detailed Operational Environmental Management Plan to control potential environmental and amenity impacts of the operation of the Proposed Development. In addition, the management plan provides a framework for operational environmental controls.
- 10.1.7 The **Outline Decommissioning Environmental Management Plan [REP5-036REP6-026]** sets out the measures that will be included in a detailed Decommissioning Environmental Management Plan to control potential environmental and amenity impacts of decommissioning. In addition, the management plan provides a framework for decommissioning environmental controls.
- 10.1.8 The **Outline Landscape and Ecology Management Plan [REP5-038]** provides a framework for delivering the green infrastructure elements of the Proposed

Development for the pre-construction and operational phase of the development including the successful establishment and future management of the proposed landscape and ecological works for the duration of its operation.

- 10.1.9 The **Outline Skills, Supply Chain and Employment Plan [REP2-057]** outlines how the Applicant would promote the delivery of economic benefits generated by the Proposed Development to people and businesses across Nottinghamshire and Lincolnshire.
- 10.1.10 The **Outline Construction Traffic Management Plan [REP5-040]** sets out the measures that will be provided in a detailed Construction Traffic Management Plan for the traffic generated during the Proposed Development's construction phase.
- 10.1.11 The **Outline Soil Management Plan [REP5-042]** sets out the measures that will be included in a detailed Soil Management Plan and will include measures for soil handling, soil moisture content assessments and storage and trafficking of soils during the construction, operation (including maintenance) and decommissioning phase of the Proposed Development.
- 10.1.12 The **Outline Battery Safety Management Plan [~~REP5-044~~REP6-028]** sets out the risks associated with BESS fires and sets out the commitments/measures proposed to minimise the impact of such an incident during construction, operation and decommissioning of the Proposed Development.
- 10.1.13 The **Outline Site Waste Management Plan [~~APP-184~~REP6-030]** acts as a guide for site staff on how to manage material assets (construction materials) and waste, in accordance with both legal and best practice requirements. The Principal Contractor will use this as a basis for producing the detailed Site Waste Management Plan for use throughout the duration of the Proposed Development's construction phase, as secured through a requirement of the DCO.
- 10.1.14 The **Outline Export Cable Route Construction Method Statement [REP3-055]** provide details of how the grid connection corridor is to be constructed to inform the assessment for the Environmental Statement.
- 10.1.15 The **Outline Public Rights of Way Management Plan [REP3-057]** outlines how Public Rights of Way (PRoW) and Permissive Paths will be managed by the Applicant for the Proposed Development. This is to ensure that they have been suitably considered and are able to operate, in terms of both user safety and accessibility, during the construction, operation and decommissioning of the Proposed Development.
- 10.1.16 The **Commitments Register [REP3-059]** tracks the commitments made by the Applicant throughout the NSIP planning process, including post decision, including commitments relating to: detailed design, procurement, construction, operation and decommissioning.

- 10.1.17 The **Glint and Glare Assessment [APP-188]** assesses the possible effects of glint and glare from the Proposed Development.
- 10.1.18 The **Glossary of Terms and Abbreviations [APP-189]** provides definitions for the terms and abbreviations used throughout the Application.
