Section 42 of the Planning Act 2008 ("the 2008 Act"), Regulation 3 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009, and Regulations 11 and 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("the 2017 Regulations")

This letter has been sent to you as part of a statutory consultation exercise being carried out pursuant to section 42 of the 2008 Act by Elements Green Trent Ltd ("the Applicant"), in respect of proposals for the Great North Road Solar and Biodiversity Park.

The Applicant

The Applicant for this project will be Elements Green Trent Ltd, a solar and energy storage developer with a 15-year development track record in the UK, EU and internationally.

The Project

The Applicant intends to build a new solar photovoltaic (PV) electricity generating station ("Great North Road Solar and Biodiversity Park") within the district of Newark and Sherwood and the county of Nottinghamshire. The Development would be located on land to the northwest of Newark-on-Trent, the west of the A1, north of the A617, east of Eakring, and south of Egmanton, occupying two main areas to the north and north-west of Staythorpe.


