1. Introduction

1.1 Purpose of this document

1.1.1 This Schedule of Changes to the Book of Reference (“BoR”) relates to an application made by Elements Green Limited (the “Applicant”) to the Secretary of State for Energy Security and Net Zero via the Planning Inspectorate (the “Inspectorate”) under the Planning Act 2008 (the “2008 Act”) for a Development Consent Order (“DCO”). If made, the DCO would grant consent for Great North Road Solar and Biodiversity Park (“GNR”).

1.1.2 The DCO application was accepted for examination on 22 July 2025

1.1.3 The Schedule details all amendments to plots and land ownership information identified through ongoing engagement with landowners, and updates provided by the Examining Authority, throughout the examination process. As such, the Schedule should be read in conjunction with the **BoR [EN010162/APP/4.3C]** and the **Land Plans [EN010162/APP/2.2B]**.

1.1.4 The Schedule will be updated at the deadlines referred to in the examination timetable (as required) to take account of the ongoing land referencing process and the Applicant’s diligent enquiry, and to confirm any new interests in the Order Land have been identified post-submission of the DCO application and the previous deadline.
