Application by Steeple Solar Farm Limited (“the Applicant”) for an Order granting Development Consent for the proposed Steeple Renewables Project (“the Application”)

We act on behalf of EDF Energy (Thermal Generation) Limited (“EDF”), who are registered as an Interested Party (Interested Party number F90DDC81F) in respect of the Application.

EDF continues to engage constructively with the Applicant in respect of protective provisions to be included on the face of the draft Development Consent Order.
