1. Introduction

- 1.1. This Schedule of Changes to the Book of Reference relates to an application made by RES (the “**Applicant**”) on 14th May 2025 under section 37 of the Planning Act 2008 (the “**PA 2008**”) for an order to grant development consent for Steeple Renewables Project (the “**Proposed Development**”).
