1 INTRODUCTION

1.1 General

- 1.1.1 Xlinks 1 Ltd (the Applicant) has submitted an application under section 37 of the Planning Act 2008 (the Act) for development consent for Xlinks' Morocco-UK Power Project (the 'Proposed Development').
- 1.1.2 This Book of Reference Schedule of Changes has been prepared to accompany the application for a Development Consent Order (DCO), made by the Applicant to the Secretary of State for the Department for Energy Security and Net Zero (SoS), formally the Department for Business, Energy and Industrial Strategy, via the Planning Inspectorate (PINS).
- 1.1.3 The DCO application was accepted for examination on 19 December 2024. For a full description of the project, reference should be made to Volume 1 Chapter 3: Project Description of the Environmental Statement (Document Reference 6.1.3).
- 1.1.4 This Schedule of Changes should be read in conjunction with the updated BoR. This Schedule of Changes details all changes in land ownership identified through regular refresh of landowner and title data, information identified through ongoing engagement with land interests and updates provided by the Examining Authority, as well as any minor amendments needed to the format or explanatory text (if necessary).
