1 Introduction

- 1.1.1 This Schedule of Changes to the Book of Reference has been prepared on behalf of Lime Down Solar Park Limited. The document references have not been updated from the original submission. Please refer to the Guide to the Application **[EN010168/APP/1.5]** (Revision 4) for the list of current versions of documents.
- 1.1.2 It presents a consolidated list of all amendments to the Book of Reference **[APP-020]** which was submitted to the Examination Authority in September 2025. Subsequent Schedules of Changes will be submitted if further changes to the Book of Reference are necessary.
- 1.1.3 As this Schedule of Changes to the Book of Reference is part of the application documentation, it should be read in conjunction with:

 - Land Plans **[EN010168/APP/2.2]** (Revision 3);

2 How to use this Schedule of Changes

2.1.1 The changes set out in this Schedule of Changes to the Book of Reference are identified by highlighting in the Tracked version of the Book of Reference (EN010168/APP/4.3.2). A summary of how these changes are presented is provided below:

- entries shown struck through and highlighted in **red** have been removed;
- entries highlighted in **blue** have been added; and
- entries highlighted in **orange** reflect updates to a name, address, or qualifier.

2.1.2 The changes presented in this document, and in both the Tracked and Clean versions of the Book of Reference, have been identified through the following processes:

- HM Land Registry (HMLR) data refresh;
- Companies House registered name and address checks;
- Desktop research undertaken to verify company and organisation names and addresses;
- Ongoing review of the location of interests and rights; and
- Incoming correspondence, including Planning Inspectorate (PINS) notification, Land Interest Questionnaires, Confirmation Schedules, returned or undeliverable mail, and ad hoc communications regarding changes in circumstances.
