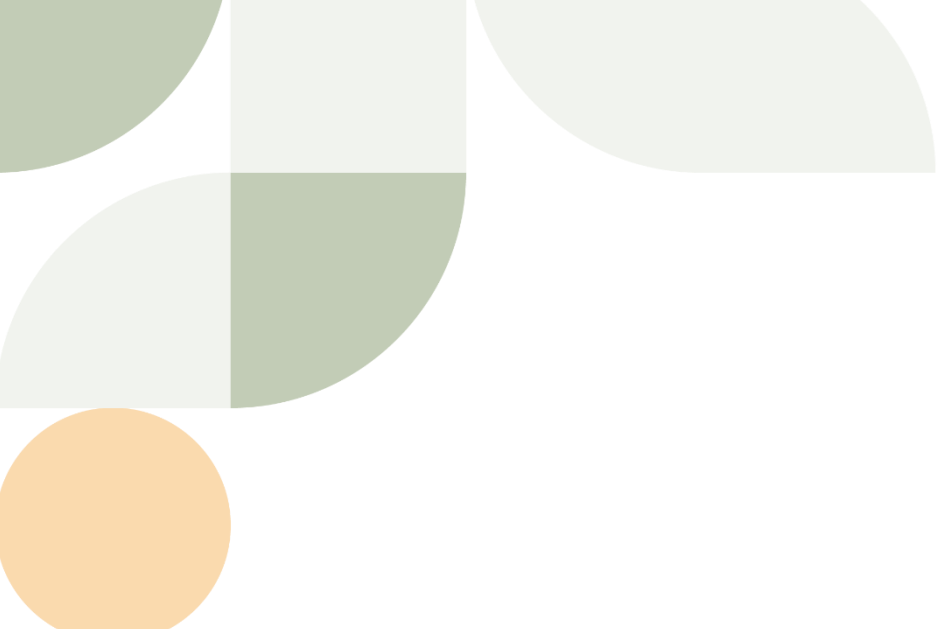

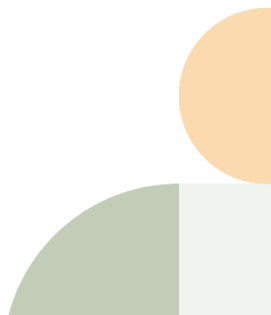

1 Introduction

- 1.1.1 This document provides a guide to the Development Consent Order (DCO) application submitted by Lime Down Solar Park Limited (the 'Applicant') to the Secretary of State for Energy Security and Net Zero (the 'Secretary of State') for Lime Down Solar Park (the Scheme). The Scheme comprises the construction, operation and maintenance, and decommissioning of a solar photovoltaic (PV) electricity generating station together with associated development, pursuant to section 37 of the Planning Act 2008 (PA 2008).
- 1.1.2 A DCO is required as the Scheme is classified as a Nationally Significant Infrastructure Project (NSIP) under sections 14(1)(a) and 15(1) and (2) of the PA 2008, being an onshore generating station in England with a capacity exceeding 100 megawatts (MW).
- 1.1.3 This Guide to the Application has been prepared in accordance with Regulation 5(2)(q) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2008 (APFP Regulations).

2 Purpose of this Document

- 2.1.1 This Guide to the Application provides an overview of the documents that have been prepared and submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.
- 2.1.2 Regulation 5 of the APFP Regulations sets out the documents that all DCO applications should include. Regulation 5(2)(q) provides for the submission of 'any other documents considered necessary to support the application', while Regulation 5(2)(o) provides for 'any other plans, drawings and sections necessary to describe the proposals'. Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including if the application is for a generating station, that is not an offshore generating station.
- 2.1.3 This Guide to the Application is a live document which, where requested by the Examining Authority ('ExA'), will be updated following each examination deadline to reflect submissions made by the Applicant, capturing both the latest versions of updated documents and recording new documents submitted as part of the examination.
