1 Land and Rights Communication Log Introduction

1.1 Summary

- 1.1.1 This Land and Rights Communication Log has been prepared by Lime Down Solar Park Limited (“the Applicant”) as part of its application for a development consent order (“DCO”) under the Planning Act 2008 for the Lime Down Solar Park (the “Scheme”)
- 1.1.2 The Land and Rights Communication Log provides a record of communications with category 1 land interests owning land within the Order Limits. It will be updated throughout Examination to provide an overview of communications with affected parties.
- 1.1.3 Within this document, Heads of Terms are referenced as ‘HoTs’ and Affected Party is referenced as ‘AP’.
