## **Landscape and Visualisation: Grendon**

#### 1. Introduction

The materials in this submission have been collated by residents of the areas concerned. The numbers of those participating is a reflection of the significance attached to the local area.

What follows has a mixture of objective data about the uses of the local area, photographs of key locations which will be impacted in some way by the proposed developments. In addition, there are personal reflections and appreciations of the importance of the area to those who live here, those who visit the area, those who rely on the surrounding countryside for recreational and health benefits.

The areas and viewpoints that are presented here also need to be interpreted in a wider context - both historical and cultural. Those who live here now are mindful of the ancestral heritage, both ancient and more recent. The rural roads, the footpaths and hedgerows and fields that surround them have been worn into place from pre-Christian era's. That these are to be stopped up for any length of time or bounded by fences in a new act of enclosure, feels painful to those who walk the area. The open fields, many of them individually named, have enabled walkers to appreciate the natural surroundings and the spires of each local church. The relationships between each village have been meaningful and long-lasting, and the disconnections imposed by the industrialised panelling between them is experienced by many as distressing.

The Overarching National Policy Statement for Energy (EN-1) acknowledges that "Virtually all nationally significant energy infrastructure projects will have adverse effects of the landscape, but there may also be beneficial landscape character impacts arising from mitigation:". (Para 5.10.5). The residents presenting this submission acknowledge, in turn, the need for carbon neutral energy generation. Almost all, however, believe that these facilities should be sited on rooftops, and contend here that the complete surrounding of two villages in the area with solar panels will never be properly mitigated.

#### 2. Local economic, recreational and health-related activities in the area.

To some extent or other the areas under consideration for the construction, operation and decommissioning of the generating scheme will impact the following:

Local walkers, including dog walkers, village and County rambler groups.
 The international Waendel walks are an annual event covering the local area. On May 9<sup>th</sup> 2025 thousands of walkers covered routes across the

County as happens each year. Many walkers, interviewed at the time, expressed profound concerns about the damage likely to be incurred by the developments. Some 30 other countries also hold a similar event, which is a promotion of international friendships.

- Local cyclists, both individual and group-based. There are regular races in the area both daytime and evening.
- The presence of horse riders using the local roads and bridlepaths. The
  presence of 4.5 metre high tracking panels will cause glint and glare
  issues impacting both horses and riders. It should be pointed out that
  local businesses providing riding and stabling facilities will be at risk if
  less destructive environments are available elsewhere.
- Individuals who walk or cycle in the area do so in part because their
  physical and mental health are sustained by it. Appreciations of local
  residents are offered below as well as their photographs which reflect
  their appreciations and concerns.

**EN-1 Para 5.13.10** indicates that "The Secretary of State may conclude that limited weight is to be given to assertions of socio-economic impacts that are not supported by evidence". In the local circumstances being discussed the evidence is to be found and weighed in light of the following elements:

- I. That a number of businesses and home-occupiers are not able formally to go on record due to their tenancy arrangements. They have nonetheless privately expressed their concerns.
- II. That the occupants of the villages concerned have, in noticeable numbers, decided that they would prefer to live elsewhere and have placed their homes for sale. As has been noted in other areas, the presence of solar farms results in a depression of the housing market and hence a local economic impact.
- III. That in the villages concerned the availability of a pool of labour to work on the development cannot be identified. At the very least, therefore, any labour required by developers will be imported to the area and hence provide no significant economic benefit to the area under consideration.

What follows are notes from meetings with local residents, photographs of the area etc.

### Notes from Grendon residents: (meetings held on 27/8/25 & 24/9/25)

- It is a privilege to live here. The walks are one of the things that matter.
- We love the vistas we get; the sense of freedom; standing and enjoying.
- We walk around once a month across to White Mills.
- The walk from Grendon to Easton Maudit, to Yardley and Castle Ashby is our "proposal walk" it has romantic memories.
- There are acknowledgements from people, whether there are conversations or not.
- Walks 3-4 times a week with the dog around the "BESS areas".
- The seasons evoke all our senses the puddles and the warmth, the hedgerows changing, sometimes badgers crossing and fox cubs in the area
- There are many reminiscences kingfishers, muntjac deer, weasels, stoats, kites and buzzards, kestrels and sparrowhawks, hares, heron, tawny owls, bittern and starling murmuration.
- We are spoiled for choice.
- There is ancient history too musket balls and ridge and furrow fields; fields with individual names like Hangmans Hill.
- The pink-red fields of clover

### The Importance of Grendon's Countryside to Me

As a Headteacher of a busy secondary school, I carry the weight of responsibility for hundreds of young minds and the dedicated staff who shape their futures. The pressures of educational leadership, the constant demands, difficult decisions, and emotional investment in every child's wellbeing, can be overwhelming. In this role, where mental health and wellbeing are not just professional priorities but personal necessities, I have found my sanctuary in the beautiful countryside surrounding Grendon and Easton Maudit.

Each day after school and at weekends, I try to walk these cherished fields with my faithful dog, finding solace in the rhythms of rural life that have remained unchanged for generations. These walks are not mere recreation, they are essential medicine for my soul and mind, providing the work-life balance that enables me to return each morning refreshed and capable of serving my school community effectively.

The glory of these fields transforms with every season, painting an ever-changing masterpiece across the landscape. In spring, the vivid emerald of new grass mingles with golden rapeseed and the delicate pastels of wildflowers. Summer brings deep, rich greens punctuated by the warm gold of ripening wheat swaying in gentle breezes. Autumn sets the countryside ablaze with amber, russet, and bronze, while winter offers its own stark beauty: the frost-kissed fields stretching toward distant horizons under pale, silver skies. As Wordsworth wrote, "In every walk with nature, one receives far more than they seek" and in these fields, I find this profound truth realised with each visit.

I am blessed with various walking routes that weave through this beautiful, landscaped tapestry, each offering its own perspective and peace. Some paths lead through ancient hedgerows where history whispers in the wind, others across open meadows where kites rise majestically across the endless sky. The fresh air fills my lungs, clears my mind, and restores my spirit, allowing me to process the challenges of my profession while reconnecting with something fundamental and grounding.

The prospect of these beloved fields being consumed by industrial solar panels for miles around fills me with **profound sadness and dread.** While I wholeheartedly support our environmental responsibilities and the need for renewable energy, the scale of this proposed development threatens to obliterate the very landscape that sustains not only my own wellbeing but that of countless others who seek respite in nature's embrace. The gentle, rolling fields that have defined this area's identity for centuries will be replaced by regimented rows of technology, transforming a living, breathing landscape into something mechanical, barren and sterile.

I do not oppose progress or our collective environmental duty, but I implore those making these decisions to consider the human cost of such extensive development. Surely, we can fulfil our obligation to renewable energy while preserving some of the precious countryside that provides such vital respite for those of us who serve our communities in demanding

roles. Could not the scale be reduced, or could not more suitable locations, perhaps former industrial sites or areas already compromised, be considered instead?

The countryside around Grendon is more than just empty space waiting for development: it is my sanctuary, a source of mental and spiritual restoration, and a living heritage that, once lost, cannot be recovered.



## **Summary**

On this route there are 7 locations where PROW or roads used by walkers/horse riders or cyclists cross or follow either the 1 kilometre or 2 kilometre ZTV. From these there is only one location Route3/1 which is likely to be severely impacted in both the use of the path/road and the visual amenity. Others such as Route 3/2c and Route3/5 are locations where the visual amenity could be impacted during the winter months.

Also included are locations of interest on the route but not on the 1 and 2 kilometre ZTV lines. Two of which (Whiston Lock and The River Nene) could have the visual amenity impacted during the winter months.




