Issue Specific Hearing 3 Action Points

Action Point 4: The Applicant held a meeting with representatives of the Lead Local Flood Authorities (LLFA) from each of the Host Authorities on 8 January 2026 to discuss the disapplication of provisions of the Land Drainage Act 1991. The Applicant is preparing a draft set of protective provisions to share with each of the LLFA's to allow for their agreement to the disapplication. The Applicant will provide a further update at Deadline 5.



Action Point 15: The Applicant is assessing whether a greater than 10% gain in habitat units can be secured and will provide a further update at Deadline 5.

Action Point 16: The Applicant is seeking clarification from Natural England on whether there are any additional requirements where it considers it should be a named consultee. The Applicant sent a follow up email to them on 7 January 2026 but is yet to receive a response. The Applicant will provide a further update at Deadline 5.
