## **Green Hill Solar Project – Change Application 2**

### **Application Ref: EN010170**

This letter sets out the documents which are submitted by Green Hill Solar Farm Limited ('the Applicant') for Change Application 2 of the Examination of Green Hill Solar Farm DCO.

These documents have been provided following a detailed review of the existing electrical design and changes to the Scheme requested by the ExA in their Schedule of Changes to draft Development Consent Order **[PD-015]**.

ES Appendix 12.6: Archaeological Mitigation Strategy (Revision B) **[CR2/GH6.3.12.6\_B]** and Technical Addendum to Chapter 12: Cultural Heritage **[CR2/GH8.4.2]** have been submitted alongside the Change Application but do not form part of the documentation supporting the requested changes. These documents are provided in advance of Deadline 5 as they clarify the environmental information assessed in the Environmental Statement, against which the changes in this Change Application have been reviewed.

It is acknowledged that, while the Technical Addendum supports the Change Application **[CR2/GH9.6]** by virtue of its relevance to Change No. 3 within Green Hill F, it is primarily relevant to the application more generally, as it relates to the existing design of the Scheme. It should therefore be considered as part of the examination irrespective of the Change Application. Change 3 seeks optionality for the cable connection between Green Hill F and Green Hill G substations to be 132kV (Work No. 5A), including in areas where the existing proposals provide for 33kV cabling to be laid. This change is shown on the Works Plan **[CR2/GH2.4\_E]**.

Viewpoint Photography and Photomontage Green Hill G (Option B) **[CR2/GH8.2.13]** also includes one of the additional viewpoints requested by Milton Keynes City Council. This viewpoint is provided alongside the Change Application, in order to enable the visual changes associated with Change 1 and Change 2 to be clearly demonstrated. This viewpoint, showing the current design **[CR2/GH8.2.12]**, has also been submitted alongside the Change Application but does not form part of the documentation supporting the



requested changes. The remaining viewpoints requested by Milton Keynes City Council will be submitted at Deadline 5.
