1 Introduction

1.1 Purpose of the Document

1.1.1 This document has been prepared to provide the Examining Authority (ExA) with the latest position on Statements of Common Ground (SoCG) between Island Green Power (IGP) (the 'Applicant') and statutory consultees, statutory undertakers and other Interested Parties (the 'parties') in relation to the proposed Green Hill Solar Project (the 'Scheme').

1.1.2 This document provides a position on the commonality on specific points between SoCGs up to Deadline ~~6~~7 (being ~~24 March~~8 April 2026).

1.1.3 The Applicant will, for each deadline during the course of the Examination, update this Statement as a record of the progress being made with the various parties. When sufficient progress has been made on agreements between parties, this document will also discuss those areas of commonality between parties to enable the efficient resolution and focusing in on the remaining issues.

1.2 Structure of this Document

1.2.1 This Statement of Commonality is structured as follows:

- Section 2 details the structure of each SoCG document. **Table 2.1** provides a full list of SoCGs being produced and offers an overview of the status of each SoCG being submitted to Deadline 6;
- Section 3 sets out the commonality between SoCGs; and
- Section 4 provides a narrative on specific topic areas for each SoCG being progressed.



2 Statement of Common Ground

4 Positions at Deadline **57**

4.1.1 This section provides a summary of the position reached across all SoCGs being progressed and submitted to Deadline **57**. The Applicant will continue to engage with those parties through the examination on matters which are ongoing.

4.2 North Northamptonshire Council

4.2.1 The matters recorded in the SoCG have been subject to discussion, through monthly catchups, between the Applicant and North Northamptonshire Council (NNC) as well as some topic specific meetings e.g. landscape and visual impact, and historic environment. ~~Following the submission of the draft SoCG at Deadline 5, the Applicant met with the LLFA on the 13 March and it was agreed that matters under hydrology, flood risk and drainage are agreed. The position on matters has not changed since the submission of the Statement of Commonality at Deadline 6.~~ In summary the matters not agreed are LVIA-10.2 (embedded design and mitigation); LVIA-13.2.2 (landscape assessment for Sites E and F); LVIA-13.3.2 (landscape assessment proposed planting and habitat measures); LVIA 13.4.2 (landscape assessment cumulative effects of the Scheme); LVIA-15 (scheme duration) and ALC-03 (impacts on ALC due to scheme duration).

~~4.2.2 The Applicant met with the Council's ecologist on the 18 March and all All other matters other than the Habitat Regulation Assessment (EB-05) relating across the topics are agreed. EB-05 has been moved to disagreed and relates to the approach to Functionally Linked Land.~~

~~4.2.3 The NNC landscape consultant issued updated comments to the Applicant on the 24 March 2026 which moved the remaining landscape matters which were under discussion to disagreed.~~

~~4.2.4.2.2 The final and a signed SoCG will be submitted forat Deadline 7. [EX7/GH8.3.1 C].~~

4.3 West Northamptonshire Council

4.3.1 The matters recorded in the SoCG have been subject to discussion, through monthly catchups, between the Applicant and West Northamptonshire Council (WNC) as well as some topic specific meetings e.g. landscape and visual impact, and historic environment. Following the submission of the ~~draft SoCG~~ Statement of Commonality at Deadline **56**, the Applicant received comments from WNC on the ~~23~~31 March 2026. The WNC landscape consultant issued updated comments to the Applicant on of the 24 March 2026 which moved the remaining landscape matters which were under discussion to disagreed. 4.4 Milton Keynes City Council

4.4.1 The matters recorded in the SoCG have been subject to discussion, through monthly catchups, between the Applicant and Milton Keynes City Council (MKCC) as well as some topic specific meetings e.g. landscape and visual impact, historic environment and ecology. ~~Following the submission of the draft SoCG at Deadline 5 the Applicant received comments from MKCC on the 22 March 2026. These comments have moved all matters agreed other than matters which have moved to disagreed on landscape and visual impact and alternatives and design evolution.~~

~~4.5 The final SoCG will be submitted for Deadline 7. Historic England~~

~~4.4.2 All matters have been agreed between the parties. The position on matters has not changed since the submission of the Statement of Commonality at Deadline 6. In summary the matters not agreed are ALT-01 (site selection); ALT-04 (site selection and design approach); LVIA-01 (meetings and workshop); LVIA-03 (appendices and figures); LVIA-05 (assessment methodology); LVIA-06 (landscape character assessment); LVIA-07 (visual receptors: assessment viewpoints for the sites); LVIA-09 (landscape receptors: value) LVIA-10 (embedded design mitigation); LVIA-11 (presentation of assessment findings); LVIA-12 (Landscape and Ecological Management Plan: Landscape and Ecological Improvements); LVIA-13 (landscape assessment); LVIA-14 (visual assessment) and EB-03 (ecology and biodiversity mitigation: skylark).~~

~~4.4.3 All other matters relating across the topics are agreed and a signed SoCG is submitted at Deadline 7 [EX7/GH8.3.3 C].~~

4.5 Historic England

4.5.1 All matters have been agreed between the parties. A signed SoCG ~~is~~was submitted at Deadline 6 [~~EX6/GH8.3.4_A~~REP6-075].

4.6 The Environment Agency

~~4.6.1 Following~~All matters have been agreed between the submission of the draft parties. The final SoCG is submitted at Deadline 7 [EX7/GH8.3.5 [REP5-065], D]. The Environment Agency advised the Applicant received comments on that they will not sign the SoCG but have included a statement which is appended at the 18 March 2026.

~~4.6.2 These comments moved the following matters end to now be agreed: HYD-01; HYD-02; HYD-04; HYD-06; HYD-08; HYD-09; HYD-09; HYD-12; HYD-13; HYD-14 and HYD-15. These have largely been moved to agreed due to the updates that were made to the hydrology documents and Outline Battery Safety Management Plan [REP5-075] at Deadline 5.~~

~~4.6.3 The only outstanding items are EB-06; EB-07; HYD-11; GCC-01 and GCC-04~~

~~4.6.4~~4.6.1 The Applicant continues to liaise with the Environment Agency, and it is hoped confirm that a number of the matters under discussion will be agreed by Deadline 7 following review of the updated documents. they agree to the final SoCG.



4.7 Natural England

4.7.1 A Rule 17 Request for Further Information [PD-019] was issued by the Examining Authority to request that the previously final and signed SoCG be updated to reflect greater detail on a number of matters. This has been done under items ECO-04 and ECO-16.

~~4.7.14.7.2~~ All matters have been agreed between the parties. A further signed SoCG is submitted at Deadline ~~5 [REP5-1067 [EX7/GH8.3.6 C]~~.

4.8 National Highways

4.8.1 ~~There has been progression on matters with National Highways since~~ Following the submission at Deadline ~~5 on matters relating to the Draft DCO Revision E [EX6/GH3.1_E], specifically protective provisions. The Applicant has added a commitment~~ 6 of additional commitments in the Outline Construction Environmental Management Plan ~~[EX6, further discussion has taken place with National Highways to amend the wording in the Outline Construction Environmental Management Plan [EX7/GH7.1_C] which secures D]~~ to secure engagement with National Highways where any works are proposed within close proximity or adjacent to the Strategic Road Network (SRN).

~~4.8.2 The final SoCG will be submitted for Deadline 7.~~

4.8.2 All matters have now been agreed between the parties with the exception of DCO-007 specifically regarding Requirement 3 which is disagreed. An email is appended at the end to confirm that they agree to the final SoCG [EX7/GH8.3.7 B] but is unsigned.

4.9 Northamptonshire Fire and Rescue Service

4.9.1 All matters have been agreed between the parties by Deadline 2. A signed SoCG was submitted at Deadline 2 ~~[REP2-063]~~.

4.10 Anglian Water Services

4.10.1 All matters have been agreed between the parties. A signed SoCG is submitted at Deadline 6 ~~[EX6/GH8.3.9_BREP6-079]~~.

4.11 National Grid Electricity Transmission

~~4.11.1 The~~ Following the meeting between the Applicant ~~met and~~ National Grid Electricity Transmission Plc (NGET) on the 13 March 2026 ~~to discuss the Weston Marsh to East Leicestershire project regarding protective provisions and project timings, there was also discussion~~ discussions have continued on the ~~Sundon to Grendon scheme. Following this meeting, the NGET solicitor is considering amendments to the form of~~ appropriate Protective Provisions.

~~4.11.2 The Applicant remains committed to reaching an agreement with NGET on the form of protective provisions, with discussions well progressed. The final SoCG Applicant remains confident that an agreement will be submitted for Deadline 7.~~

reached, likely to be shortly after the close of Examination, such that the agreed form can be included in any DCO as made by the Secretary of State.
