1 Introduction

1.1 Purpose of the Document

1.1.1 This document provides a guide to the Development Consent Order (DCO) application for Green Hill Solar Farm. The Application is made by Green Hill Solar Farm Limited (the Applicant) to the Secretary of State for Energy Security and Net Zero (the Secretary of State) pursuant to the Planning Act 2008 (PA 2008).

1.1.2 The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of ground mounted solar photovoltaic (PV) generating stations (incorporating the solar arrays); grid connection infrastructure and energy storage; and the Cable Route Corridors (the Scheme). The Application is required because the Scheme is classified as a Nationally Significant Infrastructure Project (NSIP) under the PA 2008, being an onshore generating station within England of more than 50MW.

1.1.3 This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.

1.2 Document Referencing

1.2.1 Each document that forms part of this Application has been assigned a reference number that will allow it to be located within the Application document library. When an Application document refers to another document, then the full reference information is provided, highlighted with bold. This comprises the PINS reference ('EN010170'), followed by an indication that the document forms part of the Application ('APP'), or any deadline within the examination process ('EX1', 'EX2', etc.) and then the specific document number (for example, 'GH6.2.2'); this produces a full reference in the format **[EN010170/APP/GH6.2.2]**.

1.2.2 For documents that have already been submitted as part of the DCO application, or submitted to the examination process following acceptance of the DCO application on 19 June 2025, the 'PINS document reference' referred to is that in the [Green Hill Solar Farm Examination Library](#) as hosted by PINS. Any documents superseded by latter revisions are highlighted grey.

1.2.3 Submissions relating to the Change Application submitted in November 2025 are prefixed with 'CR1'. Prior to Deadline 3, the Change Application was accepted, and therefore the 'Change Application' versions of documents have superseded previous versions and the Guide has been updated to indicate this.

1.2.4 Submissions relating to the Change Application 2 submitted in February 2026 are prefixed with 'CR2'. Prior to Deadline 5, the Change Application was accepted, and therefore the 'Change Application' versions of documents have superseded previous versions and the Guide has been updated to indicate this.
