1 Introduction

1.1 Purpose of the Document

- 1.1.1 This document provides a guide to the Development Consent Order (DCO) application for Light Valley Solar. The Application is made by Light Valley Solar Limited (the Applicant) to the Secretary of State for Energy Security and Net Zero (the Secretary of State) pursuant to the Planning Act 2008 (PA 2008).
- 1.1.2 The Proposed Development, subject of the DCO Application, comprises a solar photovoltaic (PV) electricity generating station connecting over 100 megawatts (MW) to the Monk Fryston Substation, including associated development comprising Battery Energy Storage System (BESS), substations, grid connection infrastructure and other infrastructure integral to the construction, operation and maintenance, and decommissioning phases.
- 1.1.3 The Proposed Development is classified as a Nationally Significant Infrastructure Project (NSIP) under the PA 2008, being an onshore generation station within England of more than 50MW.
- 1.1.4 This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations, and section 37 of the PA 2008.

1.2 Document Referencing

- 1.2.1 Each document that forms part of this application has been assigned a reference number that is used throughout the DCO Application documents for the purposes of cross-referencing and sign-posting. When an application document refers to another document, then the full reference information is provided, highlighted in bold. This comprises the Planning Inspectorate (PINS) reference ('EN0110012') followed by an indication that the document forms part of the DCO Application ('APP'), and then the specific document number (for example, 'LVS/01.01'). This produces the full reference format, for example for the Application Cover Letter the reference is: **[EN0110012/APP/LVS/01.01]**.
