1 Introduction

1.1 Overview and purpose of the document

- 1.1.1 The planning application history information contained within this document has been compiled using the online application search function available from North Yorkshire Council (NYC)¹. The Planning Inspectorate website's project search function² has also been used to consider relevant applications for Nationally Significant Infrastructure Projects (NISPs).
- 1.1.2 An update to this appendix has been prepared for Examination Deadline 2 on 2nd September 2026. The application search has included a review of data available from the Landstack search tool.
- 1.1.3 The planning history has been collected for the area within and directly adjacent to the Proposed Development's Order Limits. Planning applications relating to each Solar Development Site (SDS) and the Cable Route Corridor (CRC) segments are documented below. Both planning applications within and intersecting with the Order Limits have been included.

2 Planning Applications for Solar Development Sites

- 2.1.1 All planning applications within or intersecting with the seven SDSs, which have been submitted within the past 10 years, are documented below. Furthermore, planning applications located directly adjacent to the Order Limits which have been submitted within the past 3 years, have been included below.
- 2.1.2 Note that where extant consents are identified in relation to the SDSs those developments are unlikely to progress on the basis the relevant applicants (the landowners) are support of the Proposed Development. The exception to this is the SSE NSIP application at Ferrybridge (EN0110011) where Light Valley Solar Limited and SSE are in dialogue.
- 2.1.3 Relevant planning applications, collected using this approach, are set out for each SDS in Table 2-1 to Table 2-6. Where no relevant planning applications were found, this has been noted.
