1 Introduction

1.1 Purpose of Technical Note

- 1.1.1 This Technical Note is a response to the Examining Authorities request, under Rule 17, for further information regarding the changes set out within the Schedule of Changes to the Book of Reference submitted at Deadline 2.
- 1.1.2 Table 1-1 of this Technical Note identifies all parties shown in the Schedule of Changes at Deadline 2, the plots affected, the category of change, the notification each party has received, and the date the notification was issued.

2 Schedule of Changes

2.1 Approach to Diligent Inquiry

- 2.1.1 The Applicant has maintained an ongoing programme of land referencing throughout the pre-Examination and Examination period to ensure that the Book of Reference remains accurate and up to date. As a result, changes identified within the Schedule of Changes arise from several distinct sources, each of which is categorised and recorded against the relevant entry in the table below.

The categories used are:

- HMLR Refresh: updates identified through on-going HM Land Registry searches, including additions to the register, removals from the register, or amendments to existing ownership and interest information.
- Companies House Update: changes to company names or registered addresses identified through on-going checks of Companies House records.
- Continued Diligent Inquiry: new information obtained through ongoing diligent inquiry activities, including Land Interest Questionnaires (LIQs), site visits, telephone discussions, correspondence, or email responses.
- Quality Assurance: amendments made to rectify data entry errors identified during review.
- Relevant Representation: changes arising from new information provided within Relevant Representations.
- Written Representation: changes arising from new information provided through Written Representations or subsequent Examination submissions.

- 2.1.2 Each amendment within the Schedule of Changes is identified against one of the above categories, providing a clear audit trail of the source of the information and the reason for the update.

- 2.1.3 This approach enables the Examining Authority to distinguish between changes arising from routine data refreshes, continued diligent inquiry, corrections, and

information newly provided by affected persons or interested parties during the Examination process and explains why they have not been previously identified.

2.1.4 In response to the other queries raised:

- where new parties have been identified, they have been notified of the Examination; the table below indicates the date that they were sent a letter notifying them of the Examination. That party will then decide whether or not to participate in the Examination and the Applicant considers that they have sufficient time within the Examination to have a fair opportunity to participate in the Examination; and
- the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 are not engaged, as they relate specifically to the identification of new additional land subject to compulsory acquisition of land or rights power, rather than additional interests only.

2.1.5 The Applicant notes that its approach to on-going diligent inquiry is consistent with the approach taken by all DCO promoters to ensure that the Book of Reference remains as up to date as possible.
