1 Introduction

1.1 Purpose of this document

- 1.1.1 This document has been prepared on behalf of The Drovers Solar Farm Limited (the Applicant) in relation to an application (the DCO Application) for a Development Consent Order (DCO) to be made to the Secretary of State (SoS) to construct, operate and maintain, and decommission The Drovers Solar Farm (the Scheme), pursuant to the Planning Act 2008 (PA 2008).
- 1.1.2 In Annex H of the **Rule 6 letter [PD-006]**, the Examining Authority (ExA) made a request that Interested Parties submit suggested locations for the ExA to visit as part of an Accompanied Site Inspection (ASI) by Procedural Deadline A (22 April 2026).
- 1.1.3 At Procedural Deadline A, a total of three 'suggested locations for site inspections' representations were made. These were made by:
- **Borough Council of King's Lynn and Norfolk [PDA-003]**
 - **Sporle with Palgrave Parish Council [PDA-004]**; and
 - **Castle Acre Parish Council [PDA-005]**.
- 1.1.4 Two of the representations frame references to locations from an Unaccompanied Site inspection (USI) perspective instead of an ASI perspective. The Applicant considers that such reference does not diminish the suggestions made and, therefore, all three representations have been considered by the Applicant in informing this draft ASI.
- 1.1.5 This draft ASI is prepared in accordance with Item 5 of Annex H of the **Rule 6 letter [PD-006]** which requested that the Applicant produce a draft itinerary for the ASI. The ExA requested that the draft ASI takes account of:
- relevant locations referred to in the relevant representations received
 - any other locations at which the applicant has predicted likely significant environmental effects; and
 - the locations suggested by interested parties submitted by Procedural Deadline A.
- 1.1.6 This document has been updated between Deadlines 3 and 4, and accepted at the discretion of the Examining Authority, in respect of the commitments made by the Applicant in the **Applicant's Response to Written Representations and other Deadline 2 Submissions [REP3-087]** to update this document to account for Castle Acre Parish Council's **[REP2-034]** and Sporle with Palgrave Parish Council's **[REP2-038]** comments on the draft itinerary ASI. The document references have not been updated from the original submission. Please refer to the **Guide to the Application [APP/1.3.5]** for the list of current versions of documents.



1.1.7 At Deadline 2, two submissions were made which provided comment on this document. These are:

- Sporle with Palgrave Parish Council [REP2-038]; and
- Castle Acre Parish Council [REP2-034].

4.1.61.1.8 Accordingly, the purpose of this document is to provide a revised draft itinerary for an ASI, taking into account the above, for consideration by the ExA for an ASI to be undertaken during week commencing 7 September 2026.

1.2 Approach to identify the ASI route

1.2.1 The Applicant has taken representations and likely significant effects into account when identifying the locations set out within this draft itinerary.

1.2.2 **Table 2-1** sets out a list of locations which the Applicant considers important for the ExA to visit in understanding the Scheme.

1.2.3 It is recognised that the ExA has undertaken an USI across 10 March 2026 and 11 March 2026 [\[EV1-001\]](#) and, accordingly, the Applicant has sought to identify a route that does not duplicate locations already visited, albeit it is acknowledged that the USI undertaken was comprehensive.

1.2.4 The Applicant has also undertaken a review of suggested locations put forward at Procedural Deadline A and Deadline 2 by Interested Parties. **Table 2-2** sets out the locations that have been either included or excluded, alongside accompanying commentary.

1.2.5 The Applicant welcomes further comments from the ExA and other interested parties to finalise an agreed route and itinerary for the ASI.

1.2.6 In direct response to the ExA's request for the draft ASI to take account of certain matters:

1) *"relevant locations referred to in the relevant representations received"*

- a. The Applicant does not consider that any relevant representations received referred to or suggested locations for inspection beyond those that the ExA has already inspected during their Unaccompanied Site Inspection (USI) [\[EV1-001\]](#) or that has not been previously suggested by the Applicant in the **Procedural Deadline A Cover Letter** [\[PDA-001\]](#).

2) *"any other locations at which the applicant has predicted likely significant environmental effects"*

- b. The Applicant does not consider that any new locations need to be considered beyond those previously suggested by the Applicant in the **Procedural Deadline A Cover Letter** [\[PDA-001\]](#).



3) *“the locations suggested by interested parties submitted by procedural deadline A”*

- c. The Applicant notes, in **Table 2-2**, the suggested locations put forward by Interested Parties and whether the Applicant has included these as part of the Draft Itinerary for the ASI. The Applicant notes that **Castle Acre Parish Council** [\[PDA-005\]](#) did not suggest any locations but made a request for USIs around the local area during the hours of full darkness to better understand the impact that the Customer Substation, the National Grid Substation and BESS, with security lighting, might have on the rural environment.

2 Revised Draft Itinerary for the ASI

2.1 Overview

- 2.1.1 The revised draft itinerary for the ASI is set out in **Table 2-1**. The ASI comprises a combination of stops and walks to observe the Scheme. Proposed timings are set out along with a description of what is to be observed at each location. While the Applicant will endeavour to follow the proposed route and timings as closely as possible, external factors such as weather, traffic, and land access may slightly affect these timings. Those who intend to join the ASI at a specific location along the route should inform the Planning Inspectorate's case team via email or telephone in advance.
- 2.1.2 A plan showing the proposed route and comfort breaks is provided in **Annex B**.

2.2 Health and Safety

- 2.2.1 It will be necessary to wear a high visibility vest during the ASI. The Applicant will provide a high visibility vest to attendees for use during the course of the ASI.
- 2.2.2 The ASI will involve walking on terrain that may be uneven. Anyone who may find it challenging to walk in these conditions is advised to assess whether it is suitable for them to attend the ASI, either partially or in its entirety.
- 2.2.3 Some obstructions on public rights of way (PRoWs) and at field entrances may require attendees to crouch down to pass.
- 2.2.4 A first aid kit will be provided on the minibus.
- 2.2.5 The Applicant will carry out a walk of the route ahead of the ASI to identify potential hazards in advance in order to inform a Health and Safety Briefing that will be provided to all attendees at the start of the ASI.

2.3 Transport

- 2.3.1 Given the nature of the inspection points, it is considered more efficient and safer for all parties to travel in a minibus(es). Therefore, the Applicant proposes to hire a minibus(es) to aid transit around the Site.
- 2.3.2 The Applicant will provide transport for all attendees of the ASI. The meeting place to board the transport (and hence also the starting point for the ASI) is Hall Farm, Narford, Kings Lynn, Norfolk, PE32 1JA.
- 2.3.3 The minibus(es) provided by the Applicant will return to Hall Farm, Narford, Kings Lynn, Norfolk, PE32 1JA at the conclusion of the ASI.



2.4 Clothing

- 2.4.1 The ASI may include some walking on uneven or wet ground. It is therefore advised that attendees bring sturdy footwear and wear clothing that is appropriate for the weather and conditions on the day.
- 2.4.2 Foliage on PRowWs and at field boundaries/entrances can be tall and overgrown. All attendees are requested to wear clothing that keeps their arms and legs covered at all times.

2.5 Comfort Breaks

- 2.5.1 Comfort breaks will be available at Hall Farm, Narford, Kings Lynn, Norfolk, PE32 1JA in the morning before departing for the ASI, during lunch at Waitrose & Partners in Swaffham (Castle Acre Rd, Swaffham PE37 7HT) and after the ASI at Hall Farm, Narford, Kings Lynn, Norfolk, PE32 1JA.

2.6 On the day

- 2.6.1 With regards to the proposed comfort breaks and lunch break, please note that food and refreshments will not be provided by the Applicant. The route proposes to stop at Waitrose & Partners in Swaffham (Castle Acre Rd, Swaffham PE37 7HT) for attendees to purchase their own lunch and to provide a comfort break.
- 2.6.2 The Applicant will provide paper copies of the itinerary and the route map to aid navigation.
- 2.6.3 The Applicant notes that, aside from the start and end of the ASI at Hall Farm, Narford, Kings Lynn, Norfolk, PE32 1JA, all locations proposed are publicly accessible by PRowWs.

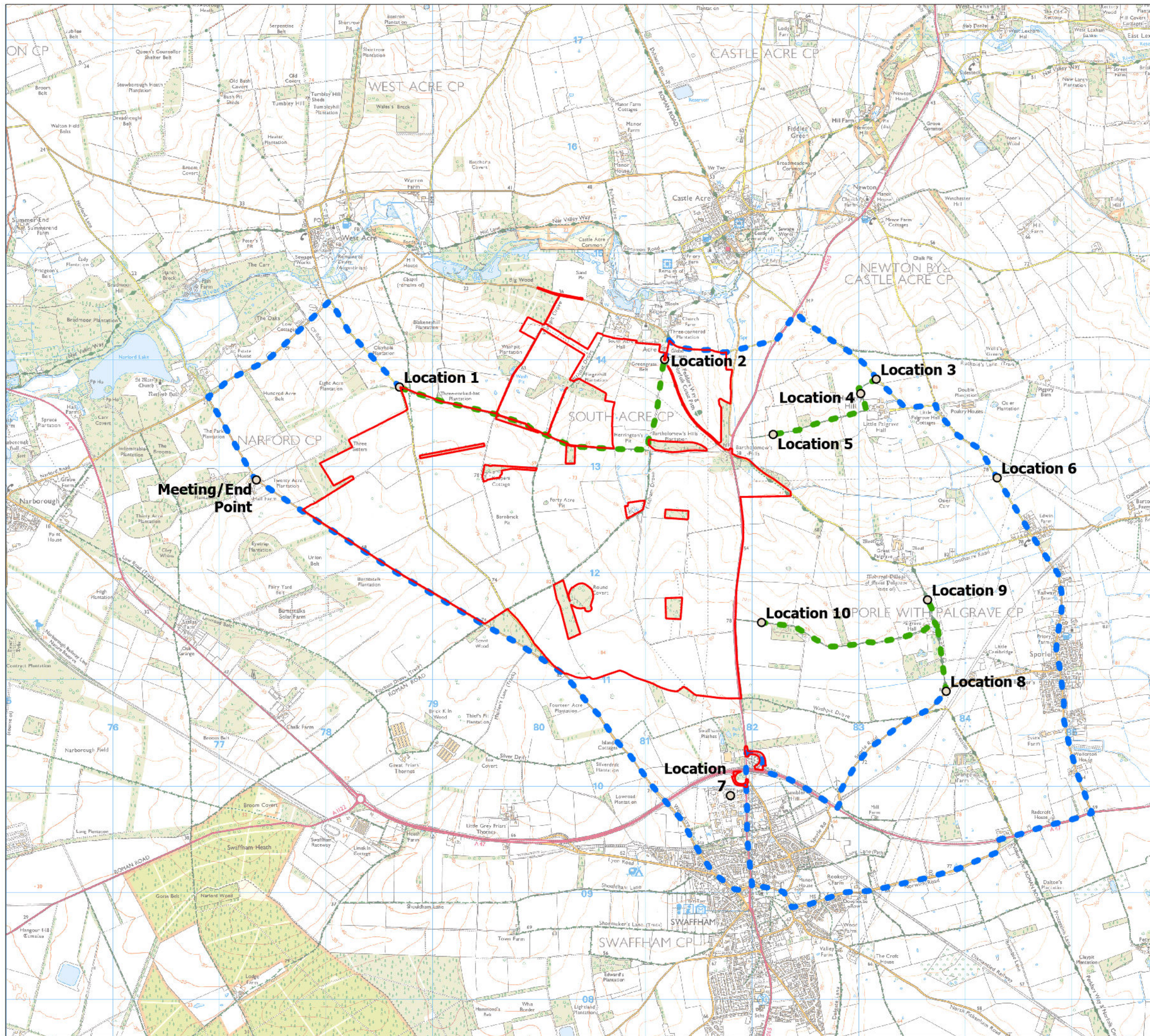

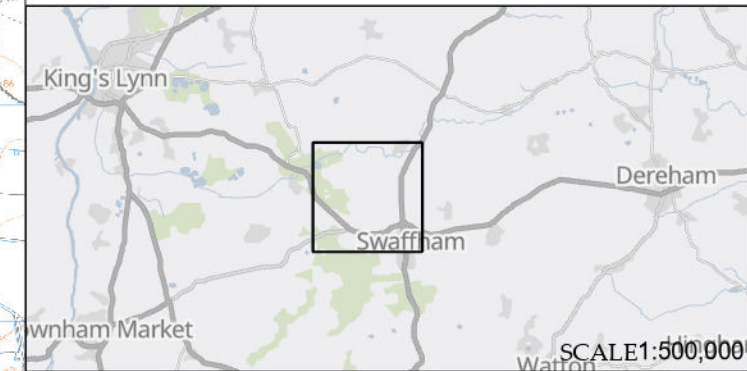
