The Applicant is submitting a Compulsory Acquisition and Temporary Possession Objections Schedule (**Document 8.4.4**) as requested by the ExA.

The Applicant is not submitting an updated Book of Reference or Schedule of Changes to the Book of Reference as requested in the Rule 8 letter **[PD-003]**, as the versions submitted at Deadline 1 **[REP1-005 and REP1-027]** have not materially changed. Updated versions will be submitted at future Deadlines as required.

### Draft Development Consent Order

The Applicant is submitting an updated draft Development Consent Order (**Document 3.1 (B)**) and the related Schedule of Changes (**Document 8.4.2 (A)**) as requested in the Rule 8 Letter dated 19 September 2023 **[PD-003]**. An updated Explanatory Memorandum **[APP-035]** was not requested for Deadline 2 but will be submitted at Deadline 3.

### Comments on any Other Submissions at Deadline 1

The Applicant does not wish to make comments on any other submissions made by Interested Parties at Deadline 1 at this stage. The Applicant will provide comments on the Local Impact Reports submitted by the Host Authorities at Deadline 3. The Applicant notes the combined representation of the Parish Councils of Assington, Bures St Mary, Leavenheath, Little Cornard, Polstead and Stoke by Nayland **[REP1-070]**. The points raised are similar to those raised within the submitted Local Impact Reports and therefore the Applicant will comment as part of the Deadline 3 response to those.
