The Navigation Document (**Document 1.4 (C)**) has been updated to reflect the above submissions.

The Applicant wishes to make the following observations by exception:

## Plans and Drawings

The Applicant is submitting an updated Design and Layout Plans Temporary Bellmouth for Access (**Document 2.11.12 (B)**) to correct an error on the previously submitted Design and Layout Plans Temporary Bellmouth for Access wherein the sight lines were incorrectly shown as extending into the public highway. This is now correctly shown with the sight lines terminating at the kerb line of the public highway.

## Management Plans

The Applicant is submitting updated Management Plans (**Documents 7.5 (B), 7.5.1 (B), 7.5.2 (B), 7.6 (B), 7.7 (B) and 7.8 (B)**) to address comments made at Deadline 1 and 2, in particular with reference to perceived 'ambiguous wording'. A schedule of the changes made to these Management Plans is provided in **Document 8.5.7**. An additional Management Plan, a Public Right of Way Management Plan (**Document 8.5.8**), is also submitted.

The Applicant is in the process of producing a full REAC, as noted in the Applicant's Response to Issue Specific Hearing 1 Action Points (Action Point 20) **[REP1-034]**.

Due to the important status of this document as a securing mechanism for the commitments made on the project, the Applicant has not completed this task for Deadline 3 and will submit this at a future deadline. Therefore, the REAC presented at Deadline 3 (**document 7.5.2 (B)**) reflects only the changes that have been made by the Applicant in terms of additional and/or amended embedded measures in response to matters raised in Deadline 1 or Deadline 2 documents.
