An application has been made under paragraph 2 of Schedule 6 of the Planning Act 2008(a) to the Secretary of State in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011(b) for a non-material change to the National Grid (North London Reinforcement Project) Order 2014(c).

The Secretary of State, having considered the application and the response to the publicity and consultation carried out in accordance with Regulations 6 and 7 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, has decided to make this Order amending the National Grid (North London Reinforcement Project) Order 2014.

The Secretary of State, in exercise of the powers conferred by paragraph 2 of Schedule 6 to the Planning Act 2008, makes the following Order.

Citation and commencement

1. —This Order may be cited as the National Grid (North London Reinforcement Project) (Amendment) Order 202[] and comes into force on [x]th [xxxxx] 202[].

Amendments to the National Grid (North London Reinforcement Project) Order 2014

2. —The National Grid (North London Reinforcement Project) Order is amended as follows.

3.—(1) The undertaker must, as soon as practicable after the making of this Order, submit copies of any substitute plans to the Secretary of State for certification that they are true copies of the plans referred to in this Order.

(2) A plan so certified by the Secretary of State is admissible in any proceedings as evidence of the contents of the document of which it is a copy.

(3) In paragraph (1) the “undertaker” has the same meaning as in article 2(1) of the National Grid (North London Reinforcement Project Order 2014).

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the National Grid (North London Reinforcement Project) Order 2014 (the “2014 Order”), a development consent order granted under the Planning Act 2008 (“the Act”).

This Order follows an application under paragraph 2 of Schedule 6 to the Act for a non-material change to the 2014 Order to allow works to facilitate the bypass of Tottenham substation using a short section of overhead electric line.

The Order also allows a minor extension to the Order Limits required to facilitate the overhead line bypass. The Applicant owns the land covered by the extension, and the Applicant is therefore not seeking new or additional authority to acquire compulsorily land or rights in land.

This Order provides for the certification of substitute plans and any certified plan is admissible in any proceedings as evidence of the contents of the plan of which it is a copy.
