# The Brechfa Forest Wind Farm Connection (Correction) Order 2017

The Brechfa Forest Wind Farm Connection Order 2016 (the "Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contains correctable errors within the meaning of the Act.
