1. Construction Dust Assessment Methodology

1.1 Assessment Methodology

- The dust risk assessment has been carried out in accordance with the Institute of Air Quality Management (IAQM) construction dust guidance (IAQM, 2024).
- The steps for assessing dust emissions in accordance with the IAQM construction dust guidance (IAQM, 2024) are detailed in the following sections.

Step 1

- Step 1 screens the requirement for a more detailed assessment. Should human receptors be identified within 250 m of the Order Limits or 50 m from the construction vehicle route up to 250 m from the proposed bellmouths, then the assessment proceeds to Step 2. Additionally, should ecological receptors be identified within 50 m of the Order Limits or 50 m from the construction vehicle route up to 250 m from the proposed bellmouths, then the assessment also proceeds to Step 2.
- 1.1.4 At the request of Natural England, these distances have been amended such that the study area for ecological receptors is the same as for human receptors, i.e. an area within 250 m of the boundary or 50 m from the construction vehicle route up to 250 m from the proposed bellmouths.
- Should sensitive receptors not be present within the relevant distances then negligible impacts would be expected and further assessment is not necessary.

Step 2

- Step 2 assesses the risk of potential dust impacts. A site is allocated a risk category based on two factors:
 - the scale and nature of the works, which determines the potential dust emission magnitude as: small, medium or large (Step 2A); and,
 - the sensitivity of the area to dust impacts, which can be defined as low, medium or high sensitivity (Step 2B).
- 1.1.7 The two factors are combined in Step 2C to determine the risk of dust impacts without mitigation applied.
- Step 2A defines the potential magnitude of dust emission through the construction phase. The relevant criteria are summarised in Table 1.1.

- 1.1.10 The guidance also provides the following factors to consider when determining the sensitivity of an area to potential dust impacts:
 - any history of dust generating activities in the area;
 - the likelihood of concurrent dust generating activity on nearby sites;
 - any pre-existing screening between the source and receptors;
 - any conclusions drawn from analysing local meteorological data which accurately represent the area;
 - the season during which works will take place;
 - any conclusions drawn from local topography;
 - duration of the potential impact, as a receptor may become more sensitive over time;
 and
 - any known specific receptor sensitivities which go beyond the classifications given in the document.
- 1.1.11 These factors were considered when undertaking the assessment.
- The criteria for determining the sensitivity of the area to dust soiling effects on people and property is summarised in Table 1.3.

Step 3

Step 3 requires the identification of site-specific mitigation measures within the guidance to reduce potential dust impacts based upon the relevant risk categories identified in Step 2. For sites with negligible risk, mitigation measures beyond those required by

legislation are not required. However, additional controls may be applied as part of good practice.

Step 4

Once the risk of dust impacts has been determined and the appropriate mitigation measures identified, the final step is to determine the significance of any residual impacts. For almost all construction activity, the aim should be to control effects using effective mitigation. Experience shows that this is normally possible, hence the residual effect will normally be not significant.

1.2 Assessment

Step 1

- The undertaking of activities such as excavation, ground works, cutting, construction and storage of materials has the potential to result in fugitive dust emissions throughout the construction phase. Vehicle movements both on-site and on the local road network also have the potential to result in the re-suspension of dust from highway surfaces. This construction dust assessment has been carried out to assess the risk associated with dust emissions from construction related activities associated with the Proposed Project.
- The potential for impacts at sensitive locations depends significantly on local meteorology during the undertaking of dust generating activities, with the most significant effects likely to occur during dry and windy conditions.
- A desk-study identified sensitive human receptors within 250 m of the Order Limits, mostly residential properties and farms in the area, which are displayed in **Application Document 6.4.2.8.1 Suffolk Construction Dust Assessment Study Area**.
- There are several ecological sites identified within 250 m of the Order Limits which are outlined in Table 1.9 and in Application Document 6.4.2.8.1 Suffolk Construction Dust Assessment Study Area.

Step 2A

Demolition

The Proposed Project does not include any proposed demolition activity, as such impacts from demolition have not been considered further in the assessment.

Earthworks

The total site area is greater than 110,000 m² and the soil type mostly consists of sand. At this stage there is no information available on the number of heavy earth-moving vehicles at any one time. However, given the large extent of the Proposed Project, the potential dust emission magnitude for construction is considered to be **large**.

Construction

The total building volume is likely to be greater than 75,000 m³ and construction materials would include concrete. There is expected to be no on-site concrete batching but based on the building volume size and material type, the potential magnitude of dust emissions from construction is considered to be **large** as a worst case.

Trackout

- During the peak year of the construction phase of the project, there are likely to be on average 36 outward HDV movements per day from the main bellmouths. The access tracks for construction HDVs would be unpaved and would be greater than 100 m in length. As such the magnitude of potential dust emissions from trackout is considered to be **large** as a worst case.
- The dust emission magnitude for each dust generating activity for the Proposed Project is summarised in Table 1.10.

Step 2B

Receptors sensitive to potential dust impacts during earthworks and construction activities were approximated from a desktop study of the area up to 250 m from the Order Limits. These are summarised in Table 1.11.

- In accordance with the IAQM construction dust guidance (IAQM, 2024), the highest level of sensitivity should be recorded from the criteria outlined in the guidance.
- The IAQM construction dust guidance (IAQM, 2024) defines residential properties and schools as being high sensitivity receptors to dust soiling impacts and therefore the sensitivity of the surrounding area for dust soiling impacts has been determined based

- on the number of high sensitivity receptors and the distance of the receptor from the source (refer to Table 1.3).
- To determine the sensitivity of the receiving environment for human health effects, the maximum 2024 PM $_{10}$ background concentration across the Order Limits was obtained from the Defra website (Defra, 2024) and identified as being 12.5 μ g/m 3 . Therefore, in accordance with the IAQM construction dust guidance (IAQM, 2024), health impacts should be determined based on the criteria within the less than 24 μ g/m 3 category (refer to Table 1.4). As the human receptors include residential properties, the sensitivity of the receptor is considered to be high and therefore the sensitivity of the surrounding area for human health impacts has been determined based on the number of high sensitivity receptors within the less than 24 μ g/m 3 background PM $_{10}$ category and the distance of the receptors from the source (refer to Table 1.4).
- In accordance with the IAQM construction dust guidance (IAQM, 2024) internationally and nationally designated sites such as SPAs and SSSIs are defined as high sensitivity for ecological impacts, therefore the sensitivity of the area to ecological impacts has been determined based on the high receptor sensitivity category and the distance of the receptor from the source (Table 1.5).
- The sensitivity of the receiving environment to specific dust impacts is summarised in Table 1.13.

Step 2C

The risk of effects in the absence of environmental measures was then defined based upon the interaction between the magnitude of emission and the highest level of area sensitivity (determined in Steps 2A and 2B, respectively) for each dust generating activity. The risk of dust effects was determined, as presented in Table 1.14.

- As indicated in Table 1.14, the potential risk of dust soiling is high for earthworks, construction and trackout. The potential risk of human health impacts is low for earthworks, construction and trackout. The potential risk of dust impacts on ecological sites is high for earthworks, construction and trackout. The assessment has therefore indicated that the risk of dust effects is high as a worst case for the Proposed Project.
- 1.2.19 It should be noted that the potential for impacts depends significantly on the distance between the dust generating activity and receptor location. Risk was predicted based on a worst-case scenario of works being undertaken at the edge of the Order Limits. Therefore, actual risk is likely to be lower than that predicted during the majority of the construction phase.

Step 3

The IAQM construction dust guidance (IAQM, 2024) provides potential mitigation measures to reduce impacts as a result of fugitive dust emissions during the construction phase. These have been adapted for the Proposed Project based on the risk of dust effects (Table 1.14) and are summarised in Table 1.15.
