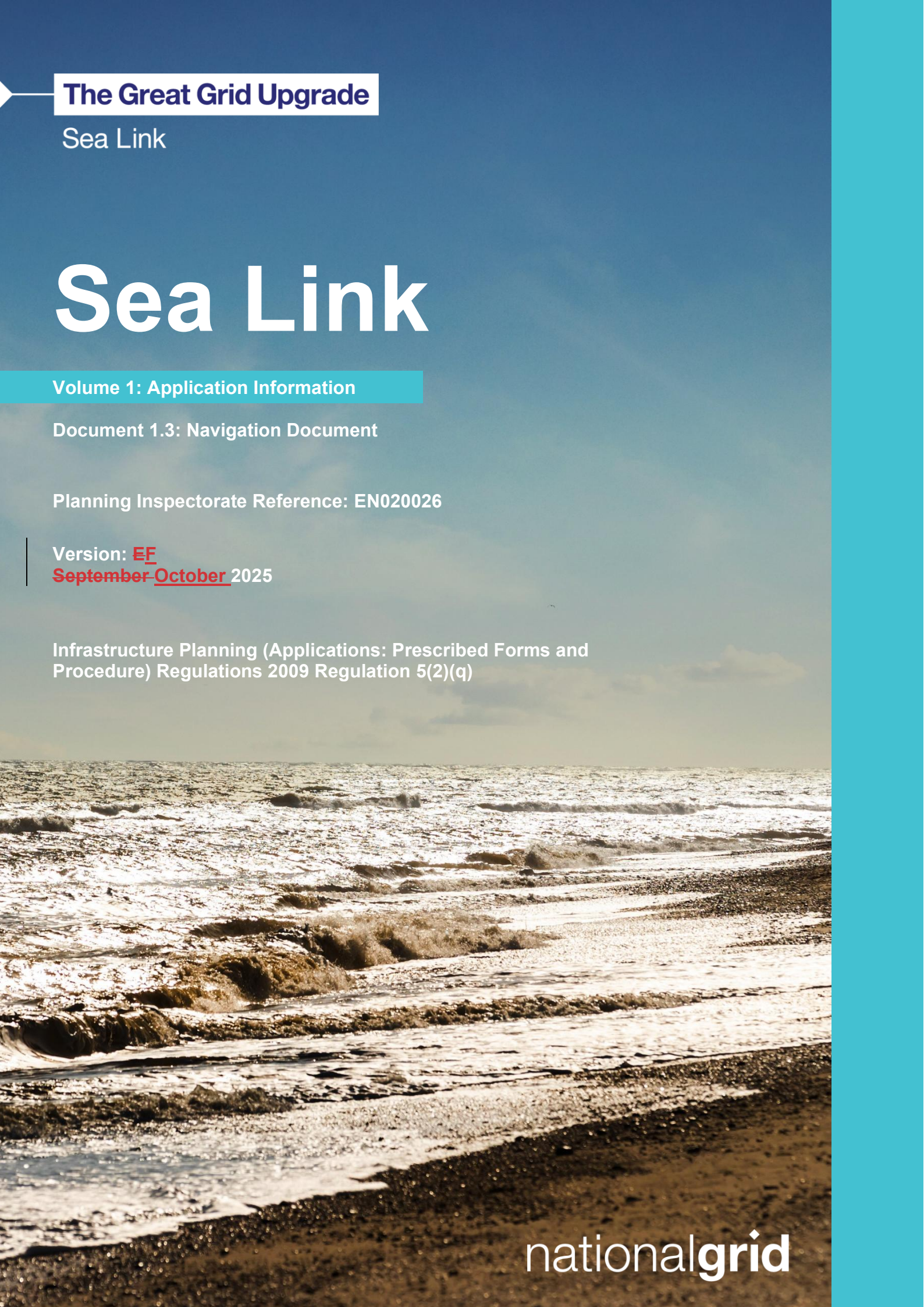

1. Introduction

1.1 Overview

- 1.1.1 The Sea Link Project (hereafter referred to as the 'Proposed Project') is a proposal by National Grid Electricity Transmission plc (hereafter referred to as National Grid) to reinforce the transmission network in the South East and East Anglia. The Proposed Project is required to accommodate additional power flows generated from renewable and low carbon generation, as well as accommodating additional new interconnection with mainland Europe.
- 1.1.2 National Grid owns, builds and maintains the electricity transmission network in England and Wales. Under the Electricity Act 1989, National Grid holds a transmission licence under which it is required to develop and maintain an efficient, coordinated, and economic electricity transmission system.
- 1.1.3 This would be achieved by reinforcing the network with a High Voltage Direct Current (HVDC) Link between the proposed Friston substation in the Sizewell area of Suffolk and the existing Richborough to Canterbury 400kV overhead line close to Richborough in Kent.
- 1.1.4 National Grid is also required, under Section 38 of the Electricity Act 1989, to comply with the provisions of Schedule 9 of the Act. Schedule 9 requires licence holders, in the formulation of proposals to transmit electricity, to:
- 1.1.5 Schedule 9(1)(a) '*...have regard to the desirability of preserving natural beauty, of conserving flora, fauna and geological or physiographical features of special interest and of protecting sites, buildings and objects of architectural, historic or archaeological interest;*' and
- 1.1.6 Schedule 9(1)(b) '*...do what [it] reasonably can to mitigate any effect which the proposals would have on the natural beauty of the countryside or on any such flora, fauna, features, sites, buildings or objects*'.
- 1.1.7 The purpose of this document is to summarise the structure of the application for development consent for the Proposed Project. Its purpose is to provide an overview of the application structure and principal contents within each 'volume' of documents shown in [Table 1.1](#).
- 1.1.8 An Application Document Tracker is provided in Appendix A of this document in order to help the Examining Authority and Interested Parties understand the application as it evolves through the Examination by identifying the latest version of any application document.

1.2 The Proposed Project

1.2.1 The Proposed Project would comprise the following elements:

The Suffolk Onshore Scheme

- A connection from the existing transmission network via Friston Substation, including the substation itself. Friston Substation already has development consent as part of other third-party projects. If Friston Substation has already been constructed under another consent, only a connection into the substation would be constructed as part of the Proposed Project.
- A high voltage alternating current (HVAC) underground cable of approximately 1.9 km in length between the proposed Friston Substation and a proposed converter station (below).
- A 2 GW high voltage direct current (HVDC) converter station (including permanent access from the B1121 and a new bridge over the River Fromus) up to 26 m high plus external equipment (such as lightning protection, safety rails for maintenance works, ventilation equipment, aerials, similar small scale operational plant, or other roof treatment) near Saxmundham.
- A HVDC underground cable connection of approximately 10 km in length between the proposed converter station near Saxmundham, and a transition joint bay (TJB) approximately 900 m inshore from a landfall point (below) where the cable transitions from onshore to offshore technology.
- A landfall on the Suffolk coast (between Aldeburgh and Thorpeness).

The Offshore Scheme:

- Approximately 122 km of subsea HVDC cable, running between the Suffolk landfall location (between Aldeburgh and Thorpeness), and the Kent landfall location at Pegwell Bay.

The Kent Onshore Scheme:

- A landfall point on the Kent coast at Pegwell Bay.
- A TJB approximately 800 m inshore to transition from offshore HVDC cable to onshore HVDC cable, before continuing underground for approximately 1.7 km to a new converter station (below).
- A 2 GW HVDC converter station (including a new permanent access off the A256), up to 28 m high plus external equipment such as lightning protection, safety rails for maintenance works, ventilation equipment, aerials, and similar small scale operational plant near Minster. A new substation would be located immediately adjacent.
- Removal of approximately 2.2 km of existing HVAC overhead line, and installation of two sections of new HVAC overhead line, together totalling approximately 3.5 km, each connecting from the substation near Minster and the existing Richborough to Canterbury overhead line.

- 1.2.2 The Proposed Project also includes modifications to sections of existing overhead lines in Suffolk (only if Friston Substation is not built pursuant to another consent) and Kent, diversions of third-party assets, and land drainage from the construction and operational footprint. It also includes opportunities for environmental mitigation and compensation. The construction phase will involve various temporary construction activities including overhead line diversions, use of temporary towers or masts, working areas for construction equipment and machinery, site offices, parking spaces, storage, accesses, bellmouths, and haul roads, as well as watercourse crossings and the diversion of public rights of way (PROWs) and other ancillary operations.

1.3 Application documentation

- 1.3.1 The documents submitted as part of this application have been grouped into the below document volumes noted within Table 1.1 to accord with the Planning Inspectorate's Advice on the Preparation and Submission of Application Documents published in August 2024 and updated in January 2025.

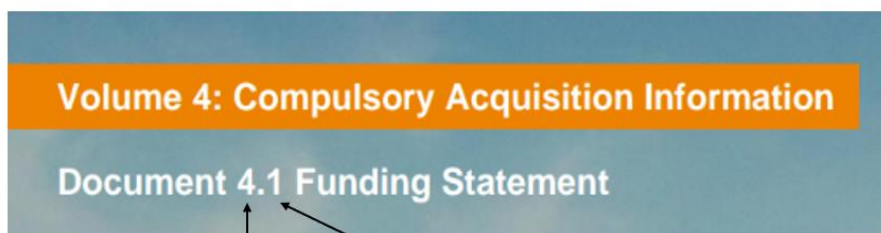
1.3.2 Each volume has been colour coded for ease of reference. The corresponding colour is displayed on the front cover of each document within this application to convey what volume it forms part of.

1.3.3 Section 2 of this document provides a summary of the purpose of the documents and plans included within each volume described in Table 1.1 above. The documents meet the requirements of the APFP Regulations.

1.4 Document referencing

1.4.1 The documents submitted as part of this application each have an individual document reference number which follow a consistent numbering format to help the reader navigate the application documents.

1.4.2 Documents are numbered in sequence with the respective volumes. The volume number is the first digit of a document number, followed by the document number and where relevant the chapter and/or appendix number. Examples are provided in Plates 1.1 to 1.4 below.



Volume number – in this instance, Volume 4 is Compulsory Acquisition Information.

Document number – in this instance, 4.1 is the Funding Statement and is the first of the compulsory acquisition documents.

Plate 1.1 Document referencing example 1

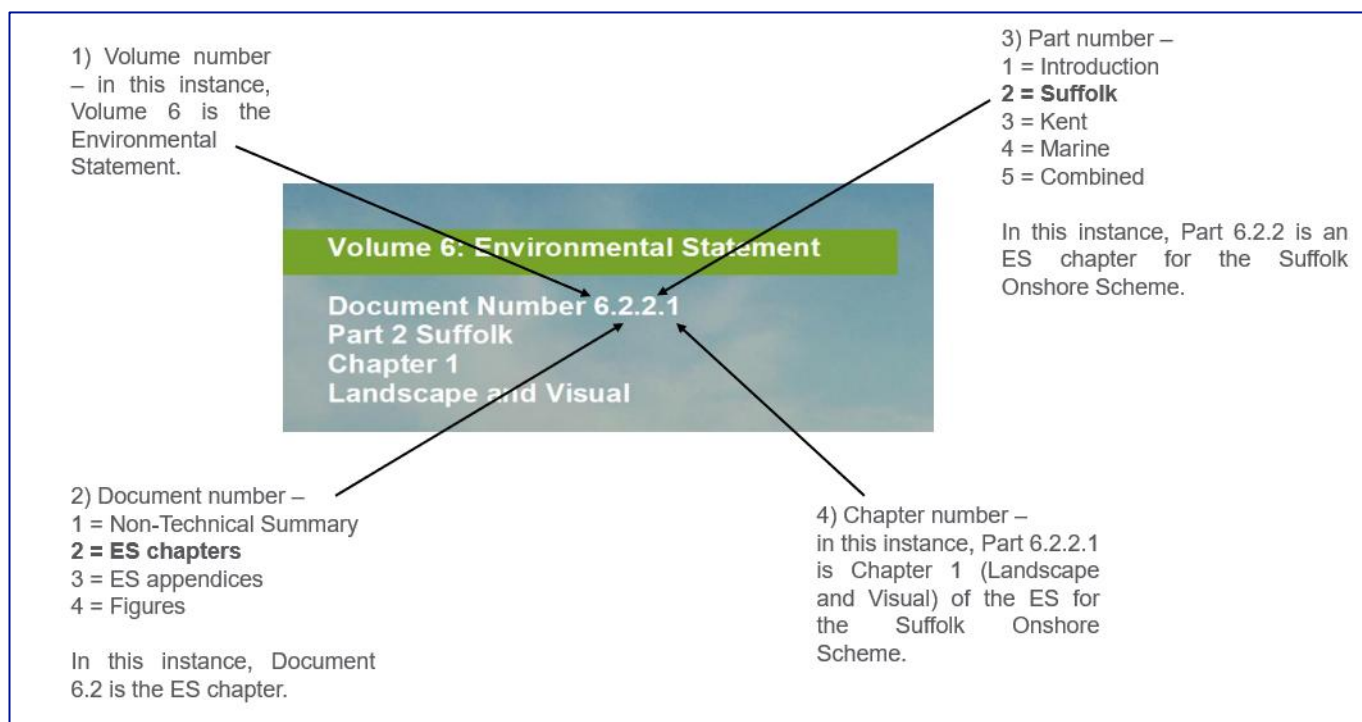


Plate 1.2 Document referencing example for an ES chapter

2. Application volumes

2.1 Volume 1: Application Information

- 2.1.1 This volume sets out the overarching project information and documents provided in accordance with application administrative requirements.

Volume 1 contents

- 2.1.2 The following documents are contained within this volume:
- **1.1 Cover Letter** – sets out the subject of the application and supporting documentation enclosed;
 - **1.2 Application Form** – is a standard form and provides a high-level summary of the Proposed Project and the documents that have been submitted. It is a form that originates from Schedule 2 of the APFP Regulations and is submitted in accordance with Section 37(3)(b) of the Planning Act 2008 and Regulation 5(1) of the APFP Regulations;
 - **1.3 Navigation Document** – (this document) acts as a guide to the application, providing a brief description of the volumes and documents that make up the application;
 - **1.4 Electronic Application Index** – is the list of electronic file names, reference numbers for each document, and the regulation numbers provided in each volume submitted with the application;
 - **1.5 Self Completed Section 55 Checklist** – is included to demonstrates how the application complies with the provisions of Section 55 of the Planning Act 2008; and
 - **1.6 Glossaries and Acronyms** – explains the language used in the application.

2.2 Volume 2: Plans and Drawings

- 2.2.1 This volume contains the plans that show where and how the proposed works will take place.
- 2.2.2 There are 13 different types of plans and drawings submitted within this volume in support of the application (excluding **Application Document 2.1 Guide to the Plans**).
- 2.2.3 In accordance with Regulation 5(4) of the APFP Regulations, where a plan comprises three or more sheets, a key plan is provided showing the relationship between the different sheets. Each set of plans (and each sheet within a set of plans) includes a key which explains the use of symbols/lines/shading to note features and information in the plans.
- 2.2.4 The Proposed Project has been subdivided into three sections:
- Suffolk Onshore Scheme
 - The Offshore Scheme
 - Kent Onshore Scheme
- 2.2.5 All plans are ordered from North (Saxmundham, Suffolk) to South (Minister, Kent). Further information on the Proposed Project sections and detail on what the different plans and drawings show is presented in **Application Document 2.1 The Guide to the Plans**.

2.3 Volume 3: Draft Development Consent Order

- 2.3.1 National Grid requires development consent from the Secretary of State to construct, operate and maintain the Proposed Project. This volume contains details of the legal powers being sought by National Grid.

Volume 3 contents

- 2.3.2 The following documents are contained within this volume:

- **3.1 Draft Development Consent Order (DCO)** – sets out the legal powers that National Grid is seeking to enable the construction, operation and maintenance of the Proposed Project. It is comprised of 62 articles and 19 schedules. The schedules are listed below:

 - Schedule 14: Trees Subject to Tree Preservation Orders
 - Schedule 15: Protective Provisions

 - Schedule 17: Public General Legislation
 - Schedule 18: Amendment of Local Legislation
 - Schedule 19: Certified Documents
- **3.2 Explanatory Memorandum** – explains the purpose and effect of each provision in the draft DCO including why it is necessary;

- **3.3 Validation Report for the Development Consent Order** – confirms that the draft DCO conforms to the current Statutory Instrument (SI) template, as required by the Planning Inspectorate’s Advice Note 15: Drafting Development Consent Orders published in 2018;
- **3.4 Draft Development Consent Order (DCO) (Editable Version)** – the draft DCO has also been provided in an editable word version to assist the Examining Authority; and
- **3.5 Consents and Agreements Position Statement** – sets out the intended strategy for obtaining the consents and associated agreements needed to implement the Proposed Project.

2.4 Volume 4: Compulsory Acquisition Information

- 2.4.1 This volume provides the evidence to justify the legal powers sought by National Grid for compulsory acquisition as well as information on how the Proposed Project is to be funded.

Volume 4 contents

- 2.4.2 The following documents are contained within this volume:

- **4.1 Funding Statement** – explains how the Proposed Project, including any compulsory purchase acquisition, would be funded;
- **4.2 Statement of Reasons** – explains that there is a compelling case in the public interest which would justify National Grid’s exercise of powers of compulsory acquisition in order to acquire land and rights permanently and to use land temporarily to enable it to construct, operate and maintain the Proposed Project. This document is supplemented by:
 - **4.2.1 Appendix A Details of purpose for which compulsory acquisition and temporary possession powers are sought**
 - **4.2.2 Appendix B Schedule of negotiations with Land Interests** – which sets out the status of negotiations with land interests
 - **4.2.3 Appendix C Special Category Land Report** – addresses the issue of special category land in respect of the Proposed Project
- **4.3 Book of Reference** – contains land referencing information for land proposed to be used or acquired for the Proposed Project. It is structured in five parts in accordance with regulatory requirements:
 - **Part 1:** Categories 1 and 2 - contains the names and addresses for service of each person within Categories 1 and 2 as set out in Section 57 (categories for purposes of Section 56(2)(d)) of the Planning Act 2008 in respect of any land which it is proposed shall be subject to powers of compulsory acquisition, rights to use land, including the right to attach brackets or other equipment to buildings; or rights to carry out protective works to buildings
 - **Part 2:** Category 3: Section 10 Compulsory Purchase Act 1965 - contains the names and addresses for service of each person within Category 3 as set out in Section 57 of the Planning Act 2008
 - **Part 3:** Easements or other private rights proposed to be interfered with, suspended or extinguished - contains the names of all those entitled to enjoy easements or other private rights over land (including private rights of navigation over water) which it is proposed shall be extinguished, suspended or interfered with
 - **Part 4:** Crown Interests - specifies the owner of any Crown interest in the land which is proposed to be used for the purposes of the order for which application is being made
 - **Part 5:** Special Category Land - specifies land the acquisition of which is subject to special parliamentary procedure; which is “special category land” for the purposes of Sections 131 and 132 of the Planning Act 2008 and which is replacement land.

2.5 Volume 5: Reports and Statements

- 2.5.1 This volume details the pre-application consultation that National Grid has undertaken on the Proposed Project.

Volume 5 contents

- 2.5.2 The following document is contained within this volume:
- **5.1 Consultation Report.** Section 37(3)(c) of the Planning Act 2008 requires that applications for development consent are accompanied by a Consultation Report. The Consultation Report and its supporting appendices explain how National Grid has consulted on the Proposed Project, summarises the responses received and explains how National Grid has had regard to those responses. The Consultation Report explains how National Grid has complied with the consultation requirements set out in the Planning Act 2008, the APFP Regulations and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (EIA Regulations). The preparation of the Consultation Report has also taken into account statutory and non-statutory guidance including guidance set out in 'Planning Act 2008: guidance on the pre-application process' published by the Department of Communities and Local Government in March 2015 and, within reason, 'Planning Act 2008: pre-application stage for Nationally Significant Infrastructure Projects' published by the Department of Levelling Up, Housing and Communities in April 2024 (for the targeted consultation) and 'Nationally significant infrastructure projects: Advice on the consultation report' by the Planning Inspectorate in August 2024. Please see **Application Document 5.1 Consultation Report** for further details.

This report has been prepared with reference to ‘Advice note: nationally significant infrastructure projects: advice on Habitats Regulations Assessments’ by the Planning Inspectorate in September 2024 and in consultation with Natural England.
- **6.7 Statement of Statutory Nuisance** – sets out the matters in Section 79(1) of the Environmental Protection Act 1990 in respect to statutory nuisance, the potential of the Proposed Project to cause statutory nuisance and the measures that have been incorporated into the Proposed Project to mitigate any such potential nuisances. This document has been submitted in accordance with Regulation 5(2)(f) of the APFP Regulations;
- **6.8 Flood Risk Assessment** – sets out the assessment of the risk of flooding and identification of mitigation measures where appropriate. This assessment has been submitted in accordance with Regulation 5(2)(e) of the APFP Regulations;

- **7.4 Statement of Commonality** – provides a summary of the status of each Statement of Common Ground (SoCG), including those that have been submitted with the application and those that are in progress but not yet submitted with the application. This is a live document that will be updated during the course of the Examination and submitted at appropriate Examination deadlines. This document is accompanied by the following:
 - **7.4.1 to 7.4.15 Statements of Common Ground** – includes SoCGs outlining matters of agreement between National Grid and key stakeholders as well as where agreement has not been reached at the time of submitting the application;

- **7.5.5 Outline Offshore Overarching Written Scheme of Investigation** – provides a summary of the known and potential marine archaeological resource that may be impacted by the Proposed Project along with methodologies, procedures and individual mitigation measures recommended to protect these assets from significant environmental effects;
- **7.5.6.1 Outline Air Quality Management Plan – Suffolk** and **7.5.6.2 Outline Air Quality Management Plan – Kent** – detail how the Proposed Project will implement measures to control and limit emissions to the atmosphere;
