Thank you. Hello. Uh, before I start, I would just like to bring it to your attention that although the converter station site is referred to as the Saxmundham site, the B1 121 one that will be accessing the site runs through Bennell, and the Sealink converter station will sit wholly within Sternfeld. Lack of holistic long term planning is leading to a chaotic imposition of infrastructure in East Suffolk, with little or no regard for the disproportionate and unacceptable burden that this is imposing on the local population.

One twin reactor nuclear power station is enough for this region, but in addition to size will see. East Suffolk is also set to host two substations a connection hub, at least two converter stations, hundreds of new homes, an industrial retail unit, A1000 acre solar park, major water and road network upgrades. And it won't stop there because more and more projects, such as multiple battery storage units and a 600 megawatt solar park are already on the horizon.

So how on earth did we get here? Initially, the output from all four ScottishPower offshore wind farms was due to be transmitted to Bramford by via a single cable route, but a short sighted decision to reduce the cost of this cable route meant that only half of Scottish Power's electricity could be transmitted to Bramford after all. Thus, a whole new connection point had to be identified at which to connect. The other half of the electricity and National Grid's connection point at Friston was born.

It is this connection point that is at the heart of everything, because it can act like a gigantic socket into which any future electricity projects can be plugged. When summing up after the substation examinations at Friston, the examiners stated that the adverse impacts of Scottish Power's projects were so substantial that it was only just possible to mitigate for them, and that caution would have to be applied. Were further projects to be added at the connection point in the future. ceiling is being added now.

Caution needs to be applied now. Sealink will not produce a single amp of electricity, nor will it connect directly to any source of electricity generation. It will simply move electricity between East Suffolk and Kent. Like an extension cable taking excess electricity that has been brought into or generated here where it is not needed. Down to the southeast where it is. Well, Sealink has the capacity to lift the lid on electrical infrastructure development in East Suffolk, with a local supply set to become 20 times greater than demand, and 30% of the country's electricity due to be generated in or transmitted through this region.

Saxmundham wasn't even considered as a potential converter station site originally, and even though it is basically inaccessible and it is way too close to the local population, it suddenly popped up as the preferred option. Had it been scrutinized in the same way and at the same time as the other sites? And

had it already been established that construction of the Sizewell link road was guaranteed to proceed? Maybe a different site, such as the Leiston airfield, would have emerged as the preferred option instead at drop in events.

Stone field has previously been identified by National Grid as an industrial agricultural location, but this title is not justified. Yes, we do have duck rearing barns and a cold storage unit. And yes, despite the totally unsuitable roads, we do have HGTV's coming into Stone field to access these sites, but the agricultural scale of this is miles away from being industrial. Therefore, please don't be misled by our barns and the HGTV's traveling through our village.

Sternfeld is not an industrial site and remains a small rural agricultural village with considerable heritage, history and charming landscape appeal. Bernal stands to be significantly disrupted by construction of Sealink, as a result of the transport of super heavy loads over the railway bridge and increased traffic flows, especially of JVs on the B117 as it runs through the village, had the worst case scenario. Principles of the Rochdale envelope been applied to the problem of transporting loads weighing 300 tons over a railway bridge, only able to withstand loads of 46 tonnes, would the Bengal route still have emerged as the preferred option.

And since the word on the street is that line link may well adopt a northern approach to the converter station site, should the northern route that was excluded in favour of the burial route during the sealing statutory consultation be put back on the table now or better still, should the Saxmundham site be taken off the table altogether? Shoehorning such large scale infrastructure so close to established communities in this small area, served by its constrained rural road network, is already resulting in cumulative impacts that are affecting our day to day life.

At what point does cumulative impact become cumulative chaos? Proceeding with construction of Sealink when the area is under such duress threatens to push us over the edge. Please take great care to recognise when enough is enough, and acknowledge when the harm of development threatens to outweigh the benefit of the project. Thank you.

Thank you. Our local community is being overwhelmed by major infrastructure development. We're told that we have a voice and we can engage with the planning process, but very few people truly understand what's actually going on here. Clear, understandable information is distinctly lacking, and we are confronted with lengthy documents that are almost impossible to navigate. Even media coverage gets in a muddle.

And just this morning, for example, we were told on the BBC news that Sealink will be bringing wind power onshore at Aldeburgh. But of course, Sealink will be just that a sea link between Suffolk and Kent, and won't connect directly with the wind farms at all. How can we possibly get our voices heard or make informed decisions if we aren't informed in a meaningful, transparent way? You may not know this, but this region is currently undergoing radical local government reorganisation and devolution.

It would be enough to be addressing this massive issue on its own, but dealing with it alongside multiple major infrastructure projects is leading to an untenable workload at all levels of local government. People are spread too thinly and compromise has become the name of the game. We are all shocked at the increasingly profound impact that construction of Sizewell C is already having on our region, and since the nuclear power station site itself hasn't even been accessed yet.

This is just the tip of the iceberg. What will East Suffolk look like when there are 10,000 workers on site at Sizewell, and when construction of all the other projects is added on top of that as well? This question really matters to us, but we fear that we are being written off as NIMBYs simply for asking it And more, and with and more and more infrastructure will continue to be crammed into this little corner of East Suffolk until the cumulative impacts of so much concurrent construction in one small area becomes overwhelming.

Worrying about this is significantly impacting our mental health and well-being as well as our physical health. And we exist with a constant background level of stress and anxiety. Please listen to our local knowledge about what it's like to be living in what already feels a bit like a construction site, and weigh up whether the considerable socio economic and environmental costs of building sealing in this unique, richly biodiverse, agriculturally productive tourist destination is actually worth it, especially when a holistic, long term, strategic alternative solution to transmitting offshore wind power is available and is already being employed by our North Sea neighbours.

Thank you very much, sir. I am Richard Cooper, chair of Marshall Parish Council.

Malmesbury Parish Council objects to the application in its current form. We support all reasonable efforts to reach the goal of achieving net zero carbon emissions, but we are concerned that the application has been submitted prematurely and without full assessment of other options for the transmission of power generated by East Anglia's offshore wind farms and the onshore generation from Sizewell C.

Parish Council is very concerned by the adverse cumulative impact of the applicant's proposals, alongside the existing impacts of Sizewell C and ScottishPower renewables. Friston projects. Miles is severed by the A12 and whilst we are grateful for the mitigation committed to buy Sizewell C and Scottish Power, it will do nothing to alleviate the increased volume of traffic passing through over 50 properties in Milford and Little Glenarm, a 20m or less from the A12 carriageway, and they already experience noise and vibration as a result of existing traffic.

This has an impact on residents quality of life and affects mental health.

00:27:02:07 - 00:27:29:12

This council does not subscribe to the apparent argument of the applicant that because its traffic is over a baseline of already increased traffic, particularly of HGVs being generated by sizeable sea and Scottish power, the effect of its own traffic will be negligible or minor. That will not be the perception of the A12 residents in this village

00:27:31:02 - 00:28:07:28

as a result of the applicant Sealink proposal, together with other energy projects. Oxford Parish Council believes that this part of Suffolk is paying a very high price in order to deliver benefits which apply across the whole country. We do not believe that the benefits to this area are balanced by the negative impacts. One topic that appears to attract little discussion is the vulnerability to attack of concentrating around 30% of the country's energy production on the east Suffolk coast.

We are surely laying ourselves open to hostile attack. An East Suffolk residence could be part of the collateral damage in the in the event of any such attack.

00:28:20:15 - 00:28:45:07

Turning now to traffic based survey, traffic data was captured by the applicant during January and February 2024. These are not recognised as neutral months, and the data is thought to show traffic flows below those that would be expected in neutral months. There is therefore a built in underestimate of current traffic in the area.

00:28:46:25 - 00:29:22:00

This or this part of Suffolk. This part of Suffolk experiences significant holiday peaks in traffic flows during July and August. There is no recognition by the applicant of the effect of seasonality, but the combined effects of holiday traffic and the applicant's traffic, plus that from other projects, will have a

material impact on highway capacity. In Milford, we are particularly concerned about three junctions in the village that give access to the A12.

Residents already experienced difficulty in right turning from these junctions, despite the future mitigation being provided by Sizeable Sea and ScottishPower renewables. The volume of traffic, even within the new 30 mile an hour limit, will make it even more difficult for vehicles to join traffic on the opposite carriageway.

00:29:46:10 - 00:30:16:18

Turning to mitigation miles, Stafford Parish Council does not consider that the applicant has done enough to mitigate the adverse adverse aspects of this scheme. In the event that consent is granted and the scheme goes ahead. This council request that the applicant be put under an obligation to provide the following mitigation contributions toward improvements of the A12 footpath between Milford Road, Milford and sizeable sea.

Southern Park and Ride funding of road markings and other traffic calming measures in areas most impacted by the applicant's project. Funding for a programme of traffic monitoring already in place and currently being funded partly by size will see.

Thank you. Funding of signage on roads most vulnerable to rat running. Elimination of Sunday and bank holiday working funding to help town and parish councils respond to inset discos and examinations. And finally, this council has worked effectively and collaboratively with sizeable sea, and has participated in community discussions designed to deliver agreed mitigation and adapt certain aspects of their project to better meet local communities needs.

If if permission is granted for this DCO, we would ask that the applicant is required to engage in an all energy projects forum to ensure that all projects coordinate their developments where they overlap, for example on transport. Such a forum would help to dispel the public perception that.

Yes, I'm Geraldine Barker from Saxmundham town Council. Saxmundham Town Council stands by our comprehensive, relevant representation. But today we're looking at issues that we consider unresolved and we're not particularly happy about. And that's construction noise, vibration, working hours and traffic implications of proposed road diversions starting with noise. We note that the applicant has now included the addresses of properties deemed to be hotspots.

However, with the exception of Wood Farm in Saxmundham, there are no other town properties included on this list. Therefore, we still have issues with this. I'll just highlight these. Um, Herts Hertz Hall is not considered a hotspot and we question this hurts hold. At one point, it's only 250m away from the proposed access road and new bridge, and will undoubtedly suffer noise and vibration.

And it's even worse because it's in a rural location. So the background noise is obviously less, and they will suffer from increased sound, both levels doing both construction and the use of the road. Um, the next one is Mana Gardens. This is a development from that is only 250m approximately away from the proposed compounds S0 two, and the residence here will be subjected to sustained levels of noise, dust and light pollution through the construction period.

The applicant's own document Coordination Document 7.10 states that B4, which is now S0 two, presents a challenge for mitigating noise and vibration and highlights that there is acoustic sensitivity to Manor Gardens. They are not considered a hotspot. Uh. Then we go on to extended working hours. Whilst the applicant has considered reducing weekend working the alternative Saturday Sunday alternative weekends and other combinations.

This was designed to reduce the average noise level. We still consider that there should be no Sunday working as per other nationally significant infrastructure projects, i.e. Sizewell and Scottish Power Renewables. It is important at this stage to also note regarding Sunday working that it is not those in

the very close proximity of the project that will be affected, but also those in many parts of Saxmundham.

Those living on the High Street, South Entrance, Chantry Road, Wrentham Road, Churchill Church Road, North entrance. They will suffer because of the traffic and I'm talking about workers vehicles like goods, vehicles that will be going to site early in the Sunday morning. I personally live in that centre of Saxmundham, and I can tell you that traffic starts at five in the morning with people heading towards sizeable sea, and it is only on Sunday where it is quiet until about 10:00 when the supermarkets Markets open.

And this is also going to be even worse with the extended working hours. You know, we would expect to see eight, 2 or 5. But no, it's far more than that. And the last thing I'm going to talk about is the road diversion which is outside the noise. But there has been no diversionary route to put in the DCO paperwork, except for something I found on a right of way map.

And do they take any account whatsoever to the physical and mental toil? All of this is taking on us, the people who live here.

Hollow words. I wished they asked the inspectors to listen.

I'm particularly concerned about two areas of the plans and the effect it will have on our mental and physical health. Firstly, is the area where the Sealink route crosses the disused railway line between Thorpe Ness and Aldeburgh. This is part of the King Charles the Third Coastal Path, a very popular circular route between the two places.

The construction will destroy ageing trees and wildflower habitats, especially in the field between the railway line and the B11 22 Leiston Road. It is an important habitat, two for deer, marsh harriers, hobbies, nightingales, winter geese and spoonbills, to name a few on the nearby nature reserve. Noise levels, light levels and construction work will disrupt flight paths, food sources and habitat for breeding.

The permanent access route will damage the countryside. No one will want to go birdwatching or walking there. Be their local residents or visitors. Secondly, I have concerns about the area around Chapel Barn Farm and the Shandling's Path, a long distance path from Lowestoft to Ipswich based on ancient sheep drovers routes along the unique habitat known as the sand lings, which around East Bridge has already been decimated by Sizewell construction.

And I'm concerned that the cumulative effects of all these different building projects, which we are threatened with, are going to severely threaten my enjoyment, my, my, the well-being I derive from the countryside around me.

Good evening. I oppose ceiling. It's the wrong solution in the wrong place. It will cause irreversible damage to protected habitat both immediately and for generations to come. Ceiling is being advanced in the absence of any coherent national offshore transmission strategy. It proposes vast onshore infrastructure, converter stations, substations, cable corridors through some of the most sensitive landscapes in Suffolk. While options for offshore coordination, the favoured approach of our European neighbours remain unexplored or sidelined.

This is not grid modernisation, it's grid fragmentation. It risks locking us into a piecemeal approach that ignores the efficiencies and environmental benefits of an integrated offshore grid. The proposed development cuts through the Suffolk Coast and Heaths AoNB, a legally protected landscape of national importance. It threatens rare habitats including ancient woodland, marshland and coastal ecosystems that support species found nowhere else. It drives a coach and horses through the Treasury supported.

2021 Dasgupta Review and the Environment Act of the same year. The construction phase alone would bring years of disruption, noise, light, traffic and ecological stress, not to mention the catastrophic long term effect of the area's vital tourist industry. And our task is to protect and enhance the town's environment, which is something of a challenge with all these energy projects around. Oba has a long history. Uh, there was shipbuilding. There was.

And there's still a bit of fishing. Uh, more recently, it's become a big center for the arts. And, uh, Benjamin Britten lived here with Peter Piers for most of their adult lives and founded a festival, annual festival of music of the arts, which is still going very strong. Aldeburgh also hosts annual festivals for literature, for poetry, documentary film, um, and food and drink, and it also promotes the popular triathlon, a carnival, uh Boxing Day swim and hosts of community events.

All these events, in addition to the traditional appeal of the beach and the serene coastal and estuary environment, uh, attract visitors from far and wide and are the foundations of our economy. Thank you. Good evening. I'm Andrew Turner, chair of Westminster and parish council. Weston is a village five miles north of Bristol and Saxmundham, and a mile inland from the coast. Weston Parish Council supports the detailed representations submitted by the parish and town councils, which will bear the brunt of the construction, the traffic on their Bureau's environmental destruction of the land surrounding their communities, and the resultant physical infrastructure which will loom over their horizons. Like those parishes, Weston is suffering the effects of size or sea construction. Notably, already a 45% increase in peak time traffic through our village.

00:57:35:24 - 00:58:13:13

The extraordinary change in our landscape is that diggers and chainsaws destroy the land of vegetation. The extra time we have to factor into journeys because of endless road closures and seeing we need the speed limits on the A12. I could go on. The Suffolk Heritage Coast. Natural environment is already being reshaped for the worst, so our instinctive reaction to the ceiling project is one of despair. The where due to suffer even more traffic, construction, inconvenience and stress. And so we ask whether it's necessary. Sealing will in effect be an extension cable from Suffolk to Kent. But what power is it planned to transmit? We understand that Scottish power wind farms, electricity can be transmitted over the existing pylon network.

That plan outlines themes for Suffolk to reach net zero transport emissions by 2040. Three of the four themes are strengthening Suffolk's economy, protecting and enhancing Suffolk's environment, and promoting and supporting the health and wellbeing of all people in Suffolk.

From from parish councils perspective. This project will do none of these. Rather it will do the complete opposite. We'll see links strengthen Suffolk's economy. Know the core components of the

Suffolk coast economy is tourism. The size will see construction is already expected to reduce significantly. Suffolk tourism industry, so much of which is centred here on this section of the coast. The seeding project will simply compound the problem. If tourists can find accommodation which is not being converted to walk accommodation, they are unlikely to return after experiencing the traffic.

The denied access of public rights of way and the construction of vistas. Conversely, Sealink will generate few local jobs during construction and, by its own admission, almost none for its operation. Will Sealink protect and enhance the environment? No. It will turn a usable shingle beach marshlands into a construction zone. It will require the destruction of vegetation to change the cables that will result in the 16 acre, 26 metre high building in a field between a small village and a market town. The applicant has assessed flood risks, but flood risks have changed in recent years and will likely worsen with time.

This is environmental destruction, not protection. And when you consider that line link which creates the need for sea link or follow and required drinks, you have many more miles and require another huge building next to sea links. It's simply extraordinary that this can be presented as anything other than environmental devastation. Mitigation is proposed, but it will be decades before these buildings are shielded by trees and saved decades during which this landscape will be an industrial, will be industrial and not rural. We'll see, link, promote and support health and well-being. No. See link and then lion link and then whatever follows will only exacerbate the negative health and wellbeing impacts of our residents.

Sadly, we know what to expect. Size will see what so accustomed us to the sudden disappearance of hedgerows and mature trees, and appearance of bare fields and sandbanks. And the applicant proposes seven day working weeks. The health impacts of these changes possibly cannot be measured, but they will be very, very real. The size of the demonstration outside the Maltings today is a clear indication of residents concern.

And what about the transport network itself? Gloucester County Council aims to make net zero by 2040. The additional 346 HGV journeys each day on the local roads are going to challenge that objective and these are, of course, in addition to the seismicity and Scottish power traffic. Um, and then add the traffic caused by line link and the other energy projects which have been drawn there by the Friston substation and facilitated by senior minute left. And what about road safety and safety? Generally, emergency service vehicles be slow to respond to emergencies in our village and in the case of ambulances, then slower to get back to the hospitals.

It may generate economic activity of 15 plus year period, but it will do so at the expense of the tourist sector, which is the mainstay of the local economy. And it will move labour from providing services to the local community to working for short term and infrastructure projects, leaving the community short of skills and services it needs.
