Oh I see. Good evening. Panel. My name is Gerald Pryor. I'm an ordinary concerned person. I'm retired, and I love nature. I'm a seascape and landscape painter and a birdwatcher, so I spend most of my time outdoors. I'm very fortunate to have a home which overlooks Pequot Bay, and I regularly visit the Pebble Bay Nature Reserve and the former hover port, which has been left to return to nature over the last 40 or so years and has turned a former environmental disaster and commercial area into a natural wild space with access over degraded tarmac and concrete all the way to the water's edge.

So it's become an important resource for those people with wheels or wheelchairs. It's National Grid's intent to take over this site and discontinue its use by the general public to bring an off shore cable onto the land, and to tunnel to a massive converter station over ten storeys high. They propose to build in the middle of the marshes, which will become an eyesore in itself and is out of character with the area a wild marsh. Up until now, this project has not been designed to give us cheaper electricity, but it's an expansion in network capacity.

In my opinion, this project is not really needed, but is being foisted upon us so they can make more profit. Currently, the UK has the most expensive electricity in Europe, but this company regularly posts many millions of pounds profit. This project will allow them to make even more. Once distributed, sorry, once disturbed and developed, our natural environment will be changed in ways that cannot be foreseen. And even if remedial measures are enforced, to reinstate what has been dug up and tunnelled through nature will struggle to return to its former glorious state.

Britain is one of the most nature depleted countries in Europe, and Peg will be one of the least disturbed areas in Kent. There are many species of endangered and rare birds that live in the Pequot Bay area, as well as seals that use the mudflats and wild ponies that live in the nature reserve. If this company were to invest into being more innovative and careful in their approach. They could come up with a solution that would not destroy our nature and allow the increased capacity of offshore wind to reach the businesses and industries that need it most.

I think mostly in the London area are not in rural Kent. There's an alternative site in the Isle of Grain which has not been fully explored and consulted. As the Pequot Bay site is the cheapest option, the best for their bottom line and is the priority and favorite, allowing an easier route to the profits that can be made by selling electricity to a Europe as it is. They are willing to ride roughshod over the protective measures seemingly already in place, and cause massive harm to the nature that's left and struggling to survive here.

I urge the panel to deny permission for this development, and for them to be compelled to explore further the use of the Isle of Grain to achieve their expansion.

We need a permanent armistice where the need for energy, even green energy in this case, meets the need for environmental protection. Many speakers will be much better qualified than I am, and have expertise in some of the core areas of concern in this application, such as flooding and drainage of the marshes.

I speak as a long standing resident and present my personal concerns as someone who has always tried to look after the local Environment. I know that planning policy does not specifically require consideration of the cumulative effect of various developments in a locality, but it is this impact which is key. Thanet has intensive residential and industrial building programs underway, many of which are on best and most versatile land. These developments are in an area which already has poor access to green space per person and already has very limited tree cover, less than 20%, and wooded areas.

Minster Marshes and Penguin Bay are two of the only remaining areas which provide free access to natural, largely undisturbed and unmanaged environments where the sterile and sanitised amelioration programmes of new building developments have not reached. They are unique areas, as is recognised by the designation of protected sites. Such protection should not be asked to give way to other pressures and convenience. We need more woodland, hedgerows and natural habitats, not less.

Both spaces are vital to the well-being of flora and fauna, but also to human life. Its proximity to the sea provides added thinking.

One minute remaining. Thank you.

He's noted a variety of rare birds, several of which are endangered, and the disturbance of construction work and traffic movement create would be a huge problem to their continued existence. Salt marshes shrinking generally and human disturbance is a large part of that. Kent Wildlife Trust talks of 200 threatened and endangered species in Kent, 80% of water in poor condition. But these two sites make a connected network a living system that sustains us all. And that is why Pequot Bay has been awarded a green flag.

They are also community assets and amenities where we can be free to roam and explore, but which also become meeting spaces for walkers and groups. The damage of the building. Its construction phase would be massive in both environments, restrictive of rights of way, and would impact on local business. The long term impact of light, noise and air pollution, loss of habitat, and the visual blight of Europe's largest converter and its pylons on the flat landscape of the marshes. Unacceptable. I fear that where this application to be accepted, we would be creating an albatross around our necks.

Hello, guys. I'm a local teacher and writer. First of all, I wanted to state that the UK has nearly 8000 miles of coastline. It's not infinite, but for a small country, that's a vast amount. It's almost double that of India. Can itself has hundreds of miles of coastline, which is one of the reasons why I find it perverse that this this site is being located here. I'm not objecting to the project per se. We need clean electricity And there is much that is knowable about Sealink. Why then in the project otherwise so well thought out? Have you chosen to locate this plant in such a special location? And why are you choosing to ruin not just one, but two areas that can never, ever be replaced? I'm going to repeat.

I know we were told not to repeat things, but I feel like it needs to be repeated. Kent has hundreds and hundreds of miles of coastline. Why is this coming here? The creation of green energy is welcome in Kent. The destruction of pristine marshland environment is distinctly unwelcome. Why on earth would you choose to cite 22 football pitch sizes of industry here, of all places. Now, I grew up in Ramsgate. My father worked on the airport for 7 or 8 years back when I was a kid. As much as people romanticize the hover port these days. The area was a complete mess.

It was a dystopian, barren wasteland. When the hovercraft returned home, you could hear it from Ramsgate town centre. The sound was deafening, even from miles and miles away. No children ever played at that port. Not one single owl ever flew there. Well, today the difference could not be starker. 40 years of painstaking regeneration has turned that port into a utopia for both children and for wildlife. And you're going to put electric cables for it. You're going to. You're going to electrify the whole area. As for Minster, I teach at the foot of the Minster Marshes.

I teach at Great Oaks Small School. My school, like the rest of the surrounding area, benefits from the huge natural dividend that the marshland pays out. Harriers, Hawks. Marsh frogs. Barn owls. My students have seen and heard them all. And you're going to electrify that as well. And not only that, but build a 28 meter tall tower on top of it. Now we teach our students about the Norman Towers that used to instill fear into this actual into the same region. We rejoice that those times are over. But are they over? Because it appears that ceiling is bringing them back.

Now, I mentioned earlier on that my children, my students see and hear wildlife. Well, in fact, they hear everything. For now, though, there is something else we teach all of our children. And that is not to vandalize. Well, clearly that's the lesson that ceiling needs to abide by as well. I'm going to I know we were told at the start not to repeat, but I'm going to repeat that fact again. We have no shortage of coastline, but we do have only one peg. Well Bay and only one Minster marshes. Build this project somewhere more sensible.

Hey. Thank you. Um, can I now go to Kerry Sabin Dawson?

My name is Kerry Sabin Dawson, and I'm extremely concerned about National Grid proposal for Sealink. I'm very much in favour of green energy, but paying with an extremely diverse habitat is not green. As a member of the local.

Just one second, the the timer just hasn't worked there. Could we reach at the time, please? Three minutes. There we go. Thank you. There we go.

You can just carry on from there. That's fine. You get six seconds.

00:26:27:12 - 00:26:59:02

As a member of the local RSPB group. I'm extremely concerned about the 36 IUCN red listed species, which either breed in or regularly use this area. Turtle doves, nightingales, yellow hammers, golden plovers, marsh harriers, European eels, water bowls to name just a few. This area is vital for migrating birds, for whom this is often a life saver. Stop off losing this food source and resting area, as well as having to navigate and increase in pylons at varying heights, will be a big loss for these birds.

We all know that light pollution plays a significant part in the decrease of our wildlife, particularly impacting migrating birds. What would be done to limit this impact? Moreover, increasing noise pollution in an already industrialised area would negatively impact birds such as nightingales already struggling to find a mate with the increasing noise. Please consider the cumulative impact of placing this proposed converter station adjacent to a site which has already been negatively impacted by battery storage.

Sewage works and solar farms in the immediate vicinity. One small field for golden plovers stuck between all of these industrial sites cannot be considered appropriate mitigation. Also, how will the sewage works expand to serve the significantly increased housing in this area? If National Grid uses this site, there will be no room for any expansion. A huge the huge increase of hard surface proposed for this converter station was significantly increased the flood risk in an area which is already projected to be underwater by 2030.

As marshland, it is of course, regularly flooded the runoff from these hard surfaces, which will be polluted from contaminated hard core rubble as as it flows directly into the Stour River. And our marine conservation area in Pago Bay will be devastating. I would like to know what the carbon footprint for this project is. I have not seen any estimated carbon impact in the hundreds of documents that have been sent by National Grid, although I must confess that I've not read every word. Furthermore, please consider the impact of a huge and unattractive converter station visible for many surrounding miles on this holiday area.

Tourism is a vital employer in this deprived area area. Moreover, the significant loss of valuable farmland must be considered with an increasing population and many fields already covered in housing. The Garden of England will be closed forever. I therefore implore the examining authority to request that National Grid go back to their initial list of potential sites, and find where there would be a smaller, negative impact on our natural world. On behalf of all of the wildlife that will be slaughtered or made homeless by this proposal, I beg you to rethink Sealink.

Okay? Can you hear me? Yeah. I'm Pippa Thorne, a farmer within the order limits to avoid duplicating the eloquent concerns on wildlife and strategy, I'm focusing on the marshes and our farms. The converter station is proposed to sit on a former sea channel, the once in which silted up in the Roman times. As you can imagine, the soil is soft alluvial clay. It has a one meter crust on the top and is often described as blancmange underneath. It has high risk of groundwater flooding and sits between two tidal rivers.

With extreme weather events, heavy downpours and droughts. The soil shrinks and swells, causing extreme volume shifts. It reveals deep cracks in drought and sticky and sinking on the surface when it's wet. This destabilizes all construction. An example is the now destroyed Richborough Power Station, built by respected engineers in the 60s on Fermor. Marsh to the west, was raised on 290,000 tons of colliery shale and reinforced with concrete piles.

It subsided just six years later. The dual carriageway you may have taken here, the A2 99, now undulates like a roller coaster. that's also built on clay soil. Our farmland is equally vulnerable. Planning documents reference soil guidelines and risk assessments, but they're irrelevant to Mars soil. It requires a unique treatment and a clay soil specialist. Current national grid.

Ground surveys with vehicles traveling in wet conditions have triggered trap collapses and flooding that run off now into the fields and run off into the Minster stream. This is risking aquatic life and contamination of our reservoirs. We have not had a risk assessment on our reservoirs, and it supports

800 tons of fresh produce annually. On the march we use minimum tillage, i.e. we don't plow those fields. This is to protect the soil.

It took ten years for the soil to consolidate and revive it. It was a slow process and we had a yield loss along the way. It took five years to get soil repaired with National Grid, and we still have ongoing issues.

The sites are hugely important to a variety of wildlife, including a thriving seal colony and migrating birds, including over 30 red listed birds. The proposed

development means a loss of one of the few remaining green areas in Thanet, which have been depleted by major housing developments and the loss of huge amounts of hedgerow and marginal habitats where these have been built over farmland.

There will be no access to the Penguin Bay Area and Coastal Path during four years of construction, which will also impact on local businesses and the wellbeing of residents. With all the infrastructure being planned, the Weatherley sewage plant will be unable to expand to cope with the future developments. Commuting by bicycle is a beautiful way to bookend my day to spend time outside and in nature and also see and also get some exercise.

If the applicant is successful, there is no doubt that this peaceful cycle route will be impacted. The project is predicted to take a minimum of four years to build.

For birds migrating to and from Africa and Europe, the area cannot be considered in isolation as it forms part of a much larger system of interconnected marshes with biodiverse wildlife habitat, not only supporting the migrating birds such as honey buzzards, ospreys and turtle doves, but others threatened species such as eels, waterfalls and beavers.

The water levels of all these marshes are controlled by the main drainage channel called the Minster Stream, which flows past the proposed site to a tidal flap at the Kingfisher Sluice. This fresh water is used for irrigation by all the agricultural businesses spread across the marshes. Any pollution caused by National Grid, especially during the proposed pile driving, which will disturb historic sedimentary layers of salt, will be catastrophic to all the businesses and the local environment.

Okay. Yes, my name is Steve Gillette. Um, I'm an individual. I've known Peggy Bay since, uh, as a child. I naturally support all the cogently presented reasons against this undesirable and ill conceived plan. But my reason for coming today is to draw the planning inspectors to its attention to the letter written by the Secretary of State, Antony Greenwood, in 1967, at which he valued the national value of Peggy Bay and stated that the hover port could only be built there because of its extreme importance to technological development.
