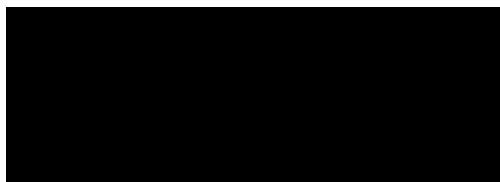

East Anglia Three Limited’s Deadline 1 Written Representation**

Dear Sir/Madam

1. Written Representation

1. We refer to the above Project and confirm we are instructed by East Anglia THREE Limited.
2. East Anglia THREE Limited was granted development consent order (“**DCO**”) on 7 August 2017 for the East Anglia THREE Offshore Wind Farm (“**EA3**”).
3. EA3 is an offshore wind farm located approximately 69km from the Suffolk coast with an offshore export cable route making landfall near Bawdsey and an onshore cable route to transport energy to a converter station in Bramford. Construction works for EA3 have commenced, including for the installation of export cables. The export cable route is shown in figure 1 below.
4. The cable route for the Project, as shown in the Work Plans – Offshore (APP-023) and Indicative General Arrangements Plans – Offshore (APP-040), will cross EA3’s export cables. As a result, protective provisions are required for the benefit of EA3 within any DCO granted in respect of the Project. East Anglia THREE Limited anticipates this matter can be resolved through discussions with National Grid Electricity plc, as the applicant for the Project. However, until this matter is resolved, East Anglia THREE Limited wishes to participate in the examination of the Project, to ensure its interests are protected.
