OPEN FLOOR HEARING STATEMENT ON 11TH NOVEMBER 2025

I wish I could make you care as much about Thanet's wildlife, Nature, Residents, and future generations as I do, because if you did, you would never allow 3 of our beautiful, diverse and vital wetlands to be damaged and destroyed forever in the name of so called Green Energy and the careless and reckless rush for Net Zero!

My family moved to Thanet when I was 5, and this has been a beautiful place to grow up in. Thanet has always attracted holidaymakers galore, coming here for its lovely beaches and characterful towns, separated by fields of crops.

Pegwell Bay has always been a special place where many migrating birds could find rest and shelter, moving to Minster Marshes when the tide was high.

Recently, I have witnessed Thanet's fields being ripped up and covered in concrete and brick as hundreds upon hundreds of

houses go up, causing immense chaos on our crowded roads and services, and pushing out the wildlife that lived there! There is always a better way to Green energy and Net Zero. Destroying Thanet's few last remaining truly wild and diverse wildlife sanctuaries is horrific and should never have even been considered.

Also, very worryingly if our country is drawn into war, a huge Converter station on the marshes would be a desirable and easy target! If it were bombed, it would cause massive power cuts and chaos.
