# 1. Details of Purpose for Which Compulsory Acquisition and Temporary Possession Powers are Sought

### 1.1 Land acquisition powers sought

The specific purposes for which each plot of land subject to compulsory acquisition or temporary possession powers is required are set out in the tables in this appendix. The first column of each table identifies the plot number (as shown on the Land Plan and used in the Book of Reference). Plots are grouped in each row to the extent that they are located on the same Land Plan Sheet. Furthermore, they are grouped into tables depending on the Class of Rights (purpose) in the fourth column.
