Application by National Grid Electricity Transmission (National Grid) for an Order Granting Development Consent for the Sea Link Project (Planning Inspectorate Reference EN020026)

#### **Proposed Change to Development Consent Order**

- 1.1.1 This cover letter has been prepared by National Grid to accompany the Change Request Application (Change Request) for the following 5 proposed changes to the DCO Application reference EN020026.
  - Change 1 Change to access at the former Hoverport, Pegwell Bay, Kent
  - Change 2 Change to limits of deviation for Friston (Kiln Lane) substation, Suffolk
  - Change 3 Change to the Order Limits east of Friston to provide flexibility in relation to heritage feature, Suffolk
  - Change 4 Benhall Railway Bridge, Suffolk
  - Change 5 Increase in area for maintenance of a new hedge to south of B1119

#### **Prior Notification of the Proposed Changes**

1.1.2 The Notification of National Grid's Intention to Submit a Request for Proposed Changes to the DCO Application was sent to the Examining Authority (ExA) on 16

- September 2025 **[AS-138]** (the Notification Letter) and provided the details and background to the request for the proposed changes.
- 1.1.3 The ExA's Rule 9 Letter **[PD-011]** dated 25 September 2025 acknowledged National Grid's intention to submit a request for changes to the application and confirmed that "The ExA is therefore satisfied that the proposed changes, whether considered individually or taken together, would not be so substantial as to amount to a materially different project from that which was applied for".
- 1.1.4 In the Rule 9 letter **[PD-011]** the ExA advised National Grid on key points to be considered in the Change Request.

### **Guidance Used to Prepare the Change Request**

1.1.5 National Grid has prepared the Change Request with due regard to Nationally Significant Infrastructure Projects: Changes to an application after it has been accepted for examination - GOV.UK (the Guidance) and additional requirements identified in the ExA's Rule 9 letter [PD-011].

## Significance of Environmental Effects of the Proposed Changes

1.1.6 A Change Request: Addendum to Volume 6 Environmental Statement as shown in **Application Document 9.76.5 New Document** submitted with the Change Request concluded no new or different significant environmental effects compared to those reported in the Environmental Statement.

### **Targeted Consultation**

- 1.1.7 National Grid voluntarily carried out consultation on the proposed changes and a non-statutory consultation exercise was carried out over a period of 31 days commencing on 7 October 2025 and closing at 23:59 on 7 November 2025.
- 1.1.8 Given the limited proposed changes to the Proposed Project, targeted engagement was completed on the proposed changes. The targeted consultation included local authorities, prescribed consultees, persons with an interest in the land affected by the proposed changes (Section 42(1) (a) to (d) parties and a select group of households.
- 1.1.9 The Application has provided a Consultation Report (see **Application 9.76.3 New Document submitted with the Change Request)** which confirms who has been consulted and how they have been consulted in relation to the proposed changes, and how National Grid has considered the content in the responses received.

- 1.1.10 Change 3 and 4 have been amended since issue of the Notification letter [AS-138] to the ExA in response to feedback from , Historic England, the County Archaeologist, East Suffolk Council, landowners and local communities. These amendments have also been informed by survey results. The amended change descriptions are included in the change summary report as shown in Application Document 9.76.2 submitted with the Change Request.
- 1.1.11 National Grid considers these changes to be relatively minor in nature, not altering the substance of the Scheme as applied for in March 2025. This aligns with the ExA's Rule 9 letter [PD-011] that, "the proposed changes, whether considered individually or taken together, would not be so substantial as to amount to a materially different project from that which was applied for".

### **Compulsory Acquisition**

- 1.1.12 National Grid confirms that additional compulsory acquisition powers are sought (in relation to land outside of the current Order Limits for proposed changes 1, 3 and 5. Regulations 5 to 19 of the CA Regulations are therefore engaged. Due to these changes, it has been necessary to make some changes to existing plots, both where plots required splitting and hence re-numbering, but also where the class of right sought for that existing plot has had to change. This is reflected in the submitted documents.
- 1.1.13 National Grid has consulted with all parties with an interest in the additional land to be included in the Order Limits. The majority of interested parties had previously been engaged with during previous consultation on the Proposed Project as they are affected persons in relation to land already included in the current Order Limits.
- 1.1.14 National Grid will give notice and publicise the proposed changes in accordance with the CA Regulations. National Grid has submitted with this Change Request the required documents as prescribed by regulation 5 of the CA Regulations.
- 1.1.15 In line with the Guidance the Change Request Report see Application Document 9.76.2 provides a detailed description of how National Grid considers the procedures in regulations 6-19 of the CA Regulations can be accommodated within the examination timetable as set by the ExA in their Rule 8 letter [PD-013] dated 10 November 2025.
- 1.1.16 The Guidance on Changes to Development Consent Orders and associated Regulation 5 of the Compulsory Acquisition Regulations 2010, sets out what must be included in a change application in respect of additional compulsory acquisition powers.

- a supplement to the Book of Reference (see Application Document 4.3 (C) (version 2, change request) Supplementary Book of Reference);
- a land plan identifying the additional land, or the land affected by the proposed provision of additional compulsory acquisition (clean and track changed version from the latest version of the land plans submitted to the examination) (see Application Document 2.3 (C) (version 2, change request) Land Plans Part 1 of 2 and Part 2 of 2)
- a statement of reasons setting out why the additional land is required (see Application Document 4.2 (E) (version 2, change request) Statement of Reasons); and
- a statement indicating how it is proposed to fund acquisition of the additional land (a funding statement) (see Application Document 4.1 (A) (version 2, change request) Funding Statement submitted with this Change Request).
- 1.1.17 In the case of the Sea Link Change Request, a full suite of land plans is submitted and only the sheets relevant to the proposed changes have been updated. In line with the Compulsory Acquisition Regulations a supplement to the Book of Reference has been submitted. This will then be integrated into a revised Book of Reference if the changes are accepted. The Land Rights Tracker has also been updated in relation to the updated land plots.
- 1.1.18 In addition, the Funding Statement (see Application Document 4.1 (A) (version 2, change request) Funding Statement) and Statement of Reasons (see Application Document 4.2 (E) (version 2, change request) Statement of Reasons), with appendices have all been updated to reflect the proposed changes.
- 1.1.19 The Change Request Report (see Application Document 9.76.3 (A) (version 2, change request) Change Request Report), and supplemental documents describe the changes sought to the project clearly along with the rationale for requesting them. To ensure clarity until the supplemental documents can be merged on acceptance, all change request supporting documents are prefixed with 'Version 2 change request' title.
