The following constitutes Natural England's formal statutory response for Examination Deadline 2.

1. Natural England's Deadline 2 Submissions

An update of Natural England's position regarding documents relevant to our remit is provided in Annex 1, Annex 2 and Annex 3, including anticipated timing of responses. Natural England is also submitting the following detailed responses:

2. Risk & Issues Log at Deadline 2

Please note that owing to the volume of documents received at Deadline 1 and Deadline 1A, we have not had sufficient time to review the majority of the documents and provide the necessary considered response for interrelated issues. However, Natural England has updated our Risk & Issues log to include comments submitted in Appendix A1 at Deadline 1. However, we will aim to provide an update to the Risk & Issues Log at Deadline 3, following review of the Applicant's Deadline 1 and Deadline 1A submissions.

To aid clarity and resolution of issues, Natural England has made amendments to comments

H3, H4 and H11 in our Risks and Issues log.

3. Natural England's Appendix A2

Please note that this appendix makes reference to information contained in the Applicant's REP1-120 with regard to acid grassland. Please note that whilst Natural England has not yet completed a full review of REP1-120 (which we will provide at Deadline 3), we consider that issues detailed in Appendix A2, including information contained in REP1-120 needed to be brought to the Examining Authority's attention at the earliest opportunity. We trust that this information is helpful and we continue to work closely with the Applicant on these matters.

4. Natural England's Comments Relating to the Applicant's Proposed Changes and Revised Examination Timetable

Natural England notes the proposed changes submitted by the Applicant at Deadline 1A and the implications for the examination timetable as noted by the Examining Authority on 5th December 2025. We note the addition of Deadlines 3A, 4A and 4B.

We also note the publication of the Report on the Implications for European Sites (RIES) is expected by 18th March 2026 and the deadline for comments has now been amended from 29th April (Deadline 7) to 13th April (Deadline 6). This period also coincides with the Easter public holidays, as a result our time to review and provide a response will be further reduced. Natural England will make best endeavours to provide a response in this timeframe.

We note that the publishing of ExQ3 may now be W/C 23rd or 30th March with the response due by 13th April. Noting that this also suffers an overlap with the Easter public holidays and therefore reduces the time available, as well as overlapping with the requirements to respond to the RIES. We advise that if the ExQ3 are not published until week commencing 23rd March we will have limited time to review and provide a response. We will make best endeavours to adhere to the timetable as drafted, however, in the event we are not able to answer all questions by Deadline 6 we may need to provide some answers at Deadline 7.
