Applicant's Response to Issues Specific Hearing 1 (ISH1) Action Points – Deadline 2

Under the Action Points arising from Issue Specific Hearing 1 (ISH1) on the scope of the development held on Tuesday 11 November 2025 [EV3-007], the ExA requested that the Applicant provide a response to a response to a post hearing submission to be made by Marianne Fellowes at Deadline 1A.

On 2 December 2025 the Applicant confirmed with the Planning Inspectorate that no submission has been made by the relevant Interested Party, so the Applicant has nothing to respond to at Deadline 2. The Applicant will of course be willing to provide a response to a future submission from this Interested Party.



#### **Relevant Representations Responses**

The Applicant submitted their responses to the Relevant Representations at Deadline 1 [REP1-112 to REP1-117] with the REP1-111 reissued as REP1A-043 at Deadline 1A. This document was split into multiple files due to the 50MB file limit.

The Applicant has received comments from parties who were struggling to navigate the Applicant Response to Relevant Representations document due to the very large number of Relevant Representations received on the project and the split of representation responses between files. Therefore, in order to make the documents easier to navigate for all participants in the Examination, the Applicant has reissued these Documents at Deadline 2, with revised formatting and a specific contents page. We hope this is helpful.

The only changes to **REP1-112 to REP1-117** are to revise the formatting and contents pages to make responses easier to find and read; the content and the responses remain as submitted at **Deadline 1**.

For 9.34.1 Applicant's Detailed Responses to the Relevant Representations [REP1A-043] the Applicant has filled in responses to blank rows G1, G2 and G3 of Table 2.38 NE - Offshore Ornithology in the response to Natural England.

Track and clean versions of both documents are provided to illustrate the changes.

#### **Accompanied Site Visits (ASI)**

In **Annex A** of their **Rule 8 Letter [PD-013]** the ExA required the Applicant to provide a draft itinerary for Accompanied Sites Inspections (ASI) at **Deadline 3** 'if required'. The Applicant therefore would greatly appreciate an early confirmation of whether or not a draft itinerary for an ASI is required.

#### **Aldeburgh Town Council**

Having reviewed Aldeburgh Town Council submission **REP1-145** and **REP1-146** the Applicant considers the points raised in this submission do not represent a Written Representation and would instead be covered in the Applicant's Written Response to Open Floor Hearing 1 and Applicant's Comments on Other Submissions Received at Deadline 1A as relevant.
