Where applicable, these documents are provided in clean and tracked versions as requested in the Rule 6 Letter **[PD-010]**. The Application and Examination Document Tracker (**Application Document 9.77 (E)**) has been updated to reflect the above submissions.

### Post Hearing Actions

As set out above, the Applicant is submitting **9.90 Applicant's Response to January Hearing Action Points from Compulsory Acquisition Hearing 1 (CAH1) and Issue Specific Hearing 2 (ISH2) – Deadline 4**.

During those hearings, a number of aspects of the draft Order were discussed, and certain actions taken by the Applicant to review or adjust drafting. Those actions included providing updates on the progress of certain drafting matters (e.g. Article 10), where it was accepted that a final agreed position could not be reached by Deadline 4. The Applicant has sought to address all such drafting changes and updates via the submissions in the above table, including amended drafting where appropriate (e.g. Article 27). This includes an updated version of the Requirements,

being Schedule 3 to the draft Order. The Applicant is aware that the ExA is scheduled to be producing its next round of written questions (ExQ2) in due course. Whilst the draft Order itself is not formally programmed to be submitted again to the ExA until Deadline 5, in order to assist with the examination the Applicant proposes to submit a revised version of the dDCO (incorporating all the matters set out above, as well as any other matters where it is possible to do so) at the earlier Deadline 4a, alongside an amended version of **9.84 Register of Environmental Actions and Commitments (REAC) (Clean) [REP3-078]**. The Applicant trusts that this will assist by having both those updated documents available together at the earliest possible deadline.


### **Late Deadline 3 Submissions**
