# Appendix A RSA Strategy

#### A.1 Introduction

#### Overview

- A.1.1 This document has been produced as an appendix to the Transport Assessment (document reference 7.11) for Norwich to Tilbury (the 'Project'), submitted as part of the Development Consent Order (DCO) application.
- A.1.2 National Grid Electricity Transmission plc ('National Grid') owns and maintains the national high voltage electricity transmission network throughout England and Wales.
- A.1.3 The transmission network connects the power from where it is generated to the regional Distribution Network Operators who then supply businesses and homes.
- A.1.4 National Grid holds the Transmission Licence for England and Wales, and its statutory duty is to develop and maintain an efficient, coordinated and economical system of electricity transmission and to facilitate competition in the generation and supply of electricity, as set out in the Electricity Act 1989.
- A.1.5 National Grid has developed plans for the Project. The Project would support the UK's net zero target through the connection of new low carbon energy generation in East Anglia and by reinforcing the transmission network.
- A.1.6 The Project comprises reinforcement of the transmission network between the existing Norwich Main Substation in Norfolk and Tilbury Substation in Essex, via Bramford Substation, the new East Anglia Connection Node (EACN) Substation and the new Tilbury North Substation.
- A.1.7 The reinforcement is needed because the existing transmission network, even with current upgrading, will not have sufficient capacity for the new renewable energy (a substantial proportion of which would be generated by offshore wind) that is expected to connect to the network over the next 10 years and beyond. Completion of the Project, together with other new reinforcements across the country, will meet this future energy transmission demand both in East Anglia and across the UK.
- A.1.8 The Project is a Nationally Significant Infrastructure Project (NSIP), and National Grid is seeking development consent under statutory procedures set by government. NSIPs are projects of certain types, over a certain size, which are considered by the government to be of national importance, hence permission to build them needs to be given at a national level, by the relevant Secretary of State (in this case the Secretary of State for Energy Security and Net Zero). Instead of applying to the Local Planning Authority for planning permission, the developer must apply to the Planning Inspectorate for a DCO that would grant development consent.
- A.1.9 National Grid has submitted an application for development consent to the Planning Inspectorate. The Examining Authority (consisting of one or more examining inspectors), after a period of public examination, would make their recommendation to the Secretary of State for Energy Security and Net Zero, who in turn would decide on whether development consent should be granted for the Project.

A.1.10 The Project is identified as critical to delivering a network which supports the clean power pathways for 2030 delivery.

#### Purpose and Structure of the Document

- A.1.11 To facilitate the construction of the Project, site access points and crossover points are planned from the existing public highway to connect to the proposed temporary haul roads. Highway mitigation measures are also proposed. Construction of the Project is anticipated to take place between 2027 and 2031.
- A.1.12 This report has been produced by Mott MacDonald to summarise the Road Safety Audit (RSA) strategy undertaken during the development of the DCO application for the Project. The Road Safety Audit strategy for the Project is to undertake Stage 1 RSAs of the preliminary designs of the site access points, haul road crossover points, and highway mitigation proposals required for the Project. The strategy has included Local Highway Authority (LHA) and National Highways engagement throughout the process, including obtaining approvals and sign-off of RSA briefs and reports in line with the Design Manual for Roads and Bridges (DMRB) document 'GG 119 Road Safety Audit' (National Highways, 2025).
- A.1.13 Whilst undertaking Road Safety Audits is not a formal legal or technical requirement for DCO submission, given the Project's scale and programme drivers, National Grid have pre-emptively undertaken these. It is expected that Stage 2 RSAs will be undertaken during detailed design, and Stage 3 and Stage 4 RSAs will be undertaken, where applicable, upon substantial completion of each phase or element of the highway works required as part of the Project.
- A.1.14 This report records the RSA1 briefs, RSA1 reports, and RSA1 response reports that have been produced at the time of writing of this report.
- A.1.15 A list of documents and drawings that were submitted for each RSA1 is also provided.

#### A.2 RSA1 requirements

- A.2.1 The Design Manual for Roads and Bridges (DMRB) document 'GG 119 Road Safety Audit' (National Highways, 2025) explains the circumstances in which RSAs should be completed (for the trunk road and motorway network). It is recognised good practice to follow the requirements outlined in GG 119 for local highway authority road networks as well.
- A.2.2 The Project proposes both temporary and permanent traffic management and physical changes to the highway.
- A.2.3 Paragraph 2.1 of GG 119 states that:
- A.2.4 'Temporary measures that last 6 months or longer in duration are considered to be physical changes to the highway. Examples of such measures include:
  - temporary traffic management
  - temporary changes to the highway not associated with the construction of a highway scheme'.
- A.2.5 As the construction period of the Project is expected to exceed 6 months and proposes temporary traffic management measures and physical changes that will be

- in effect for longer than this period, RSAs should be completed for the Project in accordance with DMRB GG 119 (Road Safety Audit) (National Highways, 2025).
- A.2.6 There are various stages of RSA required that are specified within the DMRB, which are summarised in Table A.1.

Table A.1 Stages of road safety audit

Stage	Details
Stage 1	Undertaken after completion of preliminary design.
Stage 2	Undertaken after completion of detailed design.
Combined Stage 1-2	Undertaken after completion of detailed design (if the scheme progressed straight into detailed design).
Interim Stage	Not required, but can be used to supplement Stage 1, 2 and 3 RSAs to flag issues earlier in the design process.
Stage 3	Undertaken after completion of construction.
Stage 4	Monitoring of scheme for min. 12 months post-construction. A Stage 4 RSA report is required if road traffic collisions have been recorded in the vicinity of the scheme over the period of monitoring (12 months).

- A.2.7 The RSAs referred to in this RSA Strategy are RSA1 assessments of the following proposals that have been completed to preliminary design stage:
  - Site access points
  - Crossover points
  - UK Power Networks (UKPN) access points
  - Other localised highway mitigation proposals, requiring physical construction works either within the highway or extending into private lands adjacent to the highway.
- A.2.8 There are locations within the highway requiring temporary modifications to the existing street furniture, to accommodate the safe passage of Abnormal Indivisible Loads (AILs) required to deliver large materials to various destinations within the Project, or their return journeys away from the site delivery locations. These specific locations requiring temporary modifications have not been submitted to RSA1.
- A.2.9 Such examples of these modifications are the temporary removal of street furniture comprising post mounted road signs, street lighting columns, pedestrian guard railing, illuminated/non-illuminated road bollards, or central traffic islands / pedestrian refuge islands. These temporary modifications are to be assessed on a case-by-case basis at later stages of detailed design, such as those involving pedestrian refuge islands where crossing distances may lengthen due to removal of central refuge islands.
- A.2.10 Temporary mitigation measures may be proposed at each of these locations, to maintain safety features until such time that the permanent reinstallation of the removed items is appropriate to be carried out. Factors to consider for each site

would include requirements for temporary pedestrian and/or traffic management, and timescale durations of how long the existing features will be removed to accommodate AIL delivery movements.

A.2.11 No RSA1 has been undertaken for temporary haul road crossover points on private tracks or lanes, as non-highway locations are excluded from the RSA process.

#### A.3 RSA1 methodology

A.3.1 The Project proposals span multiple local authorities in the East of England. Prior approvals in principle (AIPs) have been sought out from each 'Overseeing Organisation', the respective LHAs comprising Norfolk County Council, Suffolk County Council, Essex County Council and Thurrock Council, and additionally, National Highways where works interface with their Strategic Road Network (SRN).

#### RSA1 briefs

- A.3.2 RSA1 briefs were prepared by the 'Design Organisation' (Mott MacDonald, on behalf of National Grid) and geographically divided by Local Highway Authority or National Highways. The briefs outline the scope that the RSA team were commissioned to review.
- A.3.3 In accordance with DMRB GG 119 (National Highways, 2025), each RSA1 brief comprised the following sections:
  - Project summary; including the Project/report titles, document reference, name and dated signature of author, name and dated signature of approver representative and organisation
  - General details; including highway scheme name and road number, type of scheme, stage of RSA required, contact details of the Overseeing Authority (the Local Highway Authority or National Highways), contact details of the Design Organisation, details of the Road Safety Audit Team membership, and terms of reference to be used for the audit (DMRB GG 119)
  - Scheme details; including general description of the scheme (the Project) and its
    objectives, construction programme start and end dates, and construction hours
    of operation
  - **Design standards** applied to the scheme design (i.e. the DMRB)
  - Design speeds and existing speed limits; design speeds used for the
    preliminary design were based on 85th percentile speed survey data and sitespecific constraints to determine the suitable design speed, with the decision
    making recorded. The existing speed limits are those posted along highways in
    the locations of the proposals
  - Existing traffic flows/queues
  - Forecast traffic flows
  - Pedestrian, cyclist, and equestrian desire lines
  - Environmental constraints
  - Description of locality and relevant factors which may affect road safety

- Collision data analysis; Historical collision data to cover a minimum 5-year period was purchased from each Local Highway Authority and additionally sourced through desktop studies with data available from the CrashMap (UK Road Safety Map) website (date range between 2018 to 2022) and the DfT Mavric (Department for Transport, Mapping Application for Visualising Road Injury Casualties) website (date range between January 2019 to December 2023)
- Departures from standards; where relevant
- Previous road safety audit stage reports and response reports (including
  evidence of agreed actions). This was applicable for only some site access points
  where a design was developed post RSA (for example, a unidirectional access
  bellmouth changed to bidirectional access) or where a site access point was
  audited again as part of wider highway mitigation proposals
- Strategic decisions
- List of included documents and drawings
- Checklist (for completing the RSA brief with sufficient information).
- A.3.4 A list of RSA1 briefs produced at the time of writing is shown in Section A.4.
- A.3.5 Prior to conducting RSAs, the drafted RSA briefs were issued to the respective Overseeing Organisations for their comment and acceptance. These were then amended where agreed and issued for use by an RSA team.

#### RSA1 inspections and reports

- A.3.6 An RSA team was commissioned to carry out the audits as per the scope provided in the RSA1 briefs, which included a site visit by the RSA team during daytime hours for each location identified in the scope.
- A.3.7 The RSA team comprised of one safety audit team leader and one safety audit team member (in accordance with Paragraph 3.1 of DMRB GG 119 (National Highways, 2025)). Both individuals were independent from the highway scheme conception, design, construction, and operation (Paragraph 3.3 of DMRB GG 119).
- A.3.8 All RSA team members submitted professional curriculum vitae (CV) to the relevant Overseeing Organisation to demonstrate sufficient competency and experience prior to undertaking audits. Upon review, the Overseeing Organisation approved all RSA team members and their roles within the audits.
- A.3.9 At the request of the Overseeing Organisation, Specialist Advisor(s) or Observer(s) were brought in for National Highways SRN locations to attend the audit process.
- A.3.10 The RSA team leader was responsible for producing RSA reports upon completion of the audit. In accordance with DMRB GG 119 (National Highways, 2025), each RSA1 report comprised of the following sections:

- Introduction; including details of the RSA stage, RSA team members, Specialist Advisor(s) where applicable or Observer(s) where applicable, document reference, terms of reference (DMRB), location of audit, description of the scheme (the Project) and its location and objectives, details of the author and approver of the RSA
- Site visit records; including date, time, weather conditions, road surface conditions, traffic conditions, other observations made by the RSA team, and a record of team members who completed the site visit
- A review of information provided in the RSA brief and its appended documents
- A Road Safety Audit Decision Log detailing the RSA problems identified and the RSA recommendation for addressing these
- Location plans and photographs marked up with references to problems identified by the RSA team.
- A.3.11 A list of RSA1 reports produced at the time of writing is shown in Section A.5.

#### RSA1 response reports

- A.3.12 After receipt of each RSA1 report, the Design Organisation produced a corresponding RSA1 response report in collaboration with the Overseeing Organisation (the Local Highway Authority or National Highways).
- A.3.13 In accordance with DMRB GG 119 (National Highways, 2025), each RSA1 response report comprised of the following sections:
  - Introduction
    - Project details; including the Project/report titles, document reference, name and dated signature of author, name and dated signature of approver representative and organisation
    - Overview; including background information on the Project, a brief description
      of the preliminary design proposals subjected to the RSA audit, site visit
      details, the terms of reference used (DMRB) and the document reference of
      the audit report being responded to
    - Key personnel; including details of the Overseeing Organisation, RSA Team, Design Organisation, and Developer/Scheme Promotor
  - Road Safety Audit Decision Log; including the RSA Problem Ref, RSA Recommendation, Design Organisation Response (either 'Accepted', 'Accepted with alternative solution' or 'Disagree'), Overseeing Organisation Response, Agreed RSA Action (agreed between Design Organisation and Overseeing Organisation)
- A.3.14 The log revisits each road safety problem flagged and recommendation provided in the RSA report and records the associated response of the Design Organisation. In accordance with Paragraph 4.16 of GG 119 (National Highways, 2025), one of the following responses was selected:
  - RSA problem and recommendation accepted
  - RSA problem accepted with alternative solution (suggested and explained by the Design Organisation)

- Disagree with the RSA problem and recommendation (with reasoning provided by the Design Organisation for rejecting both).
- A.3.15 The RSA decision log also contains the response of the Overseeing Organisation to each problem, recommendation, and the RSA actions agreed between the Design Organisation and Overseeing Organisation.
- A.3.16 Either the Design Organisation or Overseeing Organisation are responsible for the implementation of the agreed RSA actions. This included changes to proposed temporary traffic management measures (such as temporary speed limit reductions or introduction of signalised crossings) at some locations. As part of the implementation of RSA actions, the preliminary design drawings for these locations were amended to account for these changes post RSA.
  - Organisation Statements
  - **Drawings and documents referenced**; including details such as reference number, revision and title.
- A.3.17 A list of RSA1 response reports is shown in Section A.6.

#### Summary of process

- Based on the requirements established in Section A.2, the Design Organisation completed the preliminary design for each location requiring a RSA1
- RSA1 briefs were prepared by the Design Organisation for these locations (GG 119, para 4.2)
- Each RSA1 brief was submitted to the Overseeing Organisation for review and acceptance in principle (GG 119, para 4.3)
- Stakeholder engagement has been held regularly with each Overseeing Organisation (Local Highway Authorities or National Highways) on area-wide proposals prior and during the writing of the RSA1 briefs and development of the preliminary design
- Overseeing Organisations signed and accepted the RSA1 briefs
- Overseeing Organisations reviewed professional CVs of the RSA team and approved its members. The RSA team were independent from the highway scheme conception, design, construction, and operation
- The RSA team completed RSA1s as instructed by the scope in each brief.
- RSA1 reports were produced by the RSA team, which identified problems to be considered by the Design Organisation and Overseeing Organisation
- The RSA team also provided recommendations for each of the RSA problems identified in the above reports. (GG 119, para 4.6 & para 4.7)
- In response to each RSA1 report, the Design Organisation produced a RSA1 response report which reviewed the findings of the RSA team and provided a response to each problem identified (GG 119, paras 4.11 to 4.19)
- The RSA1 response reports were shared with the relevant Overseeing Organisations and to keep a record on file (GG 119, para 4.20)
- After acceptance of RSA1 response reports by the Overseeing Organisation, these were also submitted to the RSA team for their consideration and acceptance of the proposed solutions (responses) to the RSA problems

- Where RSA problems remain unsolved, further Design Organisation input or consideration is to be given
- Remaining problems that are not appropriate to fully mitigate at this stage (such
  as specific temporary traffic management arrangements, construction materials or
  site-specific surface water drainage requirements) are to be further addressed in
  later detailed design stages of the Project which will be subject to Stage 2 Road
  Safety Audits (RSA2) (Stage 2 detailed design).

#### A.4 List of RSA1 briefs

- A.4.1 Table A.3 to Table A.9 record the RSA1 briefs produced for the proposed site access points (from Primary Access Routes), temporary haul road crossover points and highway mitigation proposals across their relevant Overseeing Organisation regions.
- A.4.2 A number of locations were situated away from the public highway on private roads/tracks and so were excluded from RSA. A record of these locations has been kept in the RSA1 briefs, RSA1 reports and RSA1 response reports with an accompanying note to explain that these locations were not audited for this reason.
- A.4.3 Some crossover bellmouths and site access points within the Tilbury area of Thurrock were submitted for audit, comprising alternative design options at those locations. These alternative design options were produced to coordinate with the construction of the proposed Lower Thames Crossing (LTC). All alternative design options (i.e. scenarios of 'with LTC' or 'without LTC') were submitted for review in the RSA1 briefs.
- A.4.4 There are a few instances where a repeat RSA1 was undertaken for proposals at certain locations. These were required due to the design development of the Project introducing changes to the proposals. In accordance with DMRB GG 119 (para 4.21) the repeat RSA1s were only concerned with the elements of the scheme that had changed since its previous audit. One such example was amending a site access point from unidirectional access/egress into a bidirectional access, where additional turning movements to/from the site were to be considered during the revised audit.
- A.4.5 Furthermore, through design development, many site access points (bellmouths) and haul road crossover points (bellmouths) have had their reference ID changed between the August 2024 Section 42 (S42) statutory consultation, and the final proposals being submitted within the DCO.
- A.4.6 Where such locations had been audited (RSA1) under their original reference ID (S42) and subsequently renumbered through design development, the RSA1 response reports now refer to both the original reference ID (S42) and DCO reference ID. For example, the site access point proposed on the A1066 High Road, Roydon in Norfolk is referenced as RG-B048 (S42) / RG-B052 (DCO).

Abnormal indivisible load	A large load which cannot 'without undue expense or risk of damage' be divided into two or more smaller loads for the purposes of being transported by road, and which exceeds limits set out in terms of weight (>44 tonnes), length (>18.65 m), and width (>2.9 m).
Development Consent Order	A statutory instrument which grants consents and other rights to build a Nationally Significant Infrastructure Project, as defined by the Planning Act 2008.
Local Highway Authority	The public authority whose duty it is to maintain and protect the safety and usability of public roads.
Primary Access Routes	Access routes on the public highway designated for use by construction vehicles (typically for HGVs) to travel from the strategic road network / major road network to the site access point.
Transport Assessment	Transport Assessment is a comprehensive and systematic process that sets out transport issues relating to a proposed development. It identifies what measures will be taken to deal with the anticipated transport effects of the Project. It is separate to Chapter 16: Traffic and Transport (document reference 6.16).
