
Isometric view on pylon L6(m) D STD








Isometric View on Pylon L12 D90 STD
























Elevation of L12 D90 uplift foundation




Elevation of L12 DT (0-40) MK3 uplift foundation




Elevation of L6m D uplift / compression foundation








Elevation of L6m D30 (0-10°) uplift / compression foundation


Elevation of L6m D30 (10-30°) compression foundation









Elevation of L13 LD30 (0-10) uplift / compression foundation






Elevation of L13 LD30 (10-30) uplift foundation






