Based on the information that you have provided with your request, the Examining Authority has decided that it considers that you are within one or more of the categories set out in s102B PA2008, namely category 1/2/3.

A person is within Category 1 if the person is an owner, lessee, tenant (whatever the tenancy period) or occupier of the land.

A person is within Category 2 if the person—

- (a) is interested in the land, or
- (b) has power—
 - (i) to sell and convey the land, or
 - (ii) to release the land

(4) A person is within Category 3 if, should the order sought by the application be made and fully implemented, the person would or might be entitled—

- (a) as a result of the implementing of the order,
- (b) as a result of the order having been implemented, or
- (c) as a result of use of the land once the order has been implemented, to make a relevant claim.

(5) In subsection (4) “relevant claim” means—

- (a) a claim under section 10 of the Compulsory Purchase Act 1965 (compensation where satisfaction not made for the taking, or injurious affection, of land subject to compulsory purchase);
- (b) a claim under Part 1 of the Land Compensation Act 1973 (compensation for depreciation of land value by physical factors caused by use of public works);
- (c) a claim under section 152(3).
