Further to the issuing of the Rule 6 letter and submissions you will be receiving today from, amongst other groups, Ardleigh and Little Bromley Parish Councils, via their appointed barrister Mr Simon Bell (The Barrister Group), Tendring District Council writes to confirm its support for the procedural requests made by the Parish Councils.

In particular, Tendring District Council strongly supports requests to:

- include a dedicated Issue-Specific Hearing focused on impacts within the Ardleigh and Little Bromley Area (ALBA);
- require early disclosure of, and questioning on, emergency response arrangements and worst-case incident planning;
- carry out an accompanied site inspection of the ALBA; and
- reconsider the proposed venue for the Essex-focused Open Floor Hearings and any related ISHs currently scheduled to take place at Orsett Hall, with a view to relocating these to a venue closer to the ALBA to improve accessibility for the significantly affected ALBA.

Tendring District Council considers that these measures would assist in ensuring the examination is accessible, proportionate and properly focused on the areas experiencing the most concentrated impacts of the proposed development.

Please also note that TDC has registered to speak at the preliminary hearing on Tuesday 10 February 2026 – in the main to assist in answering any questions the ExA may have (a TDC representative will be attending in person). TDC have also registered to speak virtually on Thursday 12 and Friday 13th Feb at the Essex Open Floor Hearing and the Essex Issue Specific Hearing 1.
