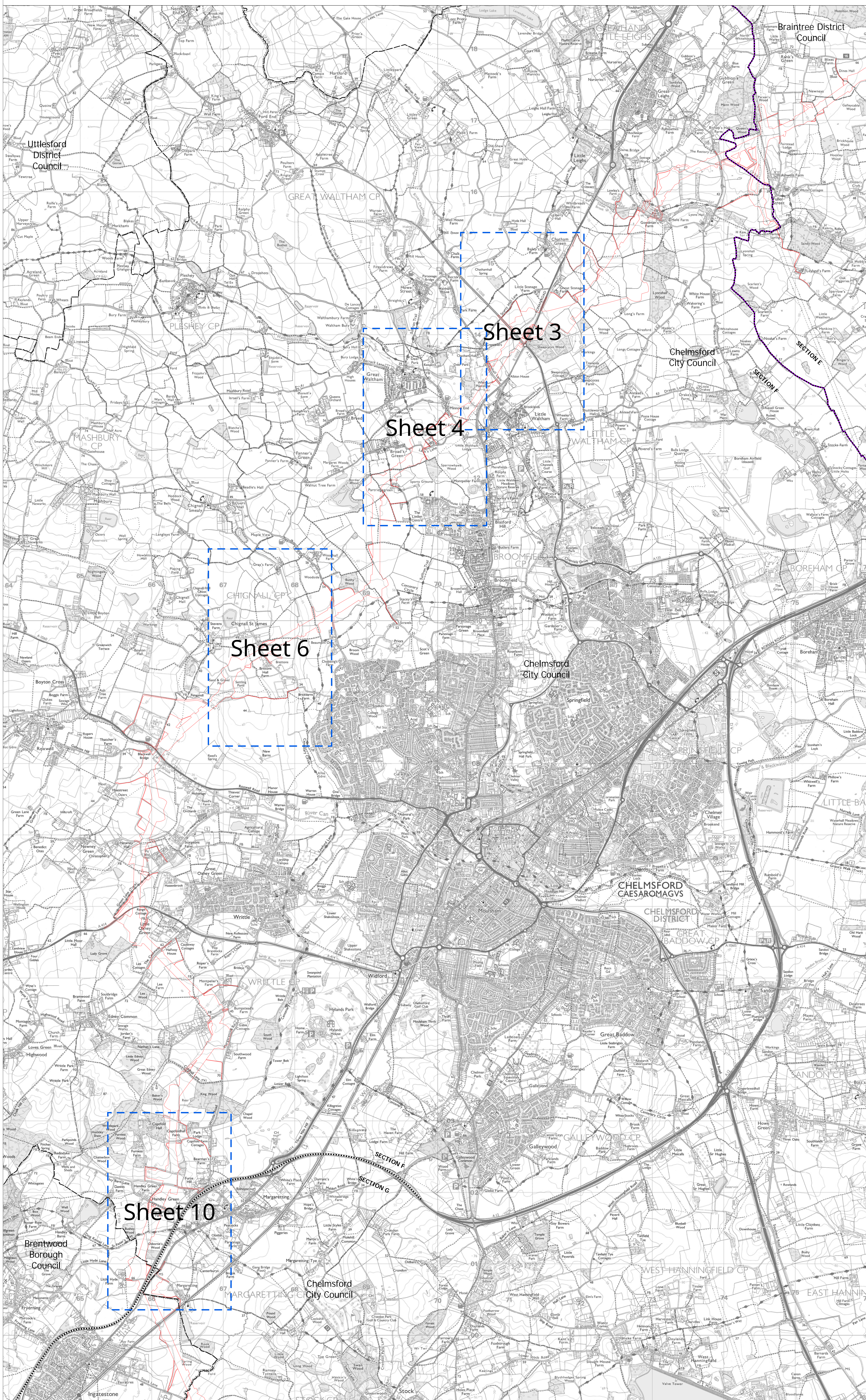

SITE MAP



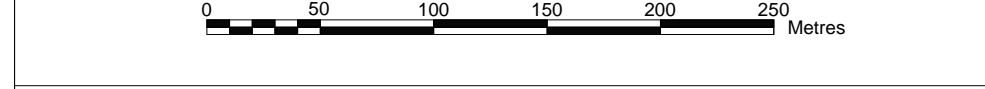

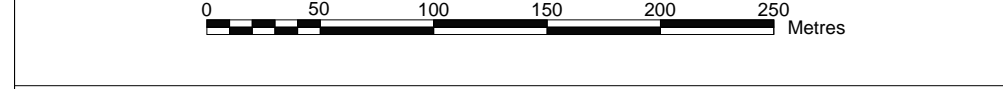

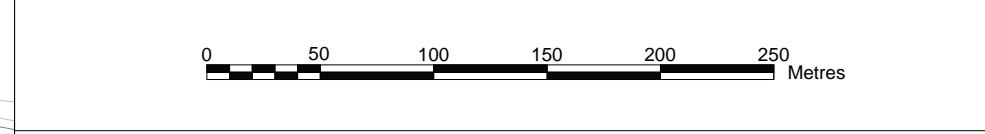
