Statements of Common Ground

1. Overview

- 1.1.1 In accordance with government guidance (Planning Act 2008: Pre-application stage for Nationally Significant Infrastructure Projects, published 30 April 2024), the Applicant has been developing Statements of Common Ground (SoCGs) with a number of statutory prescribed and non-prescribed consultees, statutory undertakers and interested parties throughout project development. The SoCGs seek to identify matters on which parties agree, and to track progress towards the resolution of any matters where agreement has not yet been reached.
- 1.1.2 The SoCGs are largely structured as follows:
- Summary of key engagement undertaken to date with the consultee
 - Table(s) summarising the key interests of the Parties (arranged by topic/discipline where relevant) and the status of each matter:
 - ‘Not agreed’ indicates a final position, where it has not been possible to resolve the issue to the agreement of both parties and there remains a difference of opinion;
 - ‘Under discussion’ indicates where issues are the subject of active ongoing discussion;
 - ‘Agreed’ indicates where an issues has been agreed or resolved satisfactorily to the agreement of both parties.
- 1.1.3 The Applicant welcomes the clarity provided in the **Rule 6 letter [PD-009]** regarding SoCGs. We note that no additional stakeholders (beyond those listed within this document) were requested by the Examining Authority to require a SoCG.
- ~~4.1.4~~ The Applicant also welcomes the level of engagement from stakeholders during the pre-application and pre-examination phases, together with the progress that has been made on the SoCGs in advance of ~~Deadline 5.~~
- ~~4.1.5~~ finalisation for ~~The Applicant looks forward to continued engagement with stakeholders to resolve outstanding matters as far as possible and will reflect this engagement in the final SoCGs to be submitted at~~ Deadline 7 as per the **Rule 6 letter [PD-009]**.

2. List of SoCGs and status

- 2.1.1 As requested by the Examining Authority in Written Question GEN 1.18, this SoCG overview document provides a list of SoCGs which:
- Includes both the name of the organisation as well as the location/name of the development which the SoCG related to (if relevant), such as the location/name of the solar farm or housing proposal

- States whether the organisation is a statutory consultee, an Affected Person (AP), and whether they are a Non-Interested Party
 - Number each of the SoCG in the table consecutively
 - Includes all examination library references.
- 2.1.2 For the purposes of this document, a Non-Interested Party (Non-IP) is a stakeholder who did not submit a Relevant Representation and did not request to become an IP accepted at the discretion of the Examining Authority.
- 2.1.3 A Statutory Consultee refers to those included in **5.1 Consultation Report – Appendix F: List of prescribed consultees identified and consulted during statutory consultation [APP-072]**.
- 2.1.4 An Affected Person is a stakeholder who has an interest in land within the project Order Limits as per **4.4 Land Rights Tracker [REP3-018REP5-074]**.

2.2 **Deadline 56 update**

- 2.2.1 Seven final SoCGs have been signed by both parties and submitted to the Examining Authority at Deadline 6. An updated SoCG with Tarchon has also been submitted at Deadline 6 to reflect the nature of discussions to date.
- 2.2.2 ~~2.2.1~~ The Applicant has been engaging with stakeholders to progress final SoCGs to be submitted at Deadline 7, focusing on moving matters to (ideally) ‘agreed’ or (in other cases) ‘not agreed’ so it is clear to both parties and the Examining Authority what matters remain under discussion and ~~require further engagement. A number of SoCGs have been submitted at Deadline 5 to reflect matters and engagement which have been progressed. The Applicant will continue to engage with stakeholders to progress matters ahead of final signed versions of SoCGs to be submitted at Deadline 7. The Applicant notes that in at least one case the other party has stopped engaging in relation to the SoCG and it is possible that not all SoCG will be signed.~~ where there will be a difference of position by the end of the examination.
- ~~2.2.2 As requested by the Examining Authority in Written Question GEN 1.18, SoCGs submitted at Deadline 4 were updated to include an ‘at a glance’ summary table of matters which remain under discussion, and a proposed deadline for resolution of those matters. These summary tables have been updated at Deadline 5 to reflect matters which have since been resolved to be either ‘agreed’ or ‘not agreed’.~~
- 2.2.3 A number of SoCGs remain at risk of not being signed by Deadline 7 due to the nature of some matters requiring ongoing, detailed discussions beyond the examination period. In these cases, the Applicant has issued updated documents to the stakeholder and is awaiting confirmation to progress with signatures.
- 2.2.4 Engagement will continue with all relevant stakeholders throughout the remainder of examination. Where a SoCG may not be signed by Deadline 7, the Applicant will submit the latest available version to reflect the current nature of engagement and issue resolution.
- 2.2.5 ~~2.2.3~~ The Applicant confirms that the submissions listed in Table 2.1 have been updated to clearly identify those SoCGs being submitted at Deadline 56.
