**Withdrawal of Representation - PACE Nano Energy Limited**

We act on behalf of PACE Nano Energy Limited (company number 12645785) (**PACE Nano**), which is a wholly owned subsidiary of Egg Power AssetCo Limited (company number 16485175) (**Egg Power**).

PACE Nano registered as an Interested Party in the Examination of the DCO for NGET's proposed Norwich to Tilbury Project. PACE Nano has made representations throughout the Examination, see: [\[RR-2789\]](#), [\[REP1-264\]](#), [\[REP3-129\]](#), [\[REP5-261\]](#) and at Deadline 5a. The parties have also engaged through a Statement of Common Ground [\[REP4-227\]](#).

PACE Nano has engaged with the Applicant and has satisfactorily resolved the matters referred to in its representations and the Statement of Common Ground in the Examination. As a result, PACE Nano hereby withdraws its representations to the DCO application and does not intend to participate any further in the Examination.

Notwithstanding this, PACE Nano reserves the right to make fresh representations in relation to any:

- new or amended provisions of the DCO that may be introduced after the date of this letter which make a change which is prejudicial to PACE Nano's interests in connection with the Proposed Development; or
- representations in relation to the management of mitigation and enhancement requirements between the Proposed Development and PACE Nano's project, Grange Solar Farm.
