Thank you for this opportunity to let me speak on the planning application for Morgan and Morgan Wind Farms. You have already heard from File Council's planning officers this morning, so I will avoid duplicating the points they have previously raised. File residents are not against wind farms or green energy.

I want to make this known, but the proposed cable corridor through file countryside to the grid connection at PEM with them is of great, great concern.

We would not want to be accused of or be known as NIMBYs in Fylde.

I will demonstrate this by mentioning today a few business operators who practice in Fylde. We have Grange one, two and three landfill sites taking the dustbins and refuge from far and wide and failed,

which residents experienced much later unpleasant orders included in hydrogen sulfide from day to day. But we don't complain.

We have the Systems Aerodrome, a company we are proud to have within our borough, providing many high skilled technical jobs. But the low flying jets bring much noise to our living environment, which concerns many people. But we don't complain. We have Clifton Marsh Water Treatment works, which takes our sewerage from far and wide. Not a pleasant practice here in Fylde, but we don't complain.

We have Springfields works, where nuclear fuels are manufactured for nuclear reactors the world over again. We are proud that this technical expertise is his champion in our borough, but it is a high risk practice that some would fear. But we don't complain. We have an open prison at Kirkham, which over the years does cause concern for many residents in Fylde. But we don't complain.

However, this cable corridor and connection is a step too far for file residents because of the environmental impacts such as closure of Saint Anne's Beach and Saint Anne's Sand Dunes. Saint Anne's is a popular tourist resort, and this will have a significant impact on our local visitor economy. Disruption to Blackpool Road North Playing Fields, the home of Saint Anne's Football Club, where many children regularly play and exercise.

Damage to grade one agricultural land, risking local food security and farming practices, which has taken many years to develop.

Noise and pollution from heavy goods vehicles during the construction along residential roads and country lanes. Not suitable for heavy traffic.

Ultimately, this is about people and livelihoods. For instance, Red Green Equity Centre 43 years of riding school for disabled children, which Princess Royal has visited several times as patron of riding for the disabled. This careful corridor will decimate their business.

Sometimes junior football club, family farms and those living near to the proposed substations, to name a few.

I urge the panel to listen to all our concerns from the professional officers of the host authorities and to all our speakers this afternoon when making your recommendation to the Secretary of State. Thank you.

Okay. Thank you. Uh, we'll now move on to Mr. from Lancashire County Council.

I don't take Valpo council. I did just confirm that, um, he isn't, uh, intending to join or speak this afternoon. Okay.

Thank you for that. Um, Mr. Morgan, then can I call on you, uh, with five minutes on behalf of the community.

Yes.

My name is Phil Morgan.

I'm vice chair of Newton with Clifton Parish Council. I'm also chair of something called the Transmission Assets Steering Committee, which is made up of eight town and parish councils and two community organizations. Um, I suppose I've got four questions or points I want to raise in this part of the session. Um, the first is in Newton with Clifton. Um, we already have a lot of nuclear and solar energy projects in our community. Um, our whole community covers about 180 acres.

Um, the existing projects already covered 225 acres. Um, that's larger than our two villages put together. In addition, there are two proposed solar farms, uh, covering another 249 acres. Um, one of these will require a major diversion of the cabling route under the A5 84. Twice in a short period of time. Short space. Face another one which has just been updated and resubmitted. Proposes an access route for construction which crosses the cabling route.

Um, this particular one is actually going to also rest next to the substations. And you're very welcome to come see the view from my house as it is now, because what you'll see in the future is a non-stop sea of solar panels, substations and cabling routes from my house in Newton scales across to our neighbours in Freckleton. Most of the assessments that took place in the proposals took no account of the cumulative impact on our community.

The second point is around why we're having two substations and why is it so large. We've heard before from the applicant that they they're working very well together. They want to do lots of things

together. But why have two substations? Couldn't they just have one? Wouldn't one be smaller? And when we look at the size of the two substations as well. They're proposing to take over 22 hectares of greenbelt land for a headline output of two gigawatts. When we look at other ones of a similar size, the Dogger Bank 2.4 only requires 7.5 hectares.

Hornsea One and two, which generate 2.5GW, have a footprint of 7.1 hectares and more than, which is the other one that relates to this indirectly, which generates 1.4GW, has a maximum footprint of 6.6 hectares. So it just is too big. There's no need for two of them, and there's no need for them to be as big as they are. And if a smaller design had been chosen, there'd have been more opportunity to look at alternative locations which weren't as damaging to our communities and to the green belt.

Um, and all of this just simply magnifies the impact it has on our community, and it has on the green belt. Um, the next point that comes on from that is that how long will the disruption last? Because we've already heard some comments raised earlier today. Why does the need to be at maximum four year gap between the two sets of construction? Why can't it all be done at once? The four year gap will have the impact of magnifying the effect of the proposals on our communities, and all the other things that people will talk about today.

It doesn't need to be like that. It can all be done as one. The last thing I want to talk about is how our community benefits from this. Um, and although it's not a topic for today, we've been disappointed. I think it's fair to say, putting it mildly with the engagement of the Mork and Morgan proposals. Um, when the original pre consultation events took place, we weren't allowed one in Newton, our neighbors, one to live on in Freckleton or Kirkham. Instead we had to go to other places in Lisburn and in my case in Penwortham.

Um, so we feel very frustrated. There has not been engagement. And on the issue of community benefits particularly, I've had a conversation with the M&M people and they said very clearly that they're not going to talk to us about any community benefits whatsoever until the consultation has been approved, and it's their reason for that. The rationale for that was their outstanding guidance of waiting. The consultation took place in 2023. Um, the government has now said it's going to update that guidance.

It's also said that it will in the new planning and infrastructure bill, make sure that there will be provision for communities to get compensation for cabling routes and for substations. And of course, we as a parish council have heard nothing from M&M in line with their previous commitment to us that they were not going to engage with us on any level whatsoever about community benefits until they got this approved. And at that point, and at that point only, would they start to talk to us about what those community benefits were. Thank you.

Thank you, Mr. Morgan. Uh, just a point of clarification. You mentioned two solar farms. Do you have to know the names of those?

Um, once and for all. And that's at Clifton Fields. Uh, that's the one that necessitates a diversion of the cabling route. Uh, under the 85, 84, on two separate occasions, a very short space of time. Uh, that's currently with Fylde Council. Uh, and I think there are objections from Natural England to that as well, which they're currently dealing with. And the other one is I think called Barracks Lane one. Uh, and that's run by Blue Fields. Um, and that's been an application which has been received previously by filed, uh, as a result of objections from the county counsel highways team.

They're now looking at an alternative access through Freckleton, actually on Lower Lane, which is one of the lanes that would be used by this particular project for its traffic. Um, and they're proposing to cut in from lower lane and cut across the brook from Freckleton into the site that way around. And that's currently with Fylde and we as a parish council, and I suspect Freckleton Parish Council will be commenting on that to Fylde in the near future.

I'm speaking on behalf of Freckleton Parish Council, as you said. I'm a chartered engineer. I'm a fellow of the Royal Aeronautical Society, uh, for whom I act as the chair of their registration committee. I'm also I'm responsible for their engineering standards, the application and confirmation of Over registration of those applicants. I also sit on the Registration Standards Committee of the Engineering Council. So I look after the competencies and the registered engineers across the 39 UK professional engineering institutions.

The field is really flat and wet. It's dotted with hundreds of small ponds, and it's an ideal home for amphibians, including great crested newts, which are on our property. I run the filed Toad Patrol in the spring, saving hundreds of amphibians from being flattened by cars.

We regularly see thousands of migratory, pink footed geese wheeling in the skies and calling to each other and feeding on the fields. Barn owls, kestrels and buzzards. Love the ample supplies of resident voles. Their favorite food papers. Straw bats love to feed on the rich menu of insect life, supplied by the ample number of ponds close by. Hedgehogs also love the menu of insects on offer on my property. I'd like to describe a visit last week with Andy Lee, who has over 50 years of conservation knowledge of the land between Kirkham, Freckleton, Clifton and Newton and who is here today.

We explored the farmland affected by the plans for the trenches and the substations, despite it having been drier than normal for the last couple of years of months. The tame cows came over to me, curious as to our intentions.

The dikes must be maintained, so cables would need to be buried really deep to avoid hitting them during the Essential Dyke maintenance programme.

Also, as the water as the land is waterlogged, buried objects tend to come to the surface in the softer areas that the trenches will cross. As this has already been noted in the gas pipeline in the area, which is reburied periodically. Has this been taken into account in the cable plans?

The bluebells were a sea of blue under the shade of trees, which are living headstones to the memory of the dead who are buried there.

It's hard enough trying to make a living as a livestock farmer these days without the threat of this cable ruining farmer's most valuable asset, the land and disrupting livelihoods.

I understand that the two parties involved in the project will not commit the simultaneous installation of their cables. This would seem basic common sense to me. Potentially this could mean that our farmland will not be restored to us in any workable order in our lifetime. How are we to earn a living? How are we to produce a food for our nation?

How do we keep our local farm workers in jobs? Farmers are not motivated by money. It's about putting our heart and our soul into the land. And this cannot be distilled into monetary compensation. Meetings offered reassurance of respect and commitment to working with landowners have proved near worthless since we judge the project by the actions of the contractors on the ground?

This has been exacerbated by some of the new build around the old villages, and certainly in places in Newton and Kirkham and Ray green.

And that touches on their ability to operate as a defense industry, adding to the economy directly and indirectly to people who work for it.

It often gets overlooked just because it's a blue bit on the Ordnance Survey map, but it's, uh, a wild ecosystem in its own right.

Fylde dunes live in Saint Anne's. We have particular skin in that game because we are actually a partner with Fylde Borough Council and Blackpool Council, and indeed the Environment Agency in accreting the dunes there, partly as a coastal defence and partly to restore the ecology which has enabled us to reintroduce the sand lizard, nationally scarce species. We are concerned that the impact of the access tract, which used to be an old stand running track and vibration there, may actually disturb the overwintering or hybridizing, I should say, uh, um, some lizards in the dunes at that point, which I don't think has been picked up by the applicant.

Uh, partly that's because of data deficiency. We have a lot of data, as you might expect, on the habitats and species of the dune system, but we have not been approached for it. And we think the data which the applicant consultant has got is deficient in that regard. I won't expand on that now. Uh, and, uh, in the case of the rest of the route from Saint John's to Penwortham, there's a kind of chicken and egg situation that we are promised mitigation for impact on local wildlife sites, but we don't know the detail of what that will be.

So we're not in a position to say what we think of it, other than we have to assume the worst possible scenario until we know otherwise. And some of the measures proposed actually have the potential to make that worse in terms of its designation
