Thank you for giving me an opportunity to speak. I'm Councillor Richard Radcliffe and I have been elected member of final council for 14 years, serving the people of Fylde. I'm chairman of the Planning committee and deputy leader of the council. I have lived in Fylde for nearly 50 years and served as a headteacher of two primary schools for 28 years. I feel privileged to speak on possibly one of the most challenging issues that has ever faced our local communities in recent times.

However, I would like to begin by reaffirming final support for the principle of cleaner energy production. Indeed, our Local Plan sets out support for renewable energy development. But importantly, we must address adverse impacts and ensure that development is not pursued at the expense of our local environment, communities or planning principles. I'm deeply concerned that the environmental statement submitted by the applicant does not contain the information reasonably required to reach a sound conclusion on the likely impacts of the scheme.

This is not just my view or our view as a council. It is a concern shared by statutory consultees. Businesses, residents. Virtually all interested parties have raised concerns along these lines. Any consideration of the potential benefits of the scheme is undermined by this issue, and as such, all parts of any planned balanced assessment would be flawed.

The landscape and residents are Fylde face real and tangible risks. Our previously submitted local impact report and written statement sets out a wide range of issues. I only have time to mention a few of these now. The impacts on large areas of farmland are unclear, and we have clear evidence from farmers that their livelihoods could be irreparably harmed. The dunes that live them in towns which are an irreplaceable and protected habitat are under threat.

And still our statutory consultees are having to request information from the applicant. The impact on Blackpool Road Playing Fields, which support 46 local football teams, is neither properly assessed or mitigated. Our council tourism, which underpins a large part of the local economy, faces prolonged disruption. The proposed substations would cover a vast area and would impact local residents.

The green belt and landscape. It is unacceptable that details of what actually be built is beyond basic, and that no clear or convincing justification for two separate buildings in such close proximity in a sensitive location has been provided. Residents have told us that they feel shut out of a process clouded by late submissions, vague commitments and no clear timeline.

This has impacted not only on their ability to engage but their wellbeing. People need to know what is being built, where and when. Additionally, there have been significant concerns expressed by local communities about the lack of assessment of the alternative route. Given that the development would result in demonstrable harm for Fylde, I would expect that any deficiencies in the justification for the applicant's chosen route be taken into consideration by the examiners.

My message today is this for this type of development to come forward. The applicant must demonstrate clearly and convincingly that it will deliver local and national benefits, while respecting our local environment, policies and people. As things stand, this proposal does not do that. There is a risk of unjustified harm with very little direct benefit for the Fylde area. Thank you.

Thank you. Good evening. I speak tonight as an elected member of Fylde Borough Council and Freckleton Parish Council on concerns the cable route for the Morecambe and Morgan windfarm may have on our Freckleton community the purpose of maintaining the greenbelt areas is to preserve and protect the countryside, keeping land permanently open. The five new golden rules brought into planning to develop the countryside and greenbelt do not mention this type of development.

Development on Greenbelt should only be given where there is a real need. This land performs a real purpose, not just for farming. The adjacent bridleway is used by horse riders, dog walkers and ramblers for pleasure and to enjoy the countryside for their health and wellbeing. Which leads me on to the effects the threat of this development is having on residents living in close proximity to the proposed covector substation site.

Some people are sensitive to noise pollution, which may be an issue from the station along with the EMF exposure. Will these factors be monitored? And if so, by Who?

Further concerns have been raised by Freckleton history Group around the proximity of the substations to the historic Quaker burial site. Documentation has been supplied regarding subsequent

burials in the fields known as the Burying Yards. Oxford Archaeology North have taken scrapes from the site. However, we have not been given any information on their findings. Will these findings be made available for public comment before any on site work is commenced? I'd like to finish with a quote by Lord Devon, chairman of the Climate Change Committee, which says what on earth are we doing trying to deal with a difficult issue with very out of date proposals.

This is not a Nimby battle. We have got an alternative which is better than which is being proposed and its more up to date. Our neighbours are building offshore hubs. Thank you.

I speak in my capacity as the elected councillor for Bourn ward on the North Wyre Peninsula, and a long standing advocate for sustainable regeneration in our region. My purpose today is to respectfully urge you to include three specific locations in your upcoming site visits as part of the Development Consent Order Examination for the Morgan and Morecambe Transmission Project.

These sites, centered on the Hillhouse Technology Enterprise Zone, are not only materially relevant but potentially transformational. I believe they offer a more efficient, cost effective and environmentally responsible alternative to the currently proposed 30 kilometre transmission route. So firstly, I'd like to highlight the socio economic and strategic importance of the wider peninsula.

The wider peninsula has for far too long borne the burden of the post-industrial decline tourism, fishing, sea transport and chemical manufacturing. Once our economic backbone have diminished drastically Today, wire is one of the most deprived areas nationally. But within that challenge lies a really rare opportunity. The Hill House industrial zone within my ward is not just an underused asset, it is a designated enterprise zone supported by our local master plan, complete with planning advantages, existing utilities and, crucially, a direct link to the national grid via the 400 kV Stanley substation.

The case for an alternative connection route. So, despite these obvious advantages, the applicant has offered no clear rationale for dismissing this site or route. The existing transmission corridor from Stanley to the Irish Sea, just two kilometres in length, is already partially developed. The Walney two offshore wind farm is proof of that. By contrast, the current proposal requires a 30 kilometre new cable trench through multiple communities, sensitive areas and virgin greenbelts.

Independent stakeholders such as MPL Hillhouse have also submitted evidence supporting this route as more appropriate, citing reduced environmental impacts, faster delivery and lower costs. Given the absence of a full evaluation of this option by the applicant, I submit that an on site assessment by the panel is not just justified, it is essential

so the specific locations and the material importance. I respectfully request you visit three locations, the first being the Hillhouse Technology Enterprise Zone to directly observe its scale, infrastructure and proximity to the existing standard substation. Also, to appreciate the warmly two transmission infrastructure and the feasibility of expansion. And also to consider the implications for regional regeneration and, crucially, potential for support supporting environmental remediation of historically contaminated land.

And there is currently an e investigation on the land as we speak. The second location is the Fleetwood Road North and Surprise Way junction to see the protected corridor for potential cable route routing, and also to assess suitability for trench technologies like HDD with minimal disruption. Finally, Russell Promenade Beach to evaluate the clear and short two kilometre corridor from shoreline to substation to compare its impact with the proposed 30km inland trench.

Each of these sites offers unique material insights into a viable and potentially superior alternative that cannot be gained from maps or documents alone. Members of the panel. It is not mere local preference. It is credible, deliverable routes that may offer better outcomes for both the project and the public. Visiting these sites will equip you with firsthand evidence to determine whether due consideration has truly been given to all reasonable alternatives, as required by law and policy.

Good evening. My name is David Thompson.

And I'm speaking as a committee member for the Newton Residents Association, a post I have held for over a decade. I'm here to raise serious and heartfelt concerns about the irreversible onshore elements of the Morgan or Morgan offshore wind farm projects. Whilst these projects are promoted as green energy solutions for us in the Fylde, especially in Newton with scales, Freckleton and Kirkham, the cost is devastating. This isn't just about cables and substations. It is about what we stand for and what we stand to lose forever.

The plan includes 35km of underground cables stretching from Blackpool Airport, culminating in the substations near Newton, and then onwards to pen with them. These two of us are vast substations, each about 34 acres in size, with buildings up to 25m high. This is equivalent to 17 football pitches per site. These industrial installations are proposed on greenbelt land. Some of the best and most productive farmland in our region. This land feeds our communities, supports our rural economy and defines the identity of the countryside.

Once in place, these substations will run 24 over seven. They will hum, they will buzz. They will light up the night sky. What is now peaceful and green will be permanently transformed into an industrial corridor. The cable trench passes close to Newton Bluecoat Primary School and crosses key local roads. These impacts were never made clear to the public. We are not just worried. We are frightened. These installations bring constant noise, light pollution, electromagnetic conditions next to homes, schools and children.

We risk losing cherished footpaths, bridleways and green spaces. Local farms and smallholdings are under threat to the historical fabric of our villages, Newton, Clifton and Southwick are all mentioned in the Domesday Book and they all face irreversible damage. HGV traffic is forecast to raise by up to 700%. Or narrow rural roads simply cannot cope. And despite repeated requests, we still have no visual renderings of the substations.

No clear noise limits, no drainage plans, no mitigation strategies, no enforcement guarantees, no answers. We are told this is about sustainability, yet it destroys the greenbelt protection and the vital areas of separation that prevent our villages from being swallowed by urban sprawl. We are told it's about clean energy, yet value farmland will be compulsory, purchased and built over. Where is the balance between energy security and food security? And that's not happening in isolation.

We already live near two operational solar farms, 25 acres of solar farms to the north of Clifton, and 25 acres to the west of the parish at Tollcross. Now two more are proposed a large solar farm in Concord and Marsh for 170 acres, and another 79 acre site west of Newton. This site was a result of a recent application which is currently under under review. We drew attention to the fact of the second site, which is reference 24 0541, as the applicant has changed their construction access to use Lower Lane rather than Park Lane in Newton.

We would contest that this is also not suitable and dangerous and yet it is a preference for the M&M project. This would lead to a more protracted and harmful impact on the residents of Lower Lane, as this would be accumulated from the existing applications, potentially plus the windfarm project. Bit by bit, we are being encircled by 300 acres of energy infrastructure, on top of the proposed 45 acres for the two substations. To quote our green and pleasant land is becoming an energy corridor, and all the while brownfield alternatives and industrial sites are dismissed without proper assessment.

Let me be clear. We are not against renewable energy. We support it. We want a greener future, but we also want fairness, transparency and a voice in the process. The way this project has been managed through unclear consultation, missing information and disregard of residents concerns has shattered public interest. Many only realize the full scale of the plan when it was nearly too late. We are calling for better. We are asking for a full reassessment of the site selection, environmental impacts and the deeply flawed consultation process.

We are asking you the examining authority to listen, not just to the data, but to people. To see the human cost, the real cost and the permanent cost of getting this wrong. Let's protect our children. And finally, let's protect our green and pleasant land.

As chair of the Lancashire Lancashire Association of Local Councils, Valley Area Committee, energy working Group. We recognise the vital role offshore wind plays in the UK's future energy mix, and support the government's ambitions for economic growth, regional levelling up, energy security and sustainable development at the lowest cost to consumers. However, our review of the applicant's proposals and responses reveals significant concerns that must be addressed for those national objectives to be delivered.

Firstly, the national significance of these projects have been overstated. Ofgem's recent grid connection reforms highlight a backlog of 750GW of projects awaiting connection, far exceeding national needs, even by 2050. The M&M projects contribute only 0.264% of that backlog, and so cannot be considered nationally significant in scale. Moreover, both projects have suffered delivery delays of over two years, meaning they will not be the 2030 clean power target had previously claimed.

The current application involves constructing two 30 kilometer underground cable corridors in separate substations, an approach that is neither efficient nor economic. This stands in direct conflict

with the requirements of the National Planning Statements and the Electricity Act 1989, which mandates economic and efficient solutions. Recent costings published by the Institute of Engineering and Technology we are to demonstrate that adopting this and nothing but adopting the material alternative route by a standard, Hillhouse would save developers and consumers approximately £904 million compared to the current the applicant's current proposal.

The applicants have failed to make use of extensive, already provisioned local energy infrastructure. The alternative route offers 130 hectares of development land with streamlined planning procedures, direct connectivity to the National Grid substation, which already holds offshore wind connections, and existing 400 volt Twin Circuits overhead line and Kingston with Pan with them and Heysham. By utilising this infrastructure, project could avoid the environmental, community and economic harms associated with the current proposals and deliver the lowest toll system costs to consumers.

There's so much land in the area being consumed by this scheme. Finding alternative grazing will be very challenging. Lastly, I want to highlight the community impact. Our animals are kept at the edge of the village on popular walking route. People often tell me the highlight of their family walk down the lane is to stop and see the horses and the alpacas. This outdoor activity is important for people's health and wellbeing, for their children's education and fosters a real sense of community. The loss of this amenity to years of construction is unthinkable.

We're always hugging the corner because something will come round and nearly take you out. The idea that these HGVs and so on will cut through our lane, you will see, is just impossible.
