## **NOTICE OF ISSUE-SPECIFIC AND COMPULSORY ACQUISITION HEARINGS**

Notice is hereby given that, at the dates, times and locations set out below, the following Hearings will be held by the Examining Authority (on behalf of the Secretary of State for Energy Security and Net Zero (the “**Secretary of State**”)) for the examination of the application made by Morgan Offshore Wind Limited (“Morgan OWL”) and Morecambe Offshore Windfarm Ltd (“Morecambe OWL”), (together, “the Applicants”), of Chertsey Road, Sunbury On Thames, UK, TW16 7BP and Hobart House, 80 Hanover Street, Edinburgh, United Kingdom, EH2 1EL , respectively, for a Development Consent Order (“DCO”) to be made under the Planning Act 2008 (“the Application”).

In October 2022, the Secretary of State for Business, Energy and Industrial Strategy issued a direction under section 35 of the Planning Act 2008 that the Project should be treated as a development for which development consent is required. The Application was therefore submitted by the Applicants pursuant to section 37 of the Act to the Secretary of State C/O the Planning Inspectorate on 21 October 2024. The Application was accepted for examination on 18 November 2024. The reference number applied to the Application by the Planning Inspectorate is EN020028.

### **The Project**

The Application is for development consent to construct, operate and maintain, and decommission the Morgan and Morecambe Offshore Wind Farms: Transmission Assets (hereafter, “the Project”), comprising two electrically separate transmission systems connecting two nationally significant infrastructure projects - the Morgan Offshore Wind Project: Generation Assets and the Morecambe Offshore Windfarm: Generation Assets (together, the “Generation Assets”), in the east Irish Sea, approximately 30 kilometres from the northwest coast of England to the national grid, at Penwortham, Lancashire. Two separate development consent applications have been made in respect of the Generation Assets.

The Project comprises onshore and offshore infrastructure. The offshore elements of the Project are located in the east Irish Sea within English offshore waters (beyond 12 nm from the English coast) and inshore waters (within 12 nm from the English coast). The onshore elements of the Project are located within the local authority areas of Fylde Council, Blackpool Council, South Ribble Borough Council, Preston City Council and Lancashire County Council. 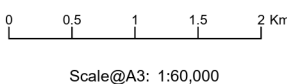
