### 1 Statement of Commonality

#### 1.1 Overview

#### 1.1.1 Introduction

- 1.1.1.1 Statements of Common Ground (SoCGs) have been prepared between Morgan Offshore Wind Limited (Morgan OWL) and Morecambe Offshore Windfarm Ltd (Morecambe OWL), (together, the Applicants) and other parties. These have been prepared to set out the areas of agreement and disagreement with these parties in relation to the Development Consent Order (DCO) application for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets.
- 1.1.1.2 In the Rule 6 Letter dated 28 March 2025, the Examining Authority (ExA) requested that the Applicants prepare a Statement of Commonality. This document provides an overview of the approach taken to capture commonality with the parties specified in the Rule 6 Letter (Table 1.1), the status of each SoCG (Table 1.2) and the agreement status with the parties for the main topics (Table 1.4) in a tabular, colour-coded format as requested by the ExA.
- 1.1.1.3 This Statement of Commonality is intended to act only as a summary of the progress of the SoCGs. For full details of the items under discussion with each stakeholder, please refer to the relevant SoCG.
