Morgan Offshore Wind Limited (Morgan OWL) and Morecambe Offshore Windfarm Ltd (Morecambe OWL) (together, the Applicants) enclose their submission for Deadline 7.

Application Guide

The Applicants have updated the Application Guide (A4/F12) and have provided a clean and a tracked version. The updated Application Guide contains a complete list of documents comprising the Applicants' Deadline 7 submission. Updates to D6 submitted plans

Crown Estate Agreement for Lease

Further to the Applicants' response to HAP CAH3_8 (S_D6_6) the Morgan Transmission Assets agreement for lease was completed with the Crown Estate on 28 October 2025. With respect to Morecambe OWL, discussions with the Crown Estate have progressed positively, and all matters concerning the Transmission Assets agreement for lease are now agreed in principle and it is expected that it will be completed prior to the determination of this Transmission Assets DCO Application.

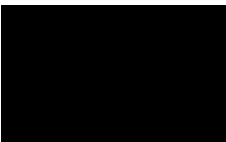
Statement of Common Ground- BAE Systems and Defence Infrastructure Organisation (DIO)

As previously agreed, BAE Systems and the DIO intended to submit a joint Statement of Common Ground (SoCG) with the Applicants at Deadline 7. Whilst the Applicants have made every effort to finalise and submit the signed document by the close of Examination, due to the late receipt of feedback from BAE/DIO, we have been advised that BAE/DIO will be unable to complete the signing process.

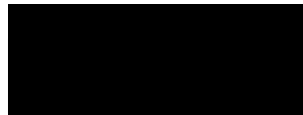
Once signed the SoCG will be submitted for the attention of the Secretary of State.
