1 Guide to the application

1.1 Introduction

- 1.1.1.1 This guide to the application summarises the structure of the application for development consent for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets (referred to hereafter as ‘the Transmission Assets’). Its purpose is to provide an understanding of the structure of the Application and the principal contents within each ‘category’ of documents.
- 1.1.1.2 Updating this document will be an iterative process and new versions will be made available as updates are made.
- 1.1.1.3 This document will be updated during the examination of the application and will be a quick-reference guide to the latest version of the application documents.

1.2 Document categories

- 1.2.1.1 There are seven categories of application documents, as set out in Table 1.1. These follow, wherever possible, the structure described in Table 1 of ‘Advice Note 6 – Suggested Order of Information Submitted with Application’ (The Planning Inspectorate, 2022).
- 1.2.1.2 These categories, A-J, accord with the Volume document numbering set out in the following ‘Annex A: Order of information submitted with NSIP applications’, of the Nationally Significant Infrastructure Projects: Advice on the Preparation and Submission of Application Documents (The Planning Inspectorate, 2024).
