**ALDBROUGH HYDROGEN STORAGE PROJECT
PLANNING ACT 2008
SECTION 46: DUTY TO NOTIFY SECRETARY OF STATE OF PROPOSED APPLICATION**

I am hereby notifying you under Section 46 of the Planning Act 2008 that Aldbrough Hydrogen Storage Limited (“the Applicant”) intends to apply under Section 37 of the Planning Act 2008 (“the Act”) for a Development Consent Order (“DCO”) for the Aldbrough Hydrogen Storage Project (“the Project”).

The Applicant will be undertaking statutory pre-application consultation under Section 42 of the Act between Monday 17 June and Sunday 18 August 2024. Responses must be received no later than 11.59pm on Sunday 18 August 2024. Responses received after this time may not be considered.

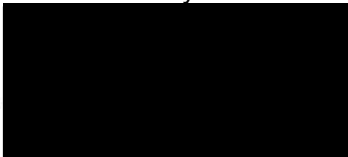
