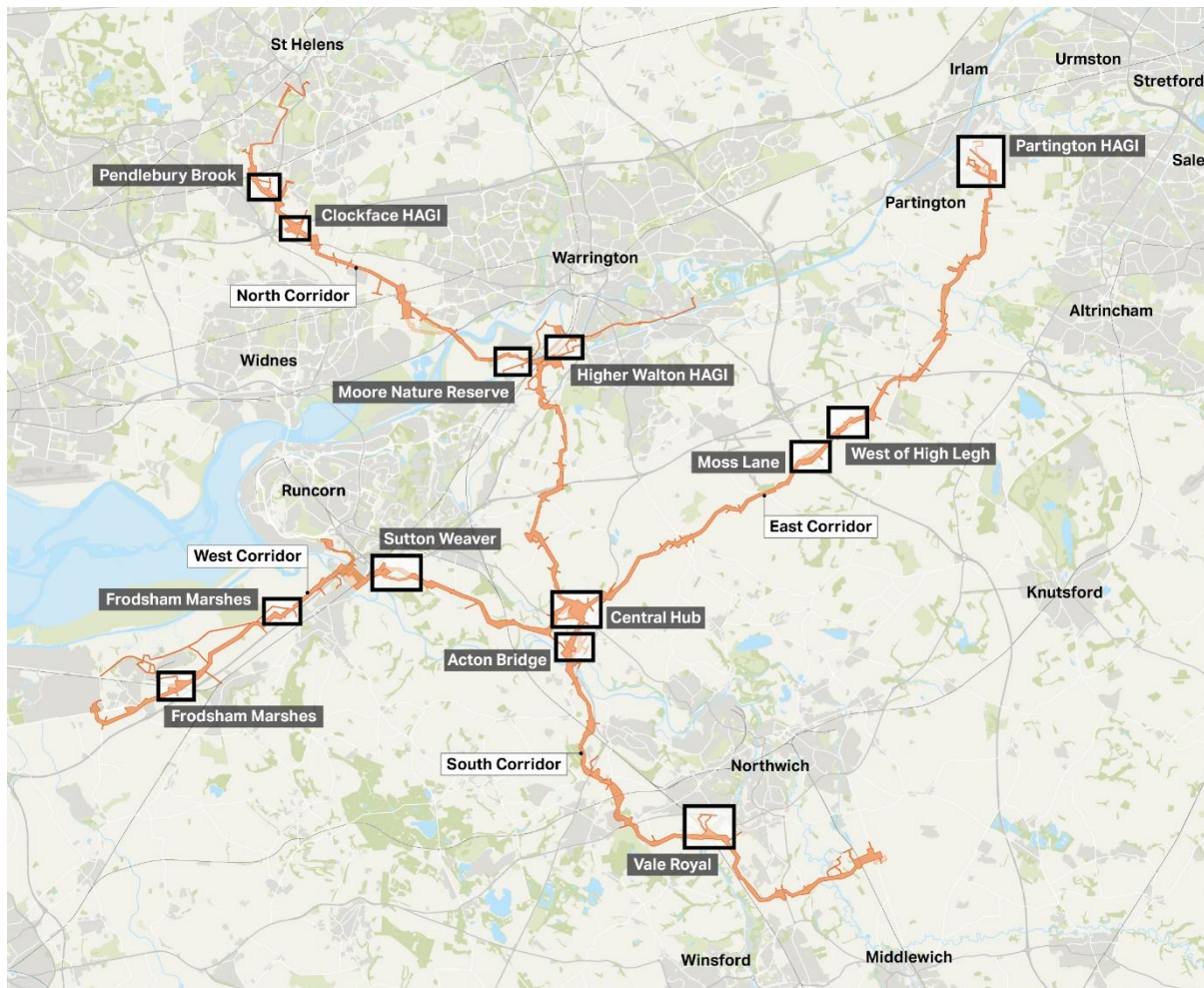

Cadent Gas Limited's HyNet North West Hydrogen Pipeline – Targeted Consultation

Notification under S46 of the Planning Act 2008 (as amended)

In accordance with Section 46 of the Planning Act 2008, we are providing notice that Cadent Gas Limited (“the Applicant”) intends to apply under Section 37 of the Planning Act 2008 (“the Act”) for a Development Consent Order (“DCO”) for the HyNet North West Hydrogen Pipeline (“the Project”).

As a result of feedback prior to and during Stage Three statutory consultation Cadent is consulting on several additional amendments to the Project as part of a targeted consultation. An overview of these amendments can be found below.



Consultation information

The Applicant will be undertaking statutory targeted pre-application consultation between 29th January 2025 and 25th February 2025. Responses must be received no later than 23:59 on 25th February, responses received after this time may not be considered.

The Project is an Environmental Impact Assessment (EIA) development as defined in the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017. Consequently, the Applicant will submit an Environmental Statement as part of the Application. This assesses the likely significant effects arising from the Project on the environment. A Draft Environmental Statement was published as part of the Applicant's Stage Three statutory consultation and an addendum to this Draft Environmental Statement forms part of the consultation material.
